Cork County Council Parking Control Bye-Laws

The Application must be accompanied by the following:-

1. A copy of the current insurance certificate for the vehicle. If the vehicle is registered in the name of a company you must supply a copy of the current insurance certificate for the vehicle and a letter from the company stating that you are employed by them and you have habitual use of the vehicle.
2. A copy of your vehicle licence certificate/registration book.
3. A copy of your current tax disc.
4. A copy of your current driving licence.
5. 2 current utility bills or financial statements.
6. The address on all supporting documentation must match the address of the residence for which you are applying for a permit.
7. If you reside in rented accommodation a copy of Rent Book/Rental Agreement and copy of confirmation letter from the Private Residential Tenancies Board (PRTB) acknowledging registration of the tenancy with the PRTB addressed to the resident at his/her address.
8. The appropriate fee.
9. Any other information requested by Cork County Council in relation to the application.

Conditions

- The display of a valid parking permit is the responsibility of the applicant.
- A valid parking permit shall be so displayed in the interior of the vehicle in respect of which it is issued that it can be read from outside the vehicle.
- The renewal of a parking permit shall be the responsibility of the applicant.
- If you move from your address, or if you dispose of your vehicle, your permit is no longer valid and must be returned to this office immediately.
- A parking permit may be issued by the Council or its agents only, in respect of the parking of a vehicle on the street specified.
- If you change your car you must apply for a new permit.
- It is an offence to display a void parking permit.
- Businesses, employees and non-resident landlords are not eligible for residents permits.
- Residents of purpose built apartment blocks are not eligible for residents permits.
- All renewed permits issued will be valid from the first day following the expiry of the previous permit. If a parking permit is not renewed within 1 month of the expiry date, a subsequent request for renewal will be dealt with as a new application and all evidence must be resubmitted.

Fodhlíthe um Rialú Páirceála Chomhairle Contae Chorcaí

Caithfidh siad seo a leanas a bheith isteach leis an Iarratas:-

1. Cóip de theastas árachais reatha na feithicle. Má tá an fheithicil cláraithe in ainm comhlachta caithfidh tú cóip de theastas árachais reatha na feithicle a chur ar fáil agus litir ón gcomhlacht ag rá go bhfuil tú fostaithe acu agus go bhfuil gnáthúsáid an chairr agat.
2. Cóip de theastas ceadúnais /leabhar cláraithe na feithicle.
3. Cóip de do dhiosca reatha mótarachánach.
4. Cóip de do cheadúnas reatha tiomána.
5. 2 bhille fónais reatha nó ráitis airgeadais.
6. Caithfidh an seoladh atá ar an doiciméadú tacaíochta uilig a bheith mar a chéile le seoladh na háite cónaithe a bhfuil cead páirceála á lorg dó.
7. Má tá cónaí ort i gcóiríocht ar cíos cóip den Leabhar Cíosa/Chomhaontú Cíosa agus cóip den litir dheimhniúcháin ón mBord um Thionóntachtaí Cónaithe Príobháideacha (PRTB) ag taispeáint clárú na tionóntachta leis an PRTB seolta chuig an áitritheoir ag a seoladh.
8. An táille chuí.
9. Aon eolas eile a bhí á éileamh ag Comhairle Contae Chorcaí maidir leis an iarratas.

Coinníollacha

- Is é freagracht an iarrthóra é ceadúnas bailí páirceála a bheith ar taispeáint.
- Cuirfear cead bailí páirceála ar taispeáint taobh istigh sa bhfeithicil a bhfuil an cead eisithe di ar bhealach gur féidir é a léamh ón taobh amuigh den fheithicil.
- Is ar an iarrthóir atá an fhreagracht cead páirceála a athnuachan.
- Má bhogann tú ó do sheoladh, nó má fhaigheann tú réidh le d'fheithicil, níl do chead bailí níos mó agus caithfear é a sheoladh ar ais chuig an oifig seo láithreach.
- Ní féidir ach leis an gComhairle nó a gníomhairí cead páirceála a eisiúint do pháirceáil feithicle ar an tsráid sonraithe.
- Má athraíonn tú do charr caithfidh tú iarratas a dhéanamh ar chead nua.
- Is cion é cead páirceála neamhnithe a bheith ar taispeáint.
- Níl gnólachtaí, fostaithe ná tiarnaí talún neamhchónaitheacha i dteideal cead páirceála áitritheora.
- Níl áitritheoirí i mblocanna árasán saintógtha i dteideal cead páirceála áitritheora.
- Beidh gach cead athnuaithe a eisítear bailí ón gcéad lá i ndiaidh dháta éaga an cheada roimhe seo. Mura mbíonn athnuachan déanta ar chead páirceála taobh istigh de 1 mhí ón dáta éaga, déileálfar leis an iarratas athnuachana ina dhiaidh sin mar iarratas nua agus caithfear an fhianaise uilig a sheoladh isteach arís.
