 - Chapter 1 Bandon Kinsale MD
 - Chapter 2 West Cork MD.

How do I make a Submission on the Proposed Amendments?

Submissions or observations regarding the Proposed Amendments to the Draft County Development Plan and the associated environmental assessments are hereby invited from members of the public, children, or groups or

associations representing the interests of children and other interested parties during the period from Tuesday 18th January, 2022 to midnight on Tuesday 15th February 2022 in either of the following two ways:

- In written form to the Senior Planner, Planning Policy Unit, Cork County Council, Floor 13, County Hall, Cork.

All such submissions lodged within the above period will be taken into consideration prior to the adoption of the new County Development Plan.

Cork County Council cannot accept email submissions.

For legal reasons, we cannot accept submissions outside the period from Tuesday 18th January, 2022 to midnight on Tuesday 15th February 2022 All such submissions lodged within the above period will be taken into consideration prior to the adoption of the new Cork County Development Plan.

Please make your submission by one medium only i.e. via the website or in hard copy. This will avoid the duplication of submission reference numbers and will streamline the process.

Where possible, please include your name and address on a separate page to the content of your submission in order to assist Cork County Council in complying with the provisions of the Data Protection Act. Your assistance on these issues is appreciated.

Please include where possible the Proposed Amendment Number that the submission relates to.

Because of the large volume of submissions expected the public are advised to make their submissions/ observations to the Council well in advance of the closing date.

Will my submission on the Proposed Amendments be published on the Cork County Council Website?

Yes Please note that in accordance with Section 19 of the Planning and Development (Amendment) Act, 2018 all valid submissions received by the Council shall be published on the Cork County Council website within 10 working days of its receipt by the Council. The planning process is an open and public process and therefore your submission (in part or in total) will be available to view online at https://www.yourcouncil.ie/service/Planning_Policy_Submissions.

Can I buy a copy of the Proposed Amendments to the Draft Cork County Development Plan 2021?

What are the Next Steps in the Review of the County Development Plan process?

We are currently at Stage Three of the Review of the County Development Plan process and following the Public Consultation period on the Proposed Amendments a Chief Executive's Report will be prepared on the Submissions received and will be available on the council's webpage.

Cork County Council Members having considered the Chief Executive's Report on the Proposed Amendments will then ADOPT the Plan with or without the Proposed Amendments.

What is the Draft County Development Plan 2021?

The Draft Cork County Development Plan sets out the overall strategy for the proper planning and sustainable development of the County while taking into account national and regional level plans, government policy and statutory guidelines and generally consists of a written statement and accompanying maps (seven volumes in total).

The Draft Plan will replace not just the current County Development Plan, 2014 (as varied) but also the following documents:

The current Clonakilty, Cobh, Fermoy, Kinsale, Macroom, Mallow, Midleton, Skibbereen and Youghal Town Development Plans and

The current 8 Municipal District Local Area Plans made in 2017.

What Documents make up the Draft Cork County Development Plan?

The Draft Cork County Development Plan 2021 published on 22nd April 2021 which consists of seven Volumes as follows:

- Volume One: Main Policy Material (including small scale policy maps
- Volume Two: Heritage and Amenity
- Volume Three: North Cork (Chapter 1 Fermoy MD and Chapter 2 Kanturk Mallow MD)
- Volume Four: South Cork (Carrigaline, Cobh, East Cork and Macroom MDs)
- Volume Five: West Cork (Bandon Kinsale and West Cork MDs)
- Volume Six: Environmental Reports-includes the SEA Environmental Report; Strategic Flood Risk

Assessment and the Habitats Directive Assessment Screening Report and Natura Impact Report Draft Cork County Development Plan.

- Volume Seven: Maps: [Detailed Maps (including large scale policy maps) available on the CDP Map Browser].
- Draft Joint Housing Strategy
