1.1 Waste

1.1.1 Launch of the Anti-Dumping Initiative Projects 2022

Cork County Council has been successful in securing funding of over €108,000 under the Waste Enforcement Regional Lead Authority (WERLA) **Anti-Dumping Initiative 2022**. The funding will support 18 diverse projects that aim to tackle illegal dumping in Cork County.

1.1.2 Use of CCTV for Waste Enforcement Purposes

The **Circular Economy and Miscellaneous Provisions Act 2022** includes among its provisions gives power to LAs to use GDPR-compliant technologies such as CCTV for waste enforcement purposes. This addresses a gap that has existed over recent years arising from a Data Commissioner ruling that prevented the use of such technologies for environmental enforcement. The new powers are however subject to development of detailed guidance by DECC, it will be a number of months before the new powers become operational.

1.3 Waste Enforcement Regional Lead Authority (WERLA)

1.3.1 The Circular Economy and Miscellaneous Provisions Act 2022

The Circular Economy and Miscellaneous Provisions Act 2022 has become law, underpinning Ireland's shift from a "take-make-waste" linear model to a more sustainable pattern of production and consumption, that retains the value of resources in our economy for as long as possible and that will to significantly reduce our greenhouse gas emissions.

A significant action provided for, under the new legislation, will see Local Authorities empowered to use GDPR-compliant technologies such as CCTV to detect and prevent unsightly and illegal dumping and littering. Take following [Link](#) for further information on the Act.

1.3.2 Single-use coffee cups

Regulations to apply levy (and what rate) are being drafted and will be the subject of consultation shortly.

1.3.3 Deposit Return Scheme (DRS) in Ireland for plastic bottles and aluminium cans

DRSI (Deposit Return Scheme Ireland) CLG is a new, not-for-profit company set up by producers. DRSI will be the operator of the Deposit Return Scheme (DRS), their application having been approved by the Minister in July last.

DRSI's approval provides a vital foundational element of the Deposit Return Scheme (DRS) project. This gives DRSI the legal standing to establish and develop a DRS in co-operation with producers and retailers.

The DRS project will be launched in October of this year & DRSI will progress the development and rollout of bespoke IT, financial and reverse vending machine infrastructure over the course of 2023.

1.3.4 Repak ELT to adopt new brand identity

REPAK ELT who have been operating the end of life tyre (ELT) scheme is rebranding to Circol ELT.

Circol confirms the schemes continued commitment to the circular economy and sustainability in the waste management sector. The changeover from Repak ELT to Circol ELT commenced in July and is due for completion by end of September 2022.



1.3.5. Enhancement of WERLA Staff Structures

Colman Kelly has been appointed as the WERLA Coordinator. Nicholas Bond and Caoimhín Nolan have been appointed as Senior Waste Enforcement Officers. Niall Dunne has been appointed to Exec role. Recruitment of two further Temp Exec and two Grade 4 assistant staff officers ongoing.

1.4 Climate Action & Energy Update

Climate Action Regional Office (CARO) – (Cork Co Co is lead authority for Atlantic Seaboard South Region)

CARO - Local Authority Climate Action Plan Guidance and Support

The signing of ministerial order requiring LAs to commence process of drafting **LA Climate Action Plans** is imminent we believe. By law latest date for signing of order is 7th March 2023.

A Draft Guidance document for LAs on the preparation of Climate Action Plans has been developed by CARO office. This draft guidance now also covers the question of Decarbonization Zones (such as Macroom) and how they can be progressed.

Framework Contracts developed by CARO, which allow Local Authorities nationwide access to specialist climate action consultants is now also in place. Local Authorities have already begun using the rapid mini-tender process to appoint consultants to assist in key tasks for their climate action plans.

CARO - Guidance for the Climate Adaptation of Regional & Local Roads

Roads Guidance Document

The guidance document for Local Authority Roads staff dealing with issues arising from Climate Change (such as more temperature-resilient road designs) will be completed on schedule in Q4. Additional proposed work on Green Procurement and measures to lower the carbon footprint of road construction and maintenance are being considered with partners in the Department of Transport.

CARO - Coastal Erosion:

Coastal Guidance Document

A final report on Coastal Erosion and the challenges for Local Authorities has been developed by working group including stakeholders from other state agencies and departments and has been approved by City and County Management Association (CCMA). CARO is currently engaging with the Department of Housing Local Government and Heritage (DHLGH) re funding to draft a guidance document for Local Authority staff dealing with coastal change issues.

EU Horizon Project: Coastal Erosion Vulnerability/Habitats.

CARO along with Cork County Council and UCC/MaREI have been successful along with European partners in Portugal and Norway in securing funding for a Horizons Europe “Lighthouse” demonstrator project focused on the issues of Coastal Erosion Vulnerability/Habitats. The project will focus on soft engineering measures to protect coastlines via Habitat Restoration and Coastal Resilience measure, all with a high level of engagement with community partners. Funding to the Irish contingent is in the order of €370,000 over an initial 4 year period. The project is currently at initiation stage, with clarifications and questionnaires being prepared for the Commission, with a key element being identification of demonstrator sites and local community partners in the Cork region.

CARO - Energy Manual for LA Municipal Buildings

An Energy Manual to assist Local Authorities in managing various building types from Libraries to Leisure centres is at an advanced stage and will be made available to Local Authority practitioners in Q4, to assist in energy management issues.

CCC Climate Action & Energy Office programmes;

In anticipation of ministerial order to commence LA Climate Action Plans, **KPMG** were appointed in August to start gathering required baseline data. That is progressing well. **Installation of LED lighting** completed on the 12 originally selected sites, further sites are being identified

A **Building Energy Audit** on key council facilities is near completion. Current Gas/Electricity price levels have raised questions on the viability of some renewable energy upgrade proposals

DECC has given approval for **Community Climate Action Officer** post funded from Climate Action fund. DoT is funding appointment of a **Green Procurement Officer** with aim of mainstreaming green procurement in design, construction and maintenance. DECC has committed to funding a Climate Action Coordinator and a Climate Action officer in each Local Authority. Sanction is being sought from the DHLGH.

1.5 Community Environmental Awareness Programmes

1.5.1. Reuse Republic Event – 25th October

The Reuse Republic event returned this year for Reuse Month, having not taken place since 2019 due to Covid. With a view to taking the event on the road, it was held this year in IRD Duhallow in Newmarket on Tuesday 25th October 2022 from 2-7pm. The event brought together national and local reuse initiatives to exhibit their services and showcase how individuals and communities can take action to reduce their consumption and positively impact climate. An exciting series of workshops themed around reuse and waste prevention, including furniture upcycling, composting and reducing single use plastic took place on the day.

As Ireland has committed to reduce food waste by 50% by 2030, in line with the United Nations (UN) Sustainable Development Goals (SDG's), food waste was a core theme of the event. Cork celebrity chef Trisha Lewis, known for Trisha's Transformation, did a cooking demonstration on the day to show innovative ways of reducing food waste when cooking meals at home. Amongst the exhibitors, ReCreate Ireland hosted a workshop on sustainable creativity in arts and crafts, reusing materials that would otherwise have gone to waste. Circular Fashion Ireland hosted a talk on the impact of fast fashion, making more sustainable fashion choices and also ran a clothing Swap Shop, where members of the public are invited to bring their lightly worn clothes to swap for other items.

1.5.2. *Climate literacy course for post primary schools*

Cork County Council recently invited post primary schools in the Southern Division of Cork County to register interest in a Climate Literacy Course. The 10 week course will be delivered in schools during the second and third terms of the 2022/23 academic year by Education for Sustainability. Cork County Council will fund all costs, i.e. €1600 per school. While we are piloting it with schools in the Southern Division, we would hope to roll it out to schools in both Western and Northern Divisions thereafter.

The 10-week course combines online resources including lesson plans and an online student workbook as well as in person teacher training for one class grouping for 10 weeks. While the course is very suitable for Transition Year or CSPE it can also be integrated with other subjects. A facilitator will visit your school weekly to deliver the course and simultaneously train the teacher(s). Course topics include climate change, sustainable development, climate justice, plastic, fast fashion, sustainable transport, biodiversity loss, food and soil and taking action. The online course materials will be made available to all teachers in the school and online training sessions will also be held for any teachers wishing to integrate climate literacy into other subjects.

1.5.3. *Community Recycling Award for Relove Paint at the Irish Environmental Pakman Awards*

We were delighted to accept the Community Recycling Award, on behalf of the partners of Relove Paint, at the Pakman Awards last Friday night from Minister of State at the Department of Public Expenditure and Reform, Ossian Smyth.

A unique collaboration between Cork County Council and Cork City Council, unwanted water based paint is collected at both local authority civic amenity sites by three social enterprises, Cycle Sense Skibbereen, IRD Duhallow and a Northside Community Enter Cork city , who filter, remix and recolour the paint before selling it back into the community at a low cost. The project resulted in 5 tonnes of paint being diverted from incineration/landfill and made available to local enterprises. To date 2,200 litres of paint have been sold back into the community with the volume of sales increasing all the time. A great example of the circular economy in action.

1.5.4. **Water Heritage Day Award for Coomhola Blue Dot Catchment Booklet Launch**

High-status or Blue Dot waters are the designations for our best quality waters. They have the highest ecological quality of all our waters and by their nature often have a greater diversity of species that are sensitive to pollution. Unfortunately, many sites previously classified at high status have disimproved over recent decades. In its most recent report the EPA reported a decline in the number of high-quality sites from almost one third (31%) of all sites monitored in the 1980s to just under one fifth (17%) in 2017, and only 30 of these remaining high status sites are considered pristine. The EPA conclude that the ongoing loss of our most pristine rivers is a very significant concern.

A large effort is required to protect the few remaining high status river sites and, where possible, return impacted ones to high status. The 'Blue Dot' Catchments Programme is a State-wide effort to conserve High Status water bodies. As part of this project, the Coomhola River was chosen to be the subject of the first Blue Dot supporting publication, establishing the template for similar publications for other Catchments throughout the country.

StreamScapes, a designer and producer of community engagement projects for catchments around Ireland, who are based in Coomhola near Bantry, developed the [Blue Dot Coomhola River](#) Catchment booklet which will be a template for communicating Blue Dot objectives to local communities across the country. The project was delivered by StreamScapes, in partnership with the Local Authority Waters Programme Office (LAWPRO) and the EPA Catchments Unit. Cork County Councils Environment Awareness Unit supported StreamScapes on this project with a contribution of €5,000. The publication was launched in August this year at a ceremony in Bantry which the County Mayor attended and spoke at.

The Coomhola Blue Dot Catchment booklet launch won the Water Heritage Day Award at the 2022 National Heritage Week Awards which were held on Thursday 20th October at the Royal College of Physicians, 6 Kildare Street, Dublin 2. Mr. Malcolm Noonan, Minister of State for Heritage and Electoral Reform was in attendance at the awards ceremony.

1.6 *Change is in the air – new solid fuel regulations*

New Solid Fuels Regulations come into effect on 31 October 2022 effectively introducing a nationwide ban on smoky solid fuel, not just coal.

Specifically the regulations specify that;

A person shall not ...burn...place on the market, sell, supply or distribute for heating purposes in a domestic or licensed premises—

- (a) solid fuel that is not an approved solid fuel, or
- (b) sod peat.

Approved fuels must comply with IS311 or ISO17225:

Coal products and manufactured solid fuels must have a smoke emission rate of less than 10 grams per hour.

Manufactured biomass products must have a smoke emission rate of less than 5 grams per hour

Coal products and manufactured solid fuels, including manufactured biomass products, must have sulphur content less than 2%, reducing to 1% by Sept 2025

Wood sold <2m3 will is required to have a moisture content of 25% or less reducing to 20% by Sept 2025,

This is primarily a public health initiative aimed at improving air quality both indoors and outside. Both the Dept of Environment, Climate & Communications (DECC) and council's Environment Directorate have been communicating with operators in the sector and will continue to promote public awareness of these changes over the coming months.

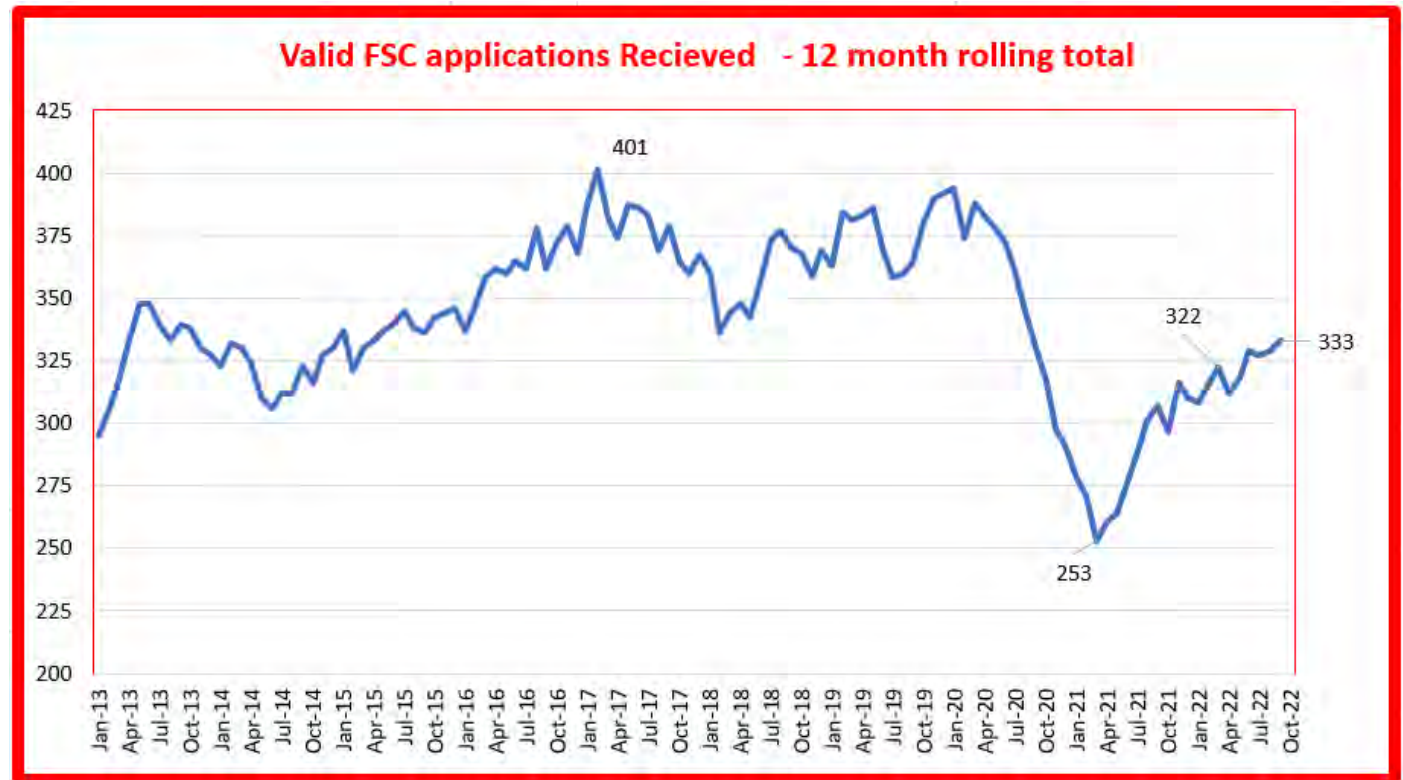

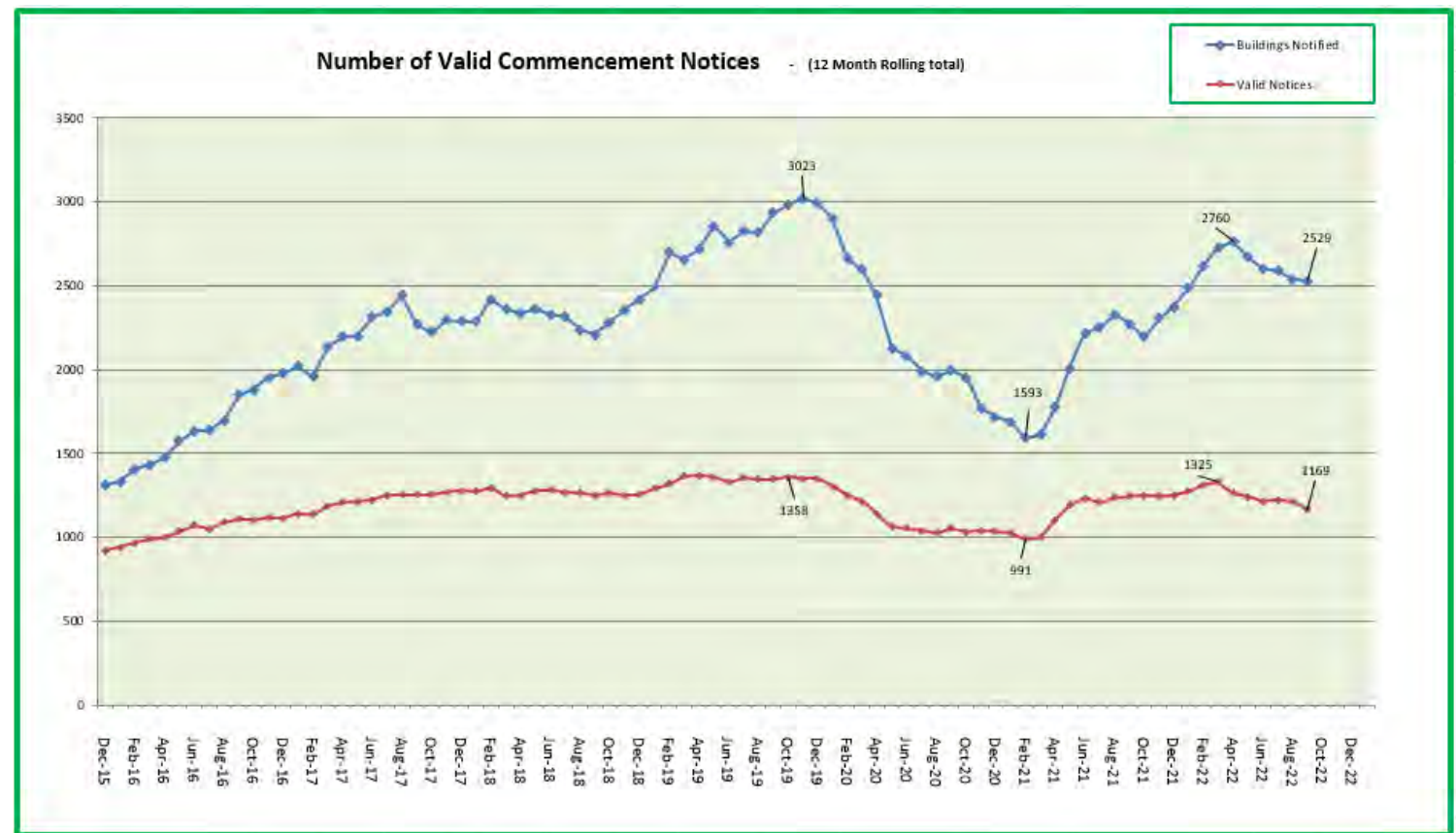

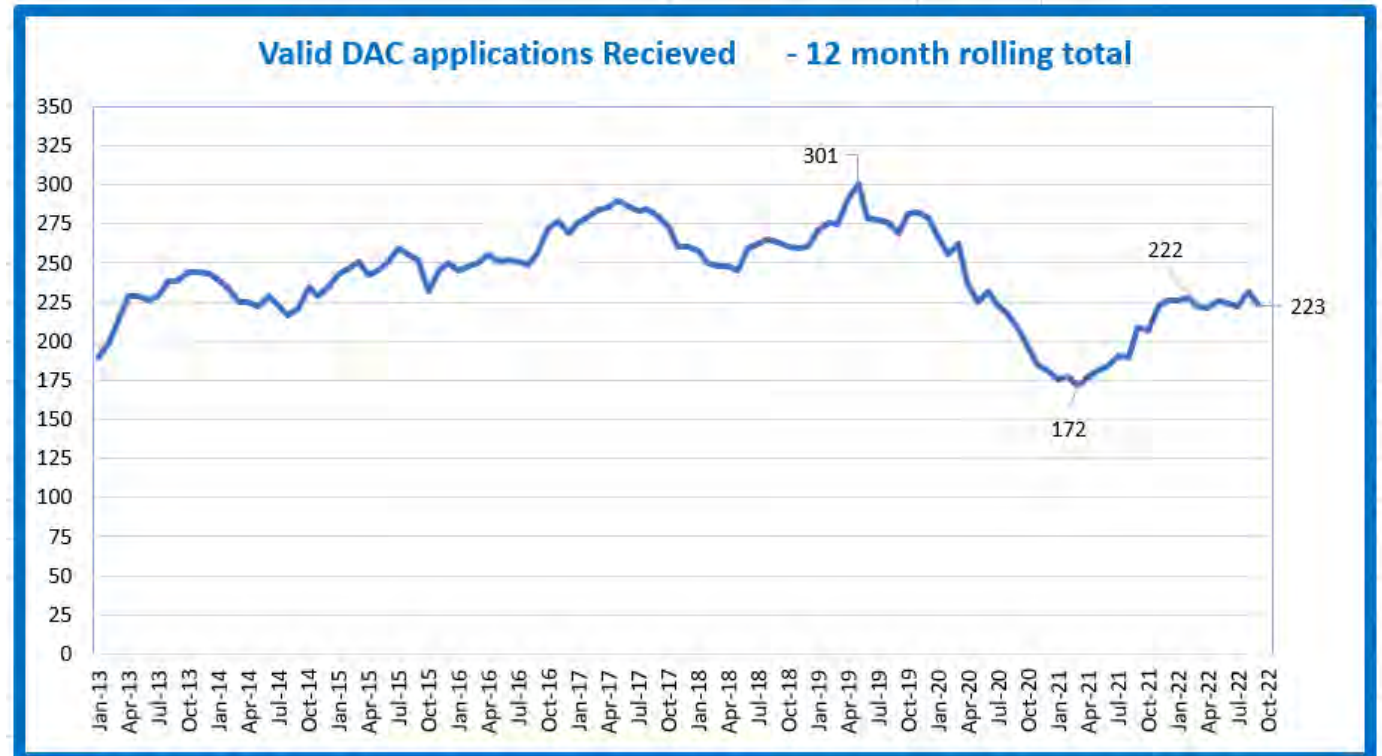

Covid-19 update:

The HSE had previously advised that sampling at nursing homes could recommence in Q2/Q3, subject to the incidence rate of Covid-19 at the time, as well as the agreement by management at individual nursing homes. Given the continued risk of Covid-19, as well resource constraints within the laboratory, sampling at nursing homes remained suspended in Q3, but will be reviewed for Q4. In Q3 2022 continued priority was given to schools and creches and to re-testing supplies which had issues, with many coming back into compliance. Q3 also saw reinstatement of sampling at private supply hotels/ B&Bs and Sports clubs.

Sampling of Group Water Schemes has not been affected by Covid-19 restrictions with outdoor monitoring points accessible at all supplies.

2.3.2 Bathing Water Compliance Programme 2021

Note: Bathing Season monitoring extends from mid-May to mid-September. In addition to bathing water sampling and testing outlined below, the Water Quality Laboratory also undertakes environmental education activities as required by the Blue Flag rules. This year, on-the-beach activities were scheduled for May and June, laboratory staff assisted by a number of NGOs plans to engage with schools. Beach activities were held on a number of beaches with students learning about beach ecology and the importance of keeping our beaches clean along with water safety instruction from Cork Co. Council's Water Safety Development Officer.

In May, An Taisce announced that our Blue Flag beaches retained their flags and that two additional beaches have been awarded Blue Flag. Youghal Front Strand regained its Blue Flag (last awarded a Blue Flag in 2011) while Fountainstown was awarded a Blue Flag (last awarded in 1991). The total number of beaches managed by Cork County Council is 29. An Taisce also announced the Green Coast Award beaches. All our existing Green Coast beaches retained their flags. Inchydoney East beach and Fountainstown are two sites in the country which have both a Blue Flag and Green Coast Awards. Cork County boasts the highest number of Green Coast beaches in Ireland. Below table outlines the planned bathing water monitoring programme for 2022.

On the 14th of August 2022, bathing water contamination was observed by the lifeguards and the public in the Warren beach and in the interest of public health the beach was closed; a **Prohibition Notice** was issued and investigations began. Samples were taken on 15/09/2022 and the results that the water quality had not deteriorated. For certainty, a second sample was taken, and results again confirmed that the water quality was excellent, and the prohibition notice was lifted on 18/08/2022.

A weather warning was issued on Sunday 04/09/2022 for heavy rain and high winds in County Cork, in the interest of public safety **11 Prior Warning Notices** were issued to Garretstown, Coolmaine, Inchydoney West and East, Warren, Tragumna, Barleycove, Oysterhaven, Cadogans Strand, Red Strand and Ballyrisode these beaches were deemed at risk of water quality deterioration due to the impact of the weather event. Our scheduled sampling of all beaches, due on the Monday 05/09/2022 had to be postponed on Health & Safety grounds and was rescheduled for Wednesday 07/09/2022. All beaches were sampled on this date, except Owenahincha, Garretstown and Sheep's Head, Dooneen Pier again due to poor weather conditions. Following the sampling that did take place on 07/09/2022 the Prior Warning Notices were lifted from Coolmaine, Tragumna, Barleycove, Oysterhaven, Red Strand and Ballyrisode on 09/09/2022. However, due to high levels of bacteria detected in Inchydoney West and East and Fountainstown samples, **3 Advisory Notices** were issued Not to Swim at these beaches. Following resampling, when it was safe to do so, on the 13/09/2022, the Advisory Notices were lifted from the Inchydoney beaches on 15/09/2022 and Fountainstown on 19/09/2022

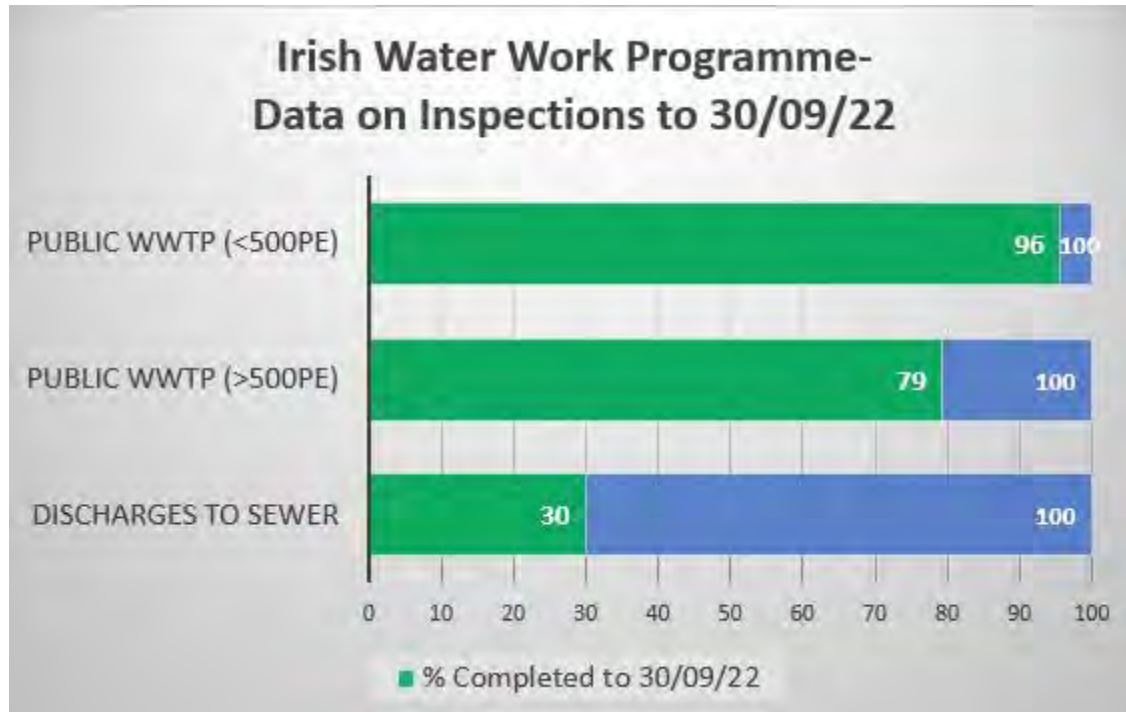


Figure 2: IW Work Programme- Inspections

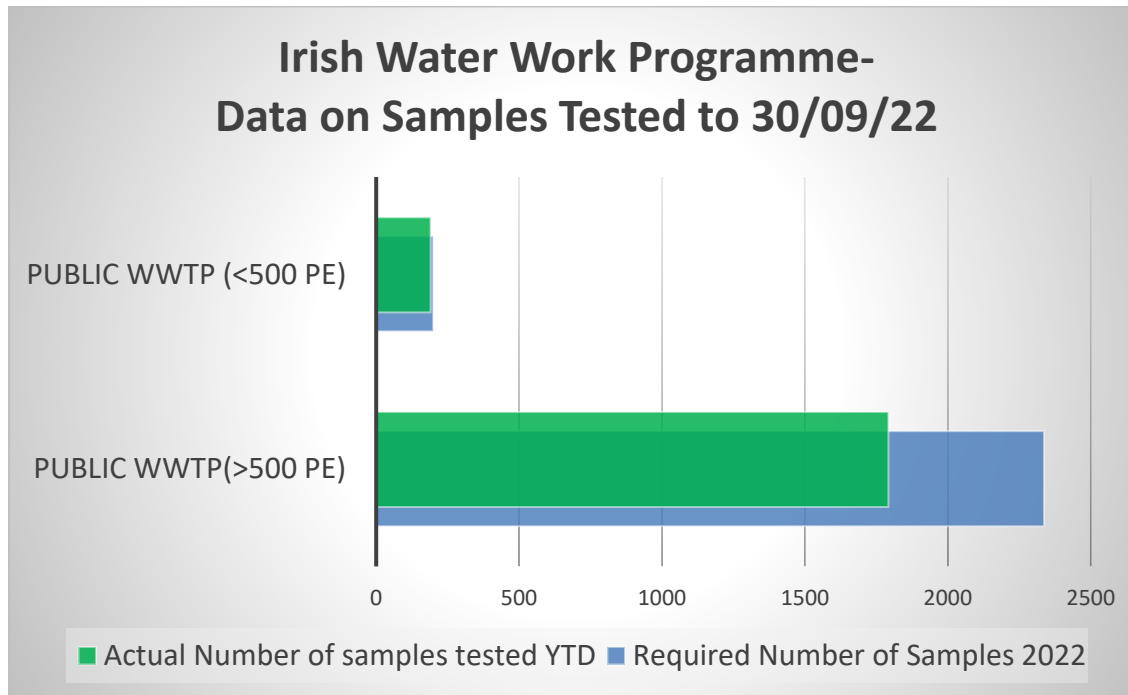


Figure 3: IW Work Programme – Samples

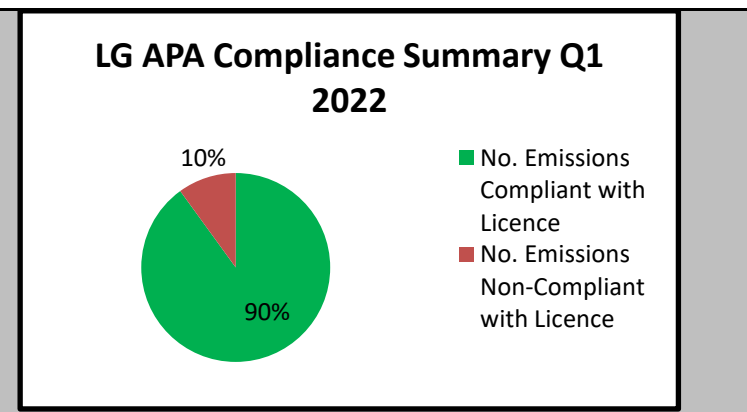

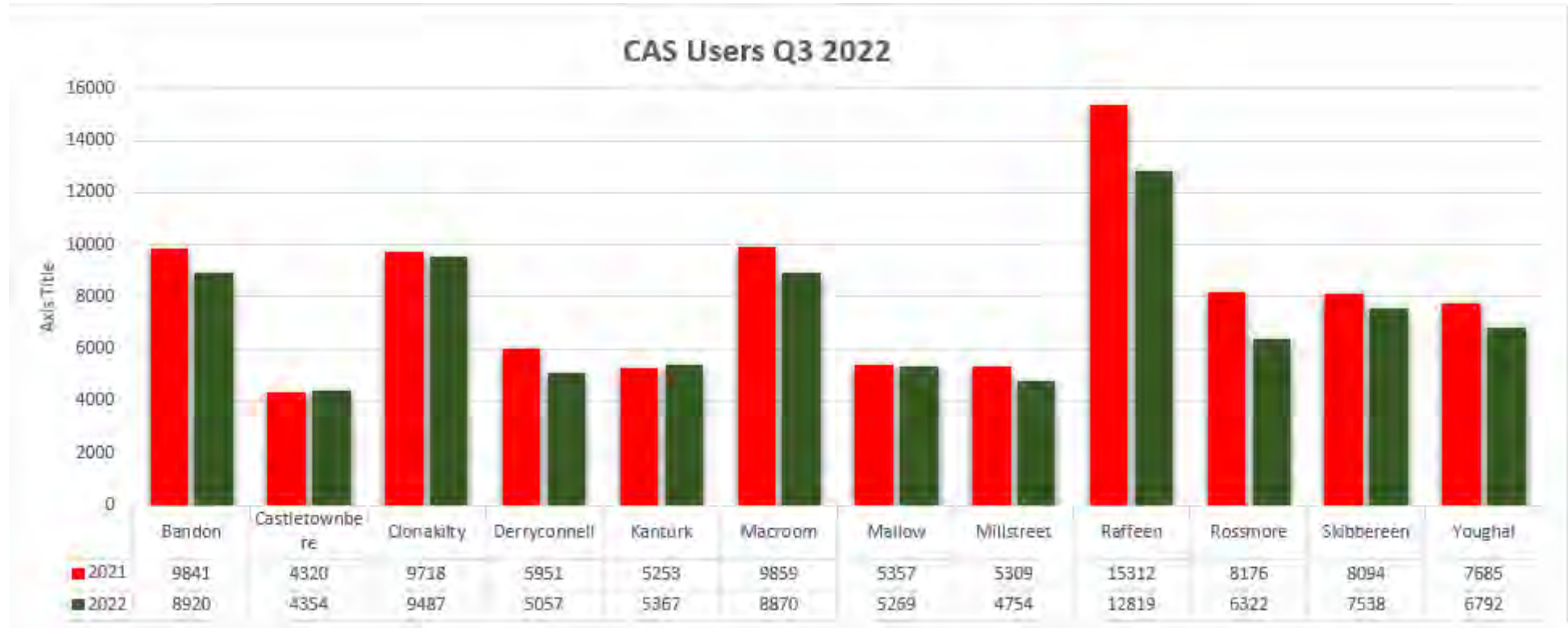

2.7. Energy Management

2.7.1. SEAI

Public bodies are required under Statutory Instrument 426 of the European Union Energy Efficiency Regulations (2014) as amended to report their energy performance annually. The system by which public bodies report their energy consumption is through the Monitoring and Reporting (M&R) system, managed by the Sustainable Energy Authority of Ireland (SEAI).

Under the National Energy Efficiency Action Plan (NEEAP), Cork County Council had an energy efficiency improvement target of 51% on 2009 energy efficiency figures by 2030.

2.7.1. Energy Efficiency Status 2030 (preliminary)

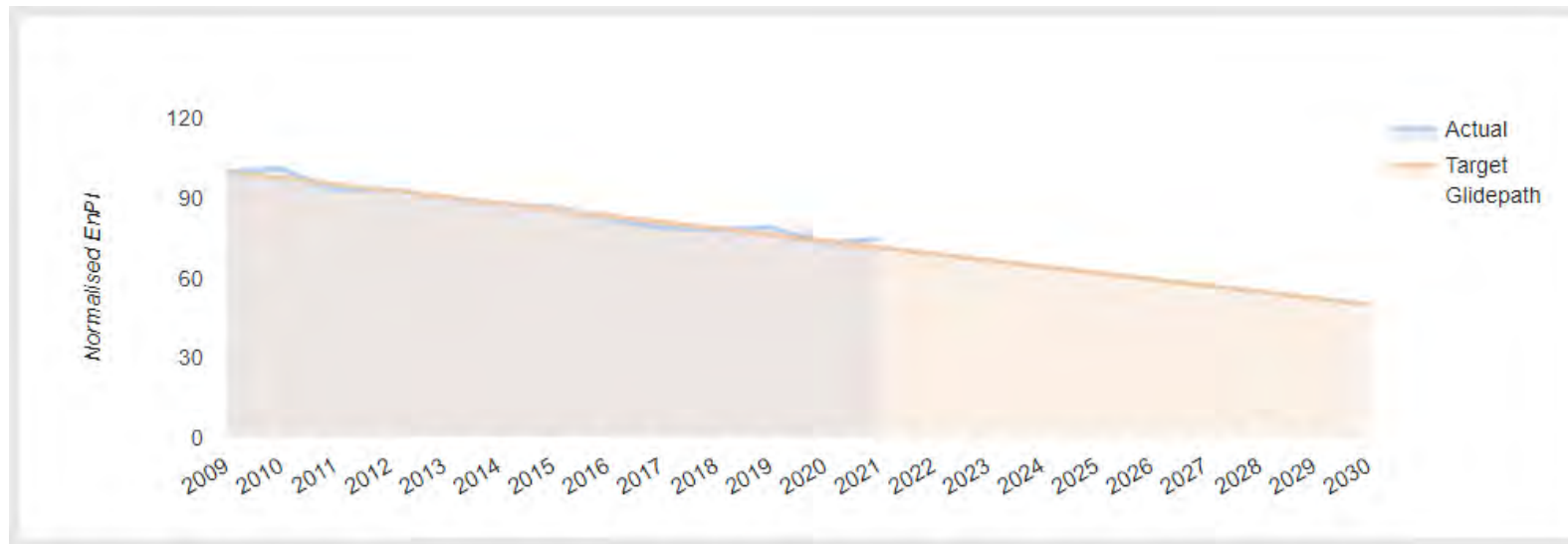


Figure 1 Cork County Council's energy efficiency performance glide path to 2030 from SEAI M&R

At the end of 2021, Cork County Council's energy efficiency was 25.3% better than baseline. The NEEAP target glide path presented in the current SEAI monitoring and reporting scorecard is shown in Figure 1.

The figures presented below were published by the SEAI in their Annual Report 2020 on Public Sector Energy Efficiency Performance. The major findings are as follows:

- 2.8% worse than 2020
- 25.3% better than baseline (2009)
- 49.4% improvement required by 2030

Cork County Council's 2021 scorecard is expected to be published by SEAI in October 2022.

2.7.4. ISO 50001

Cork County Councils Energy Management System (EnMS) is accredited to the ISO 50001 standard. Cork County Council is therefore compliant with SI 426, which is the statutory instrument that requires all large organisations to either have completed an organisational energy audit or have implemented an approved EnMS. An ISO 50001 recertification audit was successfully completed on the 31st of March 2022.

2.7.5. Significant Energy Users (SEU)

ISO 50001 is an organisational energy management system. A requirement of the ISO 50001 accreditation is that Cork County Council continuously monitors and reports on its SEU's. Cork County Council has four nr. Significant Energy Users (SEU). Cumulatively they account for more than 80% of all energy consumption. The 2022 percentage breakdown is provided below:

- Public Lighting (33%)
- Fleet (37%)
- County Hall campus (5%)
- Leisure Centres (6%)
- Fermoy
- Mallow
- Dunmanway

2.7.6. Energy Efficiency Status

The Energy & Climate Change Section monitor the energy consumption of each SEU monthly using Energy Performance Indicators (EnPI). The EnPI for each Significant Energy User is described as follows:

- **County Hall has two EnPIs**
 - A formula called CUSUM predicts what energy should have been used based on past performance and is adjusted for weather conditions.
 - kWh/m²/year
- **Fleet**
 - Is based on the average monthly litres/100km over the past 12 months.
- **The Swimming Pools**
 - A formula called CUSUM predicts what energy should have been used based on past performance and is adjusted for weather conditions.
 - kWh/m²/year
- **Public lighting** is calculated as the average wattage per lamp in the County. This energy performance indicator (EnPI) is reviewed annually.

The E&CC Section are currently reviewing the appropriateness of these EnPIs as part of CCC ISO 50001 compliance. New or additional EnPIs may be agreed with the relevant SEUs as part of this review process where required. Monthly EnPIs for 2021/ 2022 are presented in Figure 2 hereunder:

2.9. National Broadband Plan (NBP)-update Fibre Roll-out

Fibre Roll-out

NBI rely on their parent website at <https://nbi.ie/> to provide information on the National Broadband Contract. Website <https://nbi.ie/nbp-project-progress/> provides detail on the roll-out progress and the website advises the number of premises in the Intervention Area has grown by 17K since commencement of the project. NBI also advise the roll-out programme remains on target to be delivered within the originally planned 7-year programme. The latest national roll-out progress is reported as:

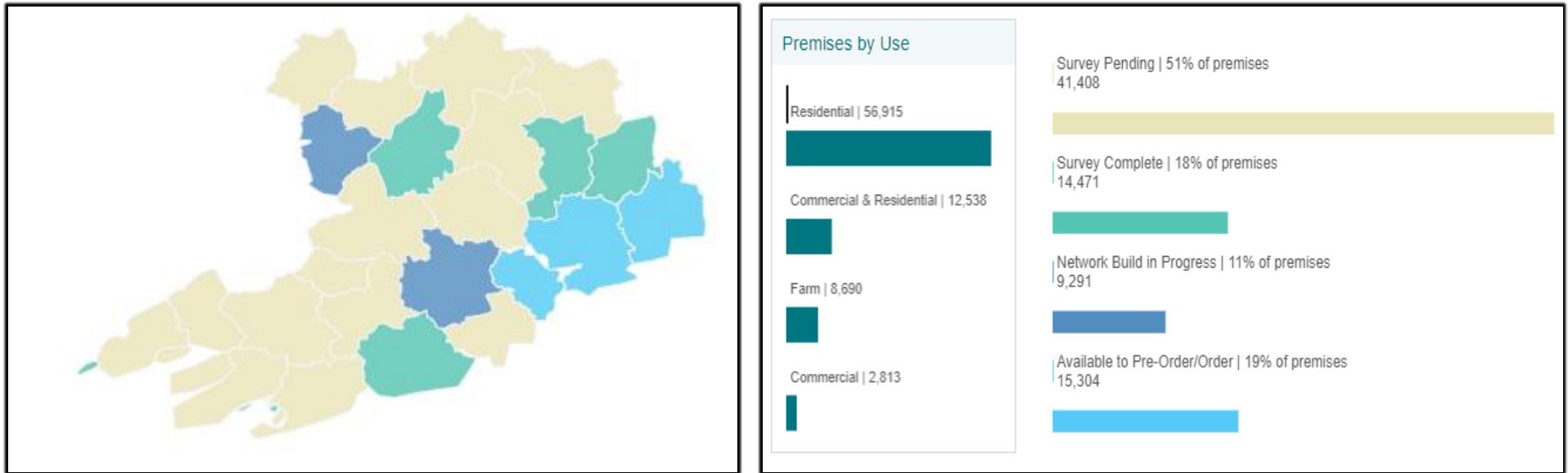
- Premises under construction to grow by 43%, to 221,000 homes (40% of the 7-year target)
- Premises available to order set to increase by 266% to 128,000 homes
- Premises passed to grow by 219% to 102,000 homes

The website provides progress report numbers at a national level.

Network build is substantially complete in Carrigaline DA and NBI are presently working in Midleton, Youghal and Rathmore DA's. Surveying works are complete at Kanturk, Templemartin, Clonakilty, Fermoy and Tallow DA's. Approx. 67,000 premises across Cork County area will ultimately benefit from access to high speed broadband constructed under the National Broadband Contract

NBI continue to operate a dedicated e-mail service at reps@nbi.ie for Elected Representative queries and news items are published at <https://nbi.ie/news/updates/>. NBI advise of issuing news items direct to relevant Elected Representatives.

Receiving the grants of €1000 each under the RISE Community Fund supported by NBI were the Castlelyons Community Centre, with plans to install a mobile booster to extend the benefits of high-speed connectivity in the area; Carrigaline GAA, to enable internet availability throughout the club grounds and use technology to enhance training methods; Carrigaline Mens Sheds, to install a smart TV into their newly built facility and give access to videoconferencing and online resources; and Courtbrack Community Centre, which will be bolstering its online capabilities to better serve everyone in the community as well as digitise some of its key functions including introducing online banking for the first time.

Broadband Connection Points

The Minister for Rural and Community Development, Heather Humphreys, officially opened a number of projects in North Cork on 29th April '22 which received DRCD funding. The Minister took the opportunity to visit the BCP at Ballindangan during her visit to North Cork. During her talk to Elected Representatives and to the local community, the Minister remarked on Cork County having a higher number of BCP's than any other LA.

A total of 24 BCP's are now completed across the county and are operational. Remote working is being accommodated at a number of BCP's.

The Council continues to support the Broadband Connection Points (BCPs) initiative and is co-funding the monthly broadband retail service costs at BCP's. Many of the BCP's are now benefitting from Town and Village funding support and availing of grant funding to purchase furniture and fittings to enhance remote working opportunities.

Grant applications under the €5 million Government Grant Connected Hubs Call 2022 scheme, totalling in excess of €300K, were lodged by a total of 6 BCP's across the county. The Connected Hubs Call 2022 aim is to add additional capacity to the existing remote working infrastructure in Ireland by upgrading existing hubs and Broadband Connection Points (BCPs). Laharn, Bere Island and Castlelyons were successful in their grant application process for their projects as listed in the table below.

These building enhancements and cost saving measures will ensure the long-term viability of this key infrastructure which serves as the heart of the community.

On 15th April, Minister Humphreys announced a €15M Community Centre Investment Fund to support community groups with the upgrade and development of their Community Centre facilities which may have become aged and dilapidated over time. Funding will be available under 3 Categories with grants of between €10,000 and €300,000 available.

Approved Category 1 type projects up to a value of €25K will allow communities to undertake upgrade works on a fully funded basis. Such funding opportunity is anticipated to have wide applicability and be of interest to managers of many community facilities, including managers of BCP sites. The closing date for applications is Thursday 14th July 2022. An announcement in respect of this grant scheme is awaited.

- East Cork MD
 - Inch Community Centre
- West Cork MD
 - Bere Island Heritage Centre, Castletownkenneigh Community Centre, Clonakilty ETB, Coláiste Phobal Cléire, Lisavaired Community Centre, Mealagh Valley Community Centre and Sherkin Island Community Hall and Caheragh Community Centre.

Fibre installation to the BCP at Glengarriff Community Centre (West Cork MD) is complete and a date for activation of the broadband is being pursued with NBI.

WiFi4EU

Under the WiFi4EU initiative, the European Commission wishes to promote free Wi-Fi connectivity for citizens and visitors in public spaces such as parks, squares, public building, libraries, health centres, and museums across Europe through the installation of state-of-the-art Wi-Fi equipment in the centres of community life.

County Council secured 4 vouchers under the WiFi4EU award procedures and each of these vouchers supports EU funded infrastructural investment. There is an additional commitment from the Irish Government to match fund the EU investment. Accordingly, the combined EU and Irish Government grant associated with the WiFi4EU scheme is up to a maximum of €120,000.

Cork County Council has appointed Paradyn to undertake installation of access points across the county. Global shortages of semi-conductor electronic components and general supply chain difficulties created a risk to completion of the project. Accordingly, Cork County Council applied to EU for an extension of time to complete the project, citing global shortage of electronic components for required equipment manufacture as the background reason.

Installation works are progressing and access point installations are complete in Cobh and Midleton.
