**Road Subject of Proposed Closure**

The R595 from its junction with the L-9810-0, entrance into Public Car Park adjacent to Field's, off Main Street, Skibbereen to its junction with the R595 North Street/L4216-15 The Square.

Access to the L-9811-0 Public Car Park adjacent to Supervalu will be available for the duration of the closure via the L-9810-0.

**Period of Proposed Closure**

To facilitate **Installation of Paved Pedestrian Crossing point as part of Skibbereen Public Realm Works.**

**Alternative Routes**

The usual one way traffic system through the town is to be maintained.

Traffic travelling from Bridge Street to North Street via Ilen Street and the By-Pass (N71) taking the exit off for R595 Baltimore.

Traffic travelling from North Street to Baltimore via R595 Market Street and continue to Baltimore roundabout, as usual.

Footpaths on both sides of the street will remain open so there will be full pedestrian access maintained to all premises along Main St for the duration of the closure.
