1. Cén bearta atá í bhfeidhm ag Comhairle Contae Chorcaí chun bac a cur ar dumpáil mídhleathach?

What measures do Cork County Council have in this Municipal District to prevent illegal dumping?

REPORT

Cork County Council has enforcement officers and litter wardens who are full time and their area of operation includes the Blarney Macroom MD. They carry out road check points as part of multi-disciplinary teams where they inspect vehicles carrying waste to ensure they are licensed waste collectors and they inspect the paper work to ensure the waste is fully traceable.

The staff also work with communities in the cleanup of dumping, but more importantly in developing lines of communication that bring incidents to our attention quickly which improves the opportunity to find evidence that identifies the offenders and allow us to prosecute them. In suitable blackspots we install covert cctv to obtain evidence to identify and prosecute the offenders.

There are also MD traffic wardens with litter powers who operate in towns. The Council has also provided a civic amenity site in Macroom which provides an opportunity to dispose of waste without the need for a kerbside collection.

The Council is in the process of amending the existing waste by-laws, the new laws should come before the Council in the coming weeks for adoption. A new power under these by-laws will allow the Council seek proof from a property owner/occupier that they dispose of their waste properly.

Déanann siad iniúchadh ar fheithiclí atá ag iompar dramhaíola chun a chinntiú gur bailitheoirí dramhaíola ceadúnaithe iad agus déanann siad iniúchadh ar an páipéarachas chun a chinntiú go bhfuil an dramhaíl inrianaithe go hiomlán.

Chomh maith leis sin, oibríonn an fhoireann leis an pobail maidir le glanadh suas dumpáil, ach níos tábhachtaí comh-oibríonn siad ar línte cumarsáide a fhorbairt a thugann ár n-aird chuig eachtraí go tapa agus ansin tugann se sin deis duinn fianaise a aimsiú a aithníonn na ciontóirí agus a chuireann ar ár gcumas iad a ionchúiseamh.

I bhall dubh bruscair oiriúnacha tá córais cctv ceilte againn chun fianaise a fháil chun na ciontóirí a aithint agus a ionchúiseamh.

Tá maoir tráchta ann freisin san Cheantar Bardasach le cumhachtaí bruscair a oibríonn i mbailte.

Chomh maith leis sin, chuir an Chomhairle Ionad athchúrsála ar fáil i Maigh Chromtha a thugann deis don phobail dhramhaíl a dhiúscairt gan an gá le bailiúchán ó thaobh cosáin.

Tá an Chomhairle ag obair faoi lathair ar na ndlíthe dramhaíola atá ann cheana a leasú, ba cheart go mbeadh na dlíthe nua os comhair na Comhairle sna seachtainí amach romhainn le glacadh leo. Tabharfaidh na fodhlíthe seo cumhacht nua don Chomhairle cruthúnas a lorg ó úinéir / áititheoir maoine go bhfuileadar ag fáil réidh lena gcuid dramhaíola i gceart.

2. Fiafraí air Comhairle Contae Chorcaí faisnéis a thaispeáint faoi na mbearta luas-rialiú atá í bhfeidhm I Clough Dubh faoi láthair.

Ask Cork County Council to report on the speed control measures in the village of Cloughduv at present.

REPORT

The adequate speed controls for a rural village such as speed limits and road markings are in place. There is a four cross road in the centre of Cloghduv Village and on the four approach roads (L2216 and L2205) there is a 50km/hr speed limit in place. Any issues with speeding are an enforcement issue for the Garda. The Area Office will list the cross roads and approach legs for the refreshing of road lining that is currently in place. There is no accident history at this locus and the last recorded accident was in 2009 and this was a minor accident.

In aon cás i ndáil le luas is saincheist forfheidhmiúcháin do na Gardaí é. Cuirfidh an Oifig Cheantair na crosbhóithre agus na cur chuige de, ar liosta maidir leis an athchóiriú líneáil bóithre atá i bhfeidhm faoi láthair. Níl aon stair timpistí ag an áit seo agus bhí an timpiste dheireanach taifeadta i 2009 agus is timpiste bheag a bhí ann.

Cllr. Moynihan queried if there could be a speed survey carried out and if the signs were effective enough. A O'Brien, EE said he would raise this with the Road Design Office.

J. Molloy, SEO said it was generally the local people who were the ones who speed.

Cllr. Lucey said that road lining was a huge problem. A O'Brien, EE said road lining will be carried out. He said that enforcement was a function of the Gardai and they should be contacted to install a speed van.

Cllr. Moynihan queried what was the policy regarding Speed Bumps.

3. Fiafraí air Comhairle Contae Chorcaí chun imscrúdú a dhéanamh faoi na roghnacha do faoiseamh toillte í droichead Teereaven, Lissarda.

Ask this Council to examine the options for flood relief for Teereaven Bridge, Lissarda

REPORT

The section of Public Road L-6002-0 south of Teeraveen Bridge is prone to flooding during and following periods of heavy rain. The primary cause of the flooding is a general build up of material/debris in the Buingea River as it flows east towards Warrenscourt. However, the County Council does not have any remit to clear this. It may be possible to raise a 200m long section of road south of the bridge by 300mm. This would cost approximately €25,000 to complete. Since there is no specific budget available for such work this would have to come from the ordinary maintenance budget for the area. At this early stage in the year I would prefer not to commit to spending this money, however, I will review our financial situation later in the year and consider the works at that stage.

Tá an chuid den Bhóthar Poiblí L-6002-0 ó dheas ó Droichead Thír Ré Mhín tugtha do thuilte le linn tréimhsí báisteach trom agus sna tréimhse ina dhiaidh sin. Is é príomhchúis an tuilte ná bailiú ginearálta de ábhar/smionagar ins an Abhainn Bhuingea agus é ag sreabhadh thoir i dtreo Cúirt an Bhairínigh. Mar sin féin, níl aon sainchúram ag an gComhairle Contae chun

é sin a ghlanadh. D'fhéadfadh sé go bhféadfaí thart ar 200m den bhóthar ar an dtaobh dheas den droichead a ardú de 300mm. Chosnódh sé seo thart ar € 25,000 le cur i gcrích. Ós rud é nach bhfuil aon bhuiséad ar leith ann le haghaidh obair den sórt sin bheadh sé seo ag teacht as an ngnáthbhuiséad cothabhála don cheantar. Toisc go bhfuil sé comh luath sa bhliain anois b'fhearr liom gan gealltanas a thabhairt an t-airgead seo a chaitheamh fós, áfach, déanfaimid athbhreithniú ar ár staid airgeadais níos déanaí sa bhliain agus déanfaidh mé breithniú ar na hoibreacha ag an bpointe sin.
