1. ELECTION OF CATHAOIRLEACH

All Members complimented Cllr. Conway on his role as Cathaoirleach.

Cllr. Conway then invited Nominations for the election of the new Cathaoirleach.

Nominations for Cathaoirleach

Cllr. Ted Lucey was proposed by Cllr. Creed and seconded by Cllr. Ryan. As there were no other nominations, Cllr. Lucey was duly elected Cathaoirleach of the Blarney Macroom Municipal District for the ensuing year.

Cllr. Conway thanked all the Members and staff for their co-operation and help during his time as Cathaoirleach. He also extended his thanks to the Media.

Cllr. Ted Lucey took the Chair.

Cllr. Lucey thanked his Proposer and Seconder and said he was looking forward to the year ahead.

Cllr. Lucey then invited Nominations for the election of Leas Cathaoirleach.

Cllr. Kevin Conway was proposed by Cllr. Moynihan and seconded by Cllr. Creed. As there were no other nominations, Cllr. Conway was duly elected Leas Cathaoirleach of the Blarney Macroom Municipal District for the ensuing year.

(a) Tower Playground – Update on Project

J. Molloy, SEO confirmed that an application had been submitted to the Department of Children and Youth Affairs for funding under the Capital Grant Scheme. He said once notification was received in relation to allocations a plan would be devised for the upgrade of the playground. Cllr. Ryan stated that it had been previously agreed that the public lighting would be improved.

J. Dwyer, SEE said there was no response from TII. He said there was some remedial work carried out.

J. Dwyer, SEE confirmed that the Vehicle Actuated Signs were ordered.

(b) <u>Grass Cutting Contract – Old Graveyard, Macroom</u> Cllr. Moynihan expressed her disappointment with the work carried out.

A discussion took place and the Members agreed that the maintenance of all graveyards needed to be improved. J. Dwyer, SEE said only one tender was received and that he was looking at other options available.

In response to Cllr. Moynihan, J. Dwyer, SEE confirmed that the contractor would be responsible for the weeds.

4. PROPOSED DEVELOPMENT OF 6 SOCIAL UNITS AT RADHARC NA CROISE DRIPSEY

E. McElroy, Executive Architect attended the meeting to informally brief the Members and gave an outline as follows:

- Originally 3 serviced sites which will be developed into 6 no. Houses 3 two bed & 3 three bed Terraced Houses
- Applied for funding in principle from the Department of Housing, Planning and Local Government. Once funding is received the project will proceed to Part 8 with the aim to be on site by the end of 2018 as the Part 8 will take approximately 4 months.

EM: Addressed in the Development

Have the final drawings been submitted

EM: Yes

Private scheme by Cork County Council

EM: Yes – subject to money received from the Department of Housing,

Planning and Local Government

Green area around the development

EM: Yes – the existing green area will remain in place

• Would one storey units be more preferable

EM: 1 bed single units are more suitable for an urban centre, this development is in keeping with the existing houses and responding to the needs of those currently on the social housing list

Any future developments should ideally be wheelchair accessible
 EM: Constraint in what was available, these were the best proposals

Part 8 Process

EM: Hoping to get confirmation of funding from the Department of Housing, Planning and Local Government in a couple of weeks and then go to Part 8. Tender documentation can commence once the Part 8 process begins.
