"That this Municipal district would conduct a proper review of the pay for parking machines in Cobh from an operational point of view. That details would be furnished on the number of times in the past year that each one has been out of order, the cost of repairing them and details of the tracking method for ensuring that they are operational. Also could we have an estimate on the cost of replacing some if not all of them to a newer more modern type of meter"

16. To consider the following Notice of Motion in the name of Cllr. Cathal Rasmussen:

"That this Municipal would give an updated report on possible new parking locations outside of the town centre itself as was raised months ago and which we are still waiting on"

17. To consider the following Notice of Motion in the name of Cllr. Cathal Rasmussen:

"That this Municipal District look at means of resolving the dumping of Rubbish in the Harbour Row area of Cobh and that steps are taken to prosecute the offenders. That we look at installing CCTV in the area and that any support that is needed by the residents in the area to combat this serious problem is given to them"

18. To consider the following Notice of Motion in the name of Cllr. Diarmaid Ó'Cadhla:

"That this Municipal District Council notes that current road access, Belvelly Bridge and the internal road network are grossly inadequate to service the needs Great Island.

Council notes that this limitation is preventing the development of the local community and the required housing, industry and tourism in the area, and at times it has left Great Island isolated and, consequently, put people's lives in danger.

Noting that the County Development Plan is due for review in the coming months we request that a plan for the resolution of this strategically important issue be included in the Issue Paper expected to be published in June 2019 and in the Draft CDP due in June 2020.

In advance of, and in order to assist this process, we request that draft drawings/plans showing potential new access routes for Great Island be drawn up for consideration by this Municipal District Council as soon as possible."

"That Cork County Council design a detailed Streetscape for Carrigtwohill. This design would be an automatic follow on to the 2009 transportation study and last year's Strategic plan both funded by Cork County Council"
