Once agreed, Cork Co. Council would commit to abide by those guidelines for any hedge-cutting/tree-surgery it is planning to carry out. Particular work that has been highlighted by members of the public or by Councillors as disproportionate to safety concerns would be reviewed by the Environment SPC or a sub-group thereof.

In addition, where landowners are asked by the Council to cut back trees or hedges for public safety they would be given information on biodiversity implications of this work & would also be further asked to abide by the hedgerow and tree management guidelines mentioned above.

These checks are called for in light of our biodiversity crisis and in light of

disproportionate hedge-cutting and tree-felling carried out by state agencies and landowners over the past year in particular.”
