I confirm that the live applications have not been assessed for eligibility as the Scheme's outline changes each year, therefore, we assess those being put forward each year as per that current year's criteria.

I also confirm that the costings on the live applications are preliminary estimates and no detailed assessment of the schemes has taken place. There are a large number of applications on the waiting list and it may be some years before works are undertaken. Therefore, a very simple estimate is done to give us an idea of the funding required in order to communicate our position to the Department of Rural & Community Development.

During this discussion the Members made the following points:

• Members thanked the Director for the report.

- Members welcomed the report but noted that the criteria is restrictive and has changed for eligibility.
- Members asked if additional funding can be accessed if offered.
- Said 60% of allocation should be spent early in the year.
- Noted that 150 applications were on the waiting list.
- Member requested that the Council be prepared to carry out the maximum number of schemes each year and that early clearance to commence be sought from the Department.
- Requested that the Council carry out as much work as possible early in the year so to be ready if additional funding made available.
- Members stated it was agreed at the Divisional Meeting to write to the Department and highlight the need to look at the criteria for eligibility of the schemes.
- Stated that it was not fair that those that applied a few years ago do not qualify now.
- Stated that the AERO report shows the Council cannot refuse Government funding and should be ready to spend the monies when granted.
- Asked if private operators could be used if additional funding is granted.
- Requested that criteria be broadened as some minor roads do not come under either scheme.
- Asked if funding could be rolled over to the following year if not utilised.
- Members stated they were well utilised schemes and were very appreciated by communities.

Mr. Aidan Weir, Senior Engineer stated that the Community Involvement Schemes (CIS) were very successful and there is a clear allocation at the start of each year.

He stated that the Local Improvement Schemes (LIS) is funded by the Department of Rural and Community Development. The Council received €1m at the start of the year. All of this will be spent in this current year. The Roads and Transportation Director has agreed to write to the Department regarding the criteria and conditions of the Scheme. He stated that presently the Council must abide by the current conditions and criteria.

"Members agreed to write to the Minister of Rural and Community Development, Heather Humphries, and request that criteria and conditions be broadened for the Local Improvement Schemes as the current conditions are too restrictive for some groups."

## PERSONAL ASSISTANCE SERVICE (PAS)

## Councillor Alan O'Connor proposed, seconded by Councillor Liam Quaide

A personal assistance service (PAS) involves the employment of personal assistants by disabled people in order that they may live as independently as possible. Recognising:

- 1. Ireland's ratification, in 2018, of the UN Convention on the Rights of People with Disabilities (UNCRPD), Article 19 of which states that disabled people have the right to live in the community and have access to a range of in-home and other supports, including a PAS;
- 2. The motion passed by Dáil Eireann on the 19th November which reaffirms that PAS should be legislated for as a right;

It is moved that Cork County Council also supports the right to a PAS for disabled people, for greater freedom, choice and control over all aspects of their lives, and to better enable us all to fully participate in an inclusive society as equals.

During this discussion the Members made the following points:

Councillor Alan O'Connor stated that this Motion has been passed by many other Local Authorities and requested that Members endorse this Motion.

- Members stated that disabled people do not always have freedom without a personal assistance.
- Noted that The Independent Living Movement of Ireland has set out how it is difficult for a person with a disability to make a career for themselves without having a personal assistant.
- Members said that the Disability Federation of Ireland has stated that Ireland has the lowest employment rate in the EU for people with disabilities.
- Members noted it will be a challenge to implement providing a personal assistant when required but stated it is a step towards a more inclusive society.
- Said that needs of young adults with disabilities need to be supported.
- Stated that 'job shadowing' that is already in place in the community is a huge advantage to everyone.
- Said that there are many people in society that can support others.

The Chief Executive said Cork County Council is committed to providing additional assistance to staff that might require it. He also stated that members of the public with disabilities are facilitated when accessing services.

### TACKLE CYBER/PHONE/EMAIL/TEXT CRIME

## Councillor Seamus McGrath proposed, seconded by Councillor Pat Hayes

"To request that the Minister for Justice and Garda Commissioner significantly enhance the capability of An Garda Siochána, in association with international partners, to tackle cyber/phone/email/text crime"

During this discussion the Members made the following points:

- Members stated there is an increase in online fraudulent activity and is widespread across society. It is at pandemic levels and has impacted people's wellbeing.
- Said that elderly people are worried about being victims of scams. They no longer trust
  electronic communications as they are not sure whether they are legitimate correspondence or
  not.
- Members requested that the Government and An Garda Siochána increase resources for dealing with this issue.
- The vulnerable people in society are being targeted.
- They noted there is a dark side to online activity.
- Stated that Covid 19 has made matters worse, and that email threats have increased.
- Stated that people are afraid to answer '01' phone numbers and now will only answer numbers they know.
- Members also sated that the public cannot block these numbers and there can be high costs if they ring back the fraudulent number.
- Expertise is needed to handle this crime.
- Suggested that "Private Numbers" on mobile phones should be barred.
- Stated that this is a multi-billion industry. A call can be made from any part of the world. Facebook and Instagram target young people.
- Suggested a "Rebellion" should be organised through social media.
- Number of Gardia should be increased to handle this crime.
- Not all crimes are reported and investigated people are embarrassed to say they were scammed.

- Stated that this is not just the responsibility of the public sector, the private sector has also a massive role to play.
- The Mayor asked that the Data Commissioner also be written to.

#### SUSPENSION OF THE CLOSURE PROCESS OF THE OWENACURRA CENTRE

#### Councillor Liam Quaide proposed, seconded by Councillor Michael Hegarty

During this discussion the Members made the following points:

- Members stated the Owenacurra Centre serves a number of Municipal Districts. It includes a day centre and other services. It was announced on the 28<sup>th</sup> June that the Centre would close on 31<sup>st</sup> October because of building defects.
- The ease of access to Midleton town is a key to the quality of life to the residents as it allows them to be active members of the local community.
- The Centre provides excellent service.
- Stated that the removal of the service from the East Cork town has left the families and clients distressed as no comparable options were put forward in it's place.
- To dislocate from the community will impact residents.
- Cllr. Quaide thanked the other 7 Councillors and 1 T.D. who previously wrote to the Oireachtas about this.
- Noted there were 3 centres in North Cork and would need double the size of Owenacurra to have similar capacity to the combined North Cork centres.
- The HSE officials have not met families or residents. The families feel that the answers received so far from the HSE are not answering their questions.
- Suggests that the families be allowed appoint their own structural engineer.
- Families are very concerned that alternative accommodations proposal are not suitable.
- There is a 50% proposed growth for East Cork in the Draft County Development Plan but this is stripping away one of East Cork Services.
- Members hope the Centre will be kept open and enhanced.
- Suggests writing to the Taoiseach, An Tanaiste, Leader of the Green Party and as well as Paul Reid, Chief Executive of the HSE and ask them to support and reconsider.
- The Day Service is also availed of by many.
- Midleton had a huge number of suicides among the younger generation. There would be a huge deficit if there was no day service.
- East Cork and Cobh Municipals are growing very quickly. Facilities like these should not be shut as people will be dependent on social or private renting. People need ongoing care.
- The funding is small for the overall important service.
- Mental Health is the Cinderalla of Health Services. Many residents have lived there long term and now they are been uprooted from the community.

- "Members agreed to write to the An Taoiseach, An Tanaiste, Leader of Green Party and Paul Reid, Chief Executive of HSE to request the following:
- 1) That families of Owenacurra Centre residents be allowed to appoint an independent structural engineer to assess the feasibility of renovations on the premises, and that the transfer of residents and staff be suspended while this is completed, and while the Public Accounts Committee examines documents relating to the closure rationale and the conditions of alternative premises.
- 2) That a local, community-based service plan for 24 hour staffed residential services be costed and time-lined for the broader client group of people with severe and enduring mental illness in East Cork as a matter of urgency, and that this would bring East Cork into line with 24 hour staffed residential provision per population in North Cork and West Cork.
- 3) That the Day Centre previously based in the Oweancurra Centre for Adult Mental Health service-users of the Midleton/Youghal Adult Mental Health Team be restored as a matter of urgency.

suspension of the closure process of the Owenacurra Centre Mental Health Facility, Midleton, including the transfer of resident, until such time as the Public Accounts Committee has fully considered documents relating to the rationale for closure and suitability of alternative facilities, and until an independent structural engineer, appointed by families of residents, has assessed the feasibility of essential renovations on the Owenacurra Centre"

### **DUNMANWAY POOL**

During this discussion the Members made the following points:

- Members stated the current closure/partial closure of Dunmanway pool had been raised at both Municipal District and Divisional level.
- They stated it was a state of art 25m pool.
- Currently it cannot facilitate regular groups or provide children's lessons due to the reduced opening hours.
- It was noted that the pools in Fermoy and Mallow are fully operative.
- A petition was made with 1000 signatures asking that a plan be formulated to reopen it on a full time basis.

During this discussion the Members made the following points:

The Chief Executive stated he had full confidence in the Western Divisional Manager and Municipal Officer to resolve the matter. He said a full briefing was given to the Divisional Committee last Monday. He sated this was the first item on the agenda for his meeting with his Divisional Mangers. The main objective here is to restore full capacity but presently cannot give a timeline.

- West Cork Members are constantly receiving queries regarding the reopening of the pool.
- Stated that it is outrageous and unfair for West Cork that this pool is being left behind. People want it re-instated as soon as possible. It is important for people's health.
- Stated there are 2 hotels in Bantry with pools. €3.5m Government funding was used for both the pool and state of art gym. Parents will want to use it over the mid-term.
- It is a fantastic facility that is serving a huge area from Bandon West to peninsulas. It is a shame to see it under utilised.
- A solution must be a priority.
- People are concerned and annoyed that is closed.
- Thanked the Executive for the report that outlined the reasons for closure and welcomed the Chief Executive's commitment to finding a solution.

• Understand that it will take time to solve and request that recruitment proceed.

The Mayor said presently there are huge challenges in leisure management recruitment.

The Chief Executive stated a detailed report was given to the Divisional Committee on the matter.
