During the discussion that followed members made the following points:

- Supports the principle there needs to be a look at Cork county Council's own policy
- The Housing SPC is awaiting management's comment on the draft policy
- With the changing demographics outdoor gyms for older people and walking facilities need to be figured in also

Members agreed to write to the Minister and refer the motion to the Housing SPC.

## **GOVERNMENT POLICY ON HOUSING AND HOMELESSNESS**

13/1-9

Councillor Diarmaid Ó Cadhla proposed, seconded by Councillor Melissa Mullane, the following notice of motion:-

"That this Council resolves as follows:

- 1. That we declare no confidence in Government policy on housing and homelessness.
- 2. That we should write to An Taoiseach to inform him of this no confidence.
- 3. That we ask An Taoiseach what emergency measures he could take in order to curtail the activities of vulture funds, rogue landlords and property speculators.
- 4. That this Council should draw up development plans for public housing on our own lands, throughout the county, and submit these for approval."

Introducing the motion Councillor Diarmaid Ó Cadhla requested that the following points be noted:

- There has been a 32% increase in homelessness in our region over the last 12 months.
- Rent prices are at an all-time high.
- Owing to continuing plunder by vulture funds and private interests in the property sector, that the crisis in housing can only get worse.
- The natural formation and development of families and communities is majorly disrupted through lack of access to housing.
- Reliance on privatisation in housing has increased inequality in our society.
- Homeless people are denied basic human rights, and many are left to die on our streets.
- Members of Council have a particular responsibility to represent community interests on the issue of housing.

During the discussion members made the following points:

- National crisis in child homelessness since Rebuilding Ireland
- Supports the regulation of AirBnB
- Cannot support items 1 and 2
- Do not support the motion of no confidence
- There is too much red tape associated with trying to progress new builds, to be silent is to be complicit
- Opposition viewpoints should be listened to more by government
- How many houses have been offered to Cork County Council by the banks and how many were taken up
- RTB is not protective of small landlords
- Add 'public & private' to number 4 on the motion

- AHB's too bound up by legislation Part 8s are very slow off the mark
- The economy is growing and housing will follow
- Contractors can't get people to work on building sites
- Funding is key
- An affordable housing pilot scheme choosing certain towns needs to be developed
- The Repair & Lease Scheme needs more publicity
- A downsizing scheme needs to be developed

In response the Chief Executive stated that he rejected the 'slow off the mark' comment with regard to Part 8, Cork County Council has not refused a single Part 8. Cork County Council has exceeded all government targets under the Action plan, the first in the country. Cork County Council has a dedicated housing capital unit but was denuded of resources for many years.

In response Councillor Diarmaid Ó Cadhla accepted the amendment regarding affordable housing, an amendment to omit parts (1) and (2) was proposed.

## CONSTRUCTION OF 37 TURBINES NEAR COOLEA
