The Senior Planner said that discussion did take place on the letter regarding the fact that there was an offer for €1 and it did not follow through. He said discussion then followed that there was no other lands available in that part of Carrigaline. He said he read out the correspondence at the meeting and it was agreed that it would be attached to the minutes.

Cllr. M. D'Alton asked if the EU directive for SEAs could be included for Ringaskiddy, this was agreed.

Cllr. M. Hegarty asked if there were maps included in the minutes.

The Senior Planner advised Members of the format of the minutes and advised that mapping is still being prepared and will be issued to Members at the end of the week. He recommended agreeing wording subject to mapping.

Cllr. F. O'Flynn referred to submission 16/16/12686408 and asked if 5 acres was included. Cllr. D. O'Brien said that it was on the list of amendments. Cllr. N. McCarthy said the submission was for 5 acres and it wasn't clarified at the meeting that this was included.

The Chief Executive said that nobody debated that issue and there was a proposal for 15 acres which changed and the confusion around same seems to be with the Members.

Cllr. K. Conway said that the map for Stoneview BM 03 02 07 is not adequate as it doesn't show the area and if the size of the shaded area is 1 or 5 acres.

The Chief Executive said it is clear but a larger map can be provided.

The Senior Planner said that is the site that was agreed at the meeting.

Cllr. A. Lombard said that a note is needed for the Southern side of Carrigaline, members were not aware what they were voting for. The Mayor advised that this was already noted in the minutes.

Cllr. K. Murphy said that the flood plains need to be looked at and maps revisited in the whole County where CFRAMS were not included.

Cllr. D. Ó Donnabháin referred to Pg.178 of the minutes and said that was not what was being sought from the zoning and it was asked for part 5 to be removed to simplify proposal.

The Chief Executive said that the intention is for a simplified phased proposal to enable the delivery of office accommodation first.

The Senior Planner said the more detailed flood study will be included and we will work with Members on same.

Cllr. A. Lombard queried the process followed for votes taken at the meeting.

The Chief Executive said that there is no issue with the process followed, and that he is satisfied with the wording of the minutes . The Mayor said the format of decisions was reflected in the minutes .

The Chief Executive said that the proposal for 5 acres in submission 16/16/12686408 was put to the floor and defeated and no map was presented on the night. He said that maps will be finalised shortly and the rationale for amendments must also be recorded.

Amendment to page 124 – of the Minutes of Council Meeting on 27th March, re Point Number 10:

10. Cllr. P. O'Sullivan proposed, seconded by Cllr. S. Sheppard, the following:-

- 1. Zoning Objective LI-X-01:
 - i. Delete text reference b) from zoning objective
 - ii. Re-order a) to e) of zoning objective to a) to d)
 - iii. Include reference to public open space (22 acres)
 - iv. Edit the site area to reflect reduced area of LI-X-01
- 2. Insert new zoning objective LI-X-02 (formerly northern portion of LI-X-01 and also including western portion of LI-I-02) as, medium B density residential development, up to a maximum of 250 dwellings, incorporating a landscape buffer between the residential units and other uses. A (TIA and RSA required). Also insert site area.
- 3. Amend site area of LI-I-02.
- 4. Insert new zoning objective LI-X-03 (western portion of LI-O-01) as, lands are to remain predominantly open space and rural in character. Limited potential for individual services sites, at very low density and up to a maximum of 15 dwellings, subject to a single agreed landscaping based scheme for all the lands. Any future development is dependent upon the provision of an adequate access. Λ (TIA and RSA required). Also insert site area.

The Director of Planning recommended no change to the Plan.

Roads & Transport SPC:

REPORT ON EASY PAYMENT METHOD OF MOTOR TAX PAYMENTS

8(a)/4-1

Cllr. D. Hurley gave an overview of the background from the Roads and Transport SPC, and said that it would not be a function of the Council to implement, so a request has been sent to the Department indicating the Council's willingness to act as a Pilot and also asked them to cease quarterly fees.

On the proposal of Cllr. Hurley, seconded by Cllr. K. Murphy, the Report on Easy Payment Method of Motor Tax Payments was agreed.

DRAFT POLICY ON DISABLED PERSONS PARKING

8(b)/4-1

Cllr. D. Hurley gave an overview of the policy and Cllr. M. D'Alton proposed that the following would be included.

"In 4(d) where it says, "Where public realm works are being designed or carried out, and where bus stops are being provided or modified, consideration to be given to providing adequate clearance for disabled access", that the underlined part be reworded to say "adequate clearance for disabled access should be provided". If Council is doing a public realm enhancement, there should always be provision for disabled access."

This was agreed

On the proposal of Cllr. D. Hurley, seconded by Cllr. K. Murphy, the policy on Disabled Persons Parking was agreed.

DRAFT POLICY ON ADVERTISING VEHICLES ON PUBLIC ROADS

8(c)/4-1

Cllr. D. Hurley outlined the terms and detail of the document and outlined exemptions for same.

During a discussion, Members made the following points:-

- Need to clarify that mobile advertising is included;
- People are now placing cars on private property at side of roads;
- Control needed re converting trucks into advertising on lands adjacent to busy roads;
- It should be implemented correctly in all areas;
- Will community/sporting groups be facilitated for temporary signs;
- Will Council remove signs or impose a fine under the Litter Act;
- Is Council responsible if someone hurts themselves from these signs;
- Will extra resources be deployed for this;
- Notice of public meetings should also be exempt;
- Communicate with small businesses before removing signs or imposing fines, need to take a pro-business approach;
- Sought update on water harvesting motion put before Council previously;
- Concerns regarding the survival of businesses without advertising;
- Include "or authorised by each Municipal District" instead of "law" in exemptions;
- Policy is not anti-business or communities, down to each Municipal District how they govern;

It was agreed to refer the matter back to the Roads & Transport SPC.

STATUTORY PUBLIC CONSULTATION LOWER LEE (CORK CITY) FLOOD RELIEF SCHEME.

12/4-1

Members noted the Flood Relief Scheme for the Lower Lee (Cork City).

The following observations were made:

Cllr Diarmaid Ó Cadhla

Noted that members had requested briefings from alternate sources of opinion. These briefings did not occur, and the decision is compromised.

Concerns remain with regard to the heritage impact of the scheme, and the safety of the people of Cork City.

Cllr Marcia D'Alton

- Was the two page letter enclosed with the minutes and sent to the Corporate Policy Group intended to speak on my behalf of all Members of Council? (It speaks of "we the Council".) It does not represent her views.
- Requested that the minutes of the Southern Committee meeting and the minutes of comments in relation to the scheme made at this meeting are to be appended. Need to see and confirm their content before they go to the OPW.
- Have concerns about the heavy construction nature of the proposals, the loss of centuries of heritage, visibility to the river and access to the river for recreational purposes and would like them noted in the submission to the OPW.

Cllr Mary Rose Desmond

Acknowledged that flooding was of extreme concern to home owners and businesses. Agreed with previous observations that concerns remain with regard to the heritage, architectural and amenity impacts of the scheme.

QUARTERLY REPORTS OF THE CHIEF EXECUTIVE ON CORPORATE AND LIBRARY SERVICES.

Suspension of Standing Orders - Bus Eireann Strike

Members made the following points:-

- This is an attack on Rural Ireland and an attack on working standards;
- Staff will lose up to €150 per week;
- Lack of access to the city for students and workers;
- Hospital appointments have to be cancelled;
- The Minister is not for the employees, he should stand aside;
- The Minister should not stand aside this is an LRC issue;
- The money needed to keep Bus Eireann afloat could be found;
- This is a social service rural Ireland has no other form of transport;
- The Minister has failed and should get involved.

It was agreed to write to the Minster for Transport.

It was agreed that the remaining items on the Agenda would be deferred to the Council Meeting on 24th April, 2017.
