Cllr. McCarthy opened the meeting by paying tribute to Council staff and officials on their recent work during ex-hurricane Ophelia.

# **Agenda for Budget Meeting**

- E. O'Halloran circulated Municipal District Draft Budgetary Plan for year 2018 and informed members that there was an extra €220,000 in budget in comparison to 2017. Members discussed and on the proposal of Cllr. Lombard, seconded by Cllr. O'Donovan Draft Budgetary Plan for 2018 was agreed.

# 2. Reports and Recommendations

# (a) Bandon Main Drainage Scheme

An update was circulated and was welcomed by members. Cllr Coughlan stressed the importance that all plans should ensure no further flooding at Oliver Plunkett Street.

### (b) Bandon Flood Relief Scheme

Update was circulated. Cllr. Murphy spoke about silt building up at bridge in Innishannon. C. McCarthy said that this was reported to the OPW

### (c) Update on Road Works

C. McCarthy distributed report and informed members that any outstanding works were in hand. Cllr. Lombard raised matter of non-reflective road markings at O'Leary's Cross. M. Daly said that this was being checked by lines contractor.

### (d) Report on Municipal Chairs Meeting

Cllr. McCarthy said that at the meeting Ophelia was discussed and that there was a positive feedback on how Cork County Council handled the situation and that the communication with the public was very good. Disappointment was expressed with regard to Irish Water and ESB. Cllr. Lombard said how service from Irish Water was inadequate as there was no back-up generators were provided in Minane Bridge or Crosshaven until the Thursday or Friday.

Cllr. McCarthy informed members that through Town & Village Renewal, Kinsale Museum was granted €80,000 and the Allin Institute was granted €32,000.

Cllr. Murphy asked for update on Part 8 for library and proposed to write to Clodagh Henihan. This was seconded by Cllr. Coleman. M O'hIci said that the Divisional Manager was considering all options.

### 3. Statutory Business

# (i) Presentation of the Ballinspittle Village Managers Report for adoption

B. Fehily passed out report to members and informed the meeting that eleven submissions were received. He outlined each submission.

M. O'hIci explained how the budget was €62,500 from Town Development Fund, subsidised with funding from path funding and RI funding, Cork County Council were showing faith in Ballinspittle's future by facilitating by the community. Members discussed various aspects of the proposal. On the proposal of Cllr. Coughlan, seconded by Cllr. O'Donovan the Ballinspittle Managers Report was adopted.

At this point in the meeting, it was agreed to suspend Standing Orders and it was agreed to extend time of meeting on the proposal of Cllr. McCarthy, seconded by Cllr. Lombard.

# (ii) Section 183 Disposal Notice - Disposal of land at Barret's Hill, Ballinhassig to Citidwell Homes Ltd.

E. O'Halloran informed members that this matter was adjourned to a future meeting.

# (iii) Joint Notice of Motion submitted by Cllrs Coughlan & O'Donovan

"That Cork County Council urgently undertakes a detailed hydraulic assessment to redefine the Flood Zone A and Flood Zone B extents along the Kilbrittain River as per Section S.I.23 of the Bandon Kinsale Local Area Plan"

Cllr. O'Donovan explained how a shop-owner in Kilbrittain was unable to get insurance and that the matter should be resolved as soon as possible. Cllr. Coughlan said how this was effecting households and business. C. McCarthy said that a County Flood Risk Survey was commissioned by the Planning Section.

On the proposal of Cllr. O'Donovan, seconded by Cllr. Coughlan it was agreed to contact Michael Lynch Senior Planner.

## (iv) Traffic Calming Scheme at Clancool Terrace, Bandon.

C. McCarthy passed out a Section 38 proposal for Clancool Terrace, Bandon and outlined the following:

- Speed ramps not the solution
- Funding was limited
- No submissions received

C. McCarthy indicated if this proposal wasn't effective, something else could be tried. On the proposal of Cllr. Coughlan, seconded by Cllr. McCarthy this was agreed.
