Ms. Susan Gallagher from Clann Credo presented to the LCDC members and a copy of this presentation had also been previously circulated.

Issues covered by presentation and Q&A session included the following;



- Community Finance (Ireland), formerly UCIT, is a Charity which provides loans exclusively to other third sector organisations such as community groups, charities, sports clubs and social enterprises in the Republic of Ireland.
- Clann Credo was founded by Sr Magdalen Fogarty and the Presentation Sisters in 1996.
- CFI Linkages with the LECP were outlined
- Application process for CFI and Clann Credo were given
- Social Impact of this funding was presented
- Clann Credo have funded 54 projects in Cork
- Both have a personal relationship with projects/groups to help them succeed
- The knowledge of social capital is not always known
- It is a non competitive sector
- Challenges seen by both at the moment include lack of cash flow to communities due to the delays with LEADER funding
- There are challenges for groups to fill in the application forms for funding
- The issues of governance was discussed and Charity regulations
- Bridging finance is so important to groups making applications for funding
