1. Confirmation of Meeting held on 3rd July 2017

The minutes of the North Cork LCDC meeting of 3rd July were proposed by Cllr. John Paul O' Shea and seconded by Ms. Marie O' Flynn and formally adopted by the meeting.

2. Presentation on Life Long Learning- Ms. Rachael Burke, Cork County Council Library Service

Ms. Rachael Burke from the Cork County Library Service made a presentation to the LCDC members on the Right to Read Literacy programme, please see attached.

Ms. Burke highlighted some case studies of the programme to date in the County. Following the presentation there was a discussion which included the following issues;

• Link with target groups in the Local Development Companies areas in North Cork



- LCDC members highlighted the need for one-to-one supports for dyslexia/dyspraxia
 Literacy issues for people that do not visit the library and accessing these people to assist them
- Examples of libraries in North Cork and their success to date

Ms. Burke was thanked by the Chair.

3. Cork County Community Facilities Scheme 2017-Approval of projects

Ms. Kay Keegan presented the approved list of the Cork County Community Facilities Scheme Projects to the LCDC. Ms. Kegan advised the LCDC members that the list of approved projects were to be treated as confidential until they are approved in full by the North Cork Municipal District Committees.

A summary of the scheme was given which stated that Cork County council had a total allocation of \in 64,500 under the scheme. The scheme offers one-off grants up to a maximum of \in 1,000 per project. Monies will need to be expended by end of 2017. Examples of projects deemed eligible under the scheme included:

- Community Centre Equipment;
- Office Equipment / Meeting Furniture;
- Sports / Recreation Facilities;
- Relevant Tools, Machinery and Appliances.

The Scheme is administered by the Local Community Development Committees (LCDCs) along with the Municipal Districts under the remit of the Local Authorities (LAs) on behalf of the Department. Cork County Council advertised the scheme in May 2017 through public newspaper advertisements, through the PPN network, through all Cork County Council formal communication channels and on the Council website and social media. Applications were invited for funding under this Scheme by 30 June 2017.

A total of 183 applications were received to the scheme broken down per Municipal District.

Evaluation committee meetings for North, South and North Division were held on the 21st; 22nd and 28th August respectively to consider applications to the scheme. A separate evaluation committee for each division was necessary to deal with the large volume of applications. The three evaluation committees comprised the LCDC Chair (North; South and North); relevant Municipal District Officers and Community Staff.

4. Healthy Ireland Fund

Ms. Fiona Hayes provided a summary report on a submission to the Healthy Ireland Fund please see attached.

Ms. Hayes outlined that In 2016 the government approved the creation of a national Healthy Ireland Fund with an initial allocation of €5 million.

Pobal is the designated authority to manage the distribution of the fund on behalf of the Department of Health. In August of 2017, LCDC's were invited by Pobal to apply to the initial Strand 1 closed call for funding: *Local Communities for a Healthy Ireland Initiative*.

Cork County Council on behalf of Cork County LCDC's applied for €300,000 under Strand 1 of the scheme. This application was submitted to Pobal on 15 September 2017.

The scheme will be managed locally by Cork County Council and implemented across Cork County in co-operation with the LCDC's; HSE, Local Sports Partnership and the Cork



Council Physical Activity and Wellness office and other key stakeholders. It will be necessary to establish a Healthy County LCDC sub-group to oversee the roll-out and implementation of the scheme. Strand 1 of the scheme will run until end of March 2018.

Action 4 - Staying Fit For the Future
