1. Confirmation of Minutes of 30th January 2017 and Matters arising

2. SICAP Report

Mr. Andrew Lewis confirmed that following the approval of the SICAP End of Year Review 2016 performance, and the Annual Plan 2017 at the last LCDC meeting on 30th January, the next contractual payment to the Programme Implementers had been made. Monitoring of the contracts was ongoing but the next formal performance review would be reported to the LCDC at the June 2017 meeting.

3. Presentation of the LEADER North Cork Website

Ms. Fiona Hayes gave an overview of the LEADER North Cork website to LCDC members www.leadernorthcork.com The presentation explained how to navigate the website, how to look up calls for Expressions of Interest, how to search to find your relevant Local Development Company and the contact details of same.

There was a discussion on other funding sources for community groups outside of the LEADER programme. The LCDC members wanted an update on where these were e.g. the Town and Village Renewal Scheme and CLÁR. Members were complimentary to how CLÁR was being implemented at a local level in North Cork.

The Chief Officer, Ms. Kay Keegan advised members that the LECF would be implemented in conjunction with the LCDC where they would see non LEADER actions./projects being piloted.
