Welcome and Introduction

The Chair welcomed all to the meeting. It was noted that a quorum was in place.

1.Presentation by Ms. Sheila Broderick HSE

Ms. Sheila Broderick from the HSE attended the meeting to speak on the Healthy Ireland initiative and the involvement of the HSE in this. Ms. Broderick gave the apologies of Ms. Priscilla Lynch who could not attend.

Issues covered included;

- Co-operation between agencies in the recent storm was complimented
- Community Services were explained as being separate to the hospital groups
- Community Services are co-operating with four care groups i.e. Mental Health, Social Care, Primary Care and Health & Wellbeing.
- The Local Implementation Plan was outlined
- This included a Compass diagram that includes 18 action areas and is an Integrated Holistic Plan
- Plan to be published and launched by 16th March 2018 and is available on www.hse.ie/corkkerryhealthyireland
- The healthy Ireland programme for Cork was outlined and the 100k per LCDC that was available, Cork County got 200k for 3 LCDCs
- The link to the LECP was cited
- The Healthy Cities and Healthy Counties was outlined
- Cllr. John Paul O'Shea requested that the LCDC would be consulted on future actions under further funding calls for Healthy Ireland

Ms. Broderick was thanked for her presentation by the Chair and left the meeting.

1. Confirmation of Minutes of the Previous LCDC Meeting of 5th February 2018

The minutes of the North Cork LCDC meeting of 5th February were proposed by Mr. Ned Brennan, seconded by Cllr. Bernard Moynihan and were formally adopted by the meeting.

2. Matters arising

3. SICAP

Nothing to report.

4. LECP

Ms. Sharon Corcoran, Director of Service reported that the LECP has now transferred to the Directorate of Economic Development, Enterprise and Tourism. Ms. Corcoran stated that there would be a new staff member in the Community section to undertake the Review of the LECP. There will be an LECP sub group which will look at themes in the LECP and assess progress on actions, undertaken by the Local Authority and relevant agencies.

The sub group will initially be tasked with identifying suitable proposals for Healthy Ireland. Mr. James Fogarty advised the LCDC that health actions cannot be delivered by the Local Authority and the forum for doing so should be within the LECP.

5. Healthy Ireland

Ms. Corcoran advised the LCDC that the Healthy Ireland funding of €200,000 will have to be spent by end of March 2018.

It was advised that Action 5 is currently being undertaken by Cork County Council. This conference will be held on the 1st May and is targeted at approx 500 transition year students from around the County to be held in the Radisson Blu Little Island.



A Healthy County Strategy is to be prepared and it is expected that this would be undertaken by a consultant.

6. A.O.B

Ms. Kay Keegan thanked members for attending induction training in Limerick. Members stated that they found it very informative.

Cllr. O' Shea requested that all funding schemes coming through the LCDC would be looked at in a workshop in April.

Ms. Brid Coakley thanked Ms. Fiona Hayes for her work on the LCDC and LAG and wished her well in her new role as the Age Friendly Co-Ordinator for Cork County. Ms. Hayes stated that she looked forward to engaging with members from North Cork in the future in her new role and thanked members and the Chair. The Chair & Chief Officer concurred.
