2. Healthy Ireland Fund - Mr Niall O'Callaghan

The Meeting agreed to take Agenda item 4 next. Niall O'Callaghan, Healthy Ireland Coordinator, gave an update to the meeting regarding the Healthy Ireland Fund. The projects that were approved under Round 2 are as follows:

Cllr. J. O'Sullivan asked that there would be special effort made to rural proof the activities under the Healthy Ireland Initiative and also that there would be co-ordination between Agencies in an area.



3. Social Inclusion and Community Activation SICAP Report

No update required on the SICAP Programme for this meeting.

4. Case Study Presentation by Comhar na nOileáin

The Case Study focussed on the setting up of a Men's Shed on Oileán Chléire, the need for which was identified through SICAP information meetings. Ms. Kay Keegan welcomed the initiative which showed collaboration between agencies including Cork County Council and the Education and Training Board.

5. LECP 2016 to mid 2018

Ms. Valerie Hayes presented a report on the Local Economic & Community Plan. The report outlines the progress made by Cork County Council under the 30 assets as identified in the LECP e.g. Human Capital, Employment/Income. Outside Agencies may need to deliver on some of the actions. The report suggested some potential Lead Agencies & Partners to advance the LECP and further reports will be presented to the LCDC.

6. Community Development Initiative 2018

Ms. Kay Keegan outlined the new capital grant scheme worth €1.5m available to communities and encouraged LCDC Members to promote the Scheme especially to groups who had not applied for grants before now. Ms. Keegan also advised that Local Development Companies are available to help community groups with the application process and that the final grant allocations will be presented to the LCDC for approval.

Ms. Phoebe Bright mentioned the importance of making a submission under the Public Consultation on the National Digital Strategy.
