Re: SECTION 177AE and PLANNING & DEVELOPMENT REGULATIONS 2001 (as amended) PROPOSED FERMOY WEIR REMEDIAL WORKS AND FISH BYPASS ON THE RIVER BLACKWATER, AT FERMOY WEIR (PROTECTED STRUCTURE), FERMOY, CO. CORK.

## Dear Sir/Madam

On behalf of Cork County Council, please find enclosed herewith an application in relation to Section 177AE of the Planning & Development Act 2000 (as amended) and the Planning and Development Regulations 2001 (as amended), in respect of the proposed Fermoy Weir Remediation and Fish Bypass Works at Fermoy, Co Cork.

The site is located at the townlands of Carrignagroghera and Fermoy and occupies an area of 5.1hA. The site comprises the Fermoy weir (a protected structure) and adjacent riverbed upstream and downstream of the weir along with lands on the north bank of the river Blackwater, west of Kent Bridge, and at Mill Island, O'Neill Crowley Quay and Ashe Quay on the South bank of the river. A letter of consent is provided in respect of lands which are not in the control of Cork County Council.

Plans and Particulars are included in the supporting documentation as listed in Schedule 1 appended herewith. Plans and other drawings included with the application are listed at Schedule 2.

The likely consequences for proper planning and sustainable development in the area in which it is proposed to situate the development are addressed in the Planning Report prepared by McCutcheon Halley, Chartered Planning Consultants.

The likely significant effects of the proposed development on a European site (the Natura Impact Statement - NIS) are addressed in the Natura Impact Statement prepared by Dixon Brosnan Ecological Consultants.

## The submission also includes:

- A Technical Engineering Report (including conservation engineer's report and flood risk assessment);
- Landscape and visual impact assessment (prepared by Doyle O'Troithigh, Landscape Architects);
- Underwater Archaeology Impact Assessment, prepared by Mizen Archaeology;
- Ecological Impact Assessment and Invasive Species Management Plan, prepared by Dixon Brosnan;
- Construction Environmental Management Plan and Outline Construction Management Plan, prepared by T.J. O'Connor & Associates;

 Fisheries aspects of the proposed works are addressed in the Technical Engineering Report (prepared by T.J. O'Connor & Associates), the Hydraulic Design Review and Fish Bypass Channel Assessment as well as the CFD Modelling report (both prepared by RHDHV) and also in the Fish Pass Operation Monitoring Plan (prepared by Trex Ecology).
