Pursuant to Section 85 of the Local Government Act 2001 as amended Cork County Council hereby agrees to enter into an Agreement with Clare County Council, Kerry County Council, Limerick City & County Council and Waterford City & County Council whereby Cork County Council will carry out all of the functions of these local authorities in respect of the Public Lighting Energy Saving LED Retrofit Project – South West Region with the exception of obtaining any necessary planning approvals and undertaking public consultation procedures as required under the Planning and Development Acts and Regulations.

It is hereby resolved under Section 85 of the Local Government Act 2001 as amended to enter into Agreements with the local authorities listed above for the provision of the services as outlined above.


