The Dept are insisting that persons applying most produce and submit income details through a combination of the following

Employment;

1)Pay and Tax summary Year to Date 2.) Statement of Liability and Employment Details, These figures can only be obtained from Revenue online Services after opening a Myaccount.ie

Social Welfare Income;

A recent Statement from Dept of Social Protection detailing all welfare payments Received. These figures can only be obtained from www.mywelfare.ie again after the person has opened a welfare account. This process is difficult enough for people with basic knowledge of I.T. And impossible for many applicants. Many applicants may not be in position to request a relation or friend to complete this task for them. In any event the applicant may not wish to share this info with close associates.

I would hope that the Housing Dept would be in position to include in Application documentation a signed form from Applicant allowing the Council Official to obtain this info from Social Welfare or Revenue.

At least then the Applicants could be sure that the information remains confidential."
