MUNICIPAL DISTRICT OF WEST CORK

Cllr. Danny Collins proposed, seconded by Cllr. Ben Dalton O'Sullivan

"That this Council would write to the Minister for Media, Tourism, Arts, Culture, Sport and the Gaeltacht, to request that the date for the commencement of the hedge cutting season would be brought back to August 1st from the date of September 1st as stated in the Wildlife Act, 2000."

During this discussion the Members made the following points:

- Advised that pressure needed to be put on the government to lengthen the hedge cutting season
- Said the matter is one of urgency on health and safety grounds
- Members proposed season be brought back to August 1st instead of September 1st
- Some Members voiced their dissent to the proposed letter
- Stated that noxious weeds and ragwort and hogweed were developing in hedges also
- Expressed that urgent guidelines were required with due regard to wildlife also
- Advised the health and safety of humans was paramount

During this discussion the Members made the following points:

- Members advised that Cork County Council had made applications but had received no correspondence
- Stated that an update was need on the programme
- Members acknowledge that progress cannot be made without a scheme
- Irish Water needs to take responsibility for treatment facilities as it's a huge problem
- Members said it was a challenge to residents of housing estates
- Finances not available for upgrading
- Development is limited by lack of Water Services capacity in some key villages

DEPARTMENT OF EMPLOYMENT AFFAIRS & SOCIAL PROTECTION

Members noted correspondence dated 7th July 2020 to Council's letter 24th June 2020 in relation to Back to School Clothing and Footwear Allowance (BSCFA).

Members welcomed the response from The Department of Employment Affairs and Social Protection.

BUS ÉIREANN

Members noted correspondence dated 6th July 2020 to Council's letter 10th June 2020 in relation to age limit for men and women who drive school buses for Bus Éireann.

During this discussion the Members made the following points:

- Expressed their dissatisfaction with the response
- Acknowledged that these drivers had passed medicals and had the qualifications required
- Wanted to know if their policy was to reject drivers aged 70 years and beyond
- Advised that Bus Éireann cannot discriminate on age grounds

Members agreed to write to Bus Éireann to follow up on the correspondence received on 6th July regarding age limit, and to ask if Bus Éireann was discriminating only on age grounds.

[h] NOTICES OF MOTION

RESIDENCY GRANT 11/7-1

Cllr. Noel Collins proposed, seconded by Cllr. Ben Dalton O'Sullivan

"That this Council call on the Minister for Rural Affairs in his residency grant improvement scheme funds, to review rural locations to include areas of historic interest this helping the tourist industry."

During this discussion, the Members made the following points:

- Members stated they welcome any support for historic sites
- Stated that villages and towns should do well in these scheme
- Acknowledge that it was hard to get businesses to reopen after Covid19
- It was suggested to that the County Archives meet with locals to get more information on local history

Members agreed to write to the Minister for Rural and Community Development, Minister Ring in his residency grant improvement scheme funds, to review rural locations to include areas of historic interest this helping the tourist industry.

ONLINE BULLYING 12/7-1

Cllr. Sinead Sheppard proposed, seconded by Cllr. Noel Collins

"That Cork County Council call on the Government to establish a Task Force to look at existing legislation dealing with the law on online bullying and abusive behaviour towards others in platforms and bring forward new legislation which gives adequate powers to a regulatory authority to deal with this issue."

During this discussion the Members made the following points:

- Acknowledge there are no laws specifically addressing cyberbullying
- Advised that current legislation for harassment laws is out of date
- Urgency needed to tackle online bullying and abusive behaviour on social media platforms
- Stressed the serious effects on a person's mental health
- Voluntary compliance by social media providers was not adequate control must be mandatory
- Young people in particular are at risk

Members requested to write to The Taoiseach's Office, Mr. Michéal Martin and Minister Ms. Helen McEntee, Minister for Department of Justice and Equality requesting the establishment of a Task Force to look at existing legislation to tackle online bullying and abusive behaviour.

N/M20 PROJECT

13/7-1

Cllr Liam Madden proposed, seconded by Cllr. Tony O'Shea

"That Cork County Council would write to the N/M20 Project Coordinator to arrange a meeting for an explanation as to why area which may be used for building of the new Cork-Limerick road has widened.

This Study area now has huge implications for planning applications. There is now the urgent need for final route selection and that serious consideration be given to reducing the width of this designated area by 30 September 2020."

During this discussion the Members made the following points:

- Welcomed the announcement of government commitment to the road
- Members suggested that N/M20 Project Team should meet with people who cannot get planning
- Expressed the need for proper consultation
- Stated that all plannings in study area are deemed "premature"
- Concerns on how plannings in the study corridor will be dealt with
- Scope of study needs to be reviewed with adequate number of options

Members agreed to the N/M20 Project Coordinator to arrange a meeting.

REOPENING OF PUBS

During this discussion the Members made the following points:

- Members suggested that an urgent cabinet meeting be held before Wednesday to discuss the reopening of pubs
- Acknowledged that publicans were in limbo with no guidelines being issued
- Advised that staff would have to be notified if returning to work on the 20th July and stock had to be ordered
- Stressed that 3-4 days wasn't enough time to get everything in order to reopen

Cllr. Gillian Coughlan proposed, seconded by Cllr. Gobnait Moynihan

During this discussion the Members made the following points:

- People with intellectual disability haven't attended day care centres since lock down
- Concerns raised as adults/children are regressing and carers are finding it hard to care and stimulate them
- Priority needed to reinstate services as a matter of urgency

Members requested that this Council write to the Minister for Children, Disability, Equality and Integration and the HSE Forum requesting that services be reinstated as a matter of urgency to prioritise their needs.
