Welcome and Introduction.

1. Confirmation of Minutes of the Previous LCDC Meeting of 24th October, 2019.

The minutes of the South Cork LCDC meeting of 24th October, 2019 were not adopted due to their not being a quorum present. These will be brought to the December 12th meeting for approval.

Matters arising

There were no matters arising.

2. Presentations from Sandy McGroarty, Transport Mobility Forum, Healthy Ireland Initiative and Ms. Tina Sheehan, Carrigaline Family Resource Centre (Passage West Food Initiative under Healthy Ireland Initiative).

Niall O'Callaghan for Cork County Council gave apologies on behalf of Ms. Sandy McGroarty and the first presentation was deferred.

Niall O'Callaghan introduced Ms. Tina Sheehan, Carrigaline Family Resource Centre. Ms. Sheehan gave a very informative presentation on Round 2 Healthy Ireland fund overview.

Ms. Kay Keegan thanked Ms. Sheehan for her presentation. Cllr. Marcia Dalton congratulated Ms. Sheehan and all involved in the project in Passage West. Cllr. Dalton commented that the project was highly effective considering such a small budget. Cllr. Dalton added that the community were also pleasantly surprised that the program was run free of charge to the community members, and delivered on its objectives. Cllr. Dalton commented that the program could be replicable to other groups such as men's groups who would benefit from learning to cook, sports teams, coeliacs and those suffering from other intolerances/allergies.

Ms. Mary O'Leary asked if there was a follow-up program planned. Ms. Sheehan commented that there is potential for a summer program, an activity program or a 'man with a pan' concept.

Thomas McHugh, Cork Chamber, commented that there would be potential for the program to delve into further promotion of local produce, sustainable development goals, shopping local and reducing waste.

Mr. Ryan Howard, SECAD, congratulated Ms. Sheehan and all involved. Mr. Howard commented that a similar program would be very beneficial throughout Ireland. Mr. Howard commented that the top down model in the HSE though beneficial to some, only focused on the urgent cases. An initiative such as the Passage West Food Initiative would reach the broader community and asked how Cork County Council could support this going forward.

Cllr. Cathal Rasmussen agreed and stated there could potentially be support through an SPC



3. SICAP

Cllr. Rasmussen stated a vote would be taken at the next meeting on Mr. John Fitzgibbons appointment to SICAP Cork County/City liaison group. Approval in principal was granted as there was not a quorum present.

4. Healthy Ireland Round 3 Fund
