Welcome and Introduction.

The LCDC was conducted through Microsoft Teams.

It was noted that a quorum was in place and the meeting commenced.

1. Confirmation of Minutes of the Previous LCDC Meeting of 24th June 2021.

- 2. SICAP:
- Approval of Mid-Year Review for Lot 18.4.

Andrew Lewis gave an update on the outcomes of the mid year reviews which were undertaken by LCDC SICAP Sub Group members together with the Local Development Company and LCDC SICAP Support Staff.

Andrew Lewis reported that the SICAP Sub-Group had held a meeting in advance of the LCDC meeting to consider the progress achieved by the Local Development Company as part of the SICAP Mid-Year Review 2021 and a summary of progress to date was reported to the meeting.

Mr Lewis confirmed that the programme is being rolled out by the following Programme Implementer for South Cork:

Lot 18-4 South & East Cork

SECAD CLG

The Mid Year Reports had been submitted on time by the LDC. It was confirmed that the Local Development Company had achieved satisfactory progress to date and the mid-term Key Performance Indicators (KPI's) have been achieved. The budgetary position as also deemed satisfactory at this stage. A small number of issues relating to data housekeeping in the ICT system were identified. These were forwarded to each LDC for them to address formally in writing, following the meeting.

The SICAP Sub-Group confirmed that satisfactory progress had been made by the LDC, and the Mid Year Review for the Lot can be approved by the LCDC.

Andrew Lewis thanked John Lyne and John Fitzgibbons for their work on the reviews for the Sub-Group. The Chief Officer thanked the SICAP team Andrew Lewis, Terence Sheehan and Maire Ní Thuama and the Local Development Company reps, Ryan Howard and Toni McCaul.



The Mid Year Review for Lot 18.4 was approved on the Proposal of Cllr. Michael Hegarty and seconded by Mary O'Leary.

3. Community Enhancement Programme 2020 - Reallocation of unspent allocations

The Chief Officer has identified groups where we were unable to fund their full requested amount and have receipts on file to support this.

In addition to the €2,885.89 to be reallocated under South Cork underspends, there was an additional amount of €5,363.85 in unspent funds from West Cork which have to be reallocated in South Cork. This brings the total reallocation to South Cork to €8,249.74. On that basis the following recommendations are now being made for reallocation:

Farran Community Association - It is recommended to allocate an additional €5,000 (i.e. €1,885.89 from South Cork underspend + €3,114.11 from West Cork underspend)

Ballygarvan Community Association - It is recommended to allocate an additional €3,249.74 (i.e. €1,000 from South Cork underspend + €2,249.74 from West Cork underspend)

Mary O'Leary asked why the additional €5363.85 in unspent funds from West Cork was not reallocated in West Cork. The Chief Officer confirmed that all monies that could be reallocated to West Cork had been and that there are no other suitable projects to reallocate monies to in this area and the CEP allocation is a county allocation rather than an individual LCDC one. Ryan Howard agreed with this approach. He asked if two groups were absorbing the full reallocation. The Chief Officer confirmed that this was the case. Thomas McHugh offered his approval for this approach and said that it would be good practice going forward.

4. Community Enhancement Programme 2021 - Allocations

The Chief Officer gave the following report:

Community Enhancement Programme 2021

The 2021 CEP scheme is funded by the Department of Rural & Community Development with support from the Local Community Development Committees (LCDCs) of Cork County Council.

The scheme was launched by Minister Humphreys on 10th May with a countywide allocation of €156,299 awarded to Cork County Council. As with the 2020 Scheme a minimum of 30% of monies had to be applied to projects of €1,000 or less. For 2021 there were three types of grants available:

- Small scale capital grant up to a maximum of €1,000 or less
- Capital grant in excess of €1,000
- One-off grants associated with the reopening or sustainability of a facility, these are limited to costs incurred or due in 2021 up to a maximum of €1,000. As per DRCD guidelines up to 50% of the total allocation could be allocated to this grant type.

The CEP was launched in Cork County on 15th June with a closing date of 4pm on Friday, 2nd July.

All projects have until 30th November, 2021 for drawdown of monies, this includes return of receipts plus photographs prior to payment being made.

The majority of applications were able to be funded either partially or fully. Those that were unsuccessful were either too large to be funded, the timeline for completion unachievable or the project was deemed ineligible under the scheme guidelines.

An analysis of the 170 applications received which was an increase on 2020, breakdown of allocations can be found hereunder:

Allocation for 2021:

€156,299

Up to 50% = €78,149.50 could be allocated to new grant type however, only 32 No. applications received — Allocated amount €31,500
Up to 30% = €46,889.70 could be allocated to projects of €1k or less
Amount Allocated to €1k or less = €38,000

Balance = €86,799 allocated to Projects of €1k or more

Peter Dineen asked that if no breakdown of costs is provided in an application are the group contacted. The Chief Officer confirmed that the community section would not have the capacity to do so and can only assess the applications based on the information provided.

Proposed by Cllr. Michael Hegarty and seconded by Thomas McHugh.

5. Community Development Initiative 2021 Overview

The Chief Officer updated LCDC members on the launch of Phase 2 of this scheme.

- €750,000 available. 25% of this is allocated for administration and animation by the Local Development Companies.
- Grant Applications, minimum of €1,000 and maximum of €25,000.
- Launch date: Monday 9th August 2021.
- Closing date: 4pm on Friday 17th September 2021.
- Closing date for completion of projects and claims: Wednesday 30th November 2022.
- This fund cannot be used as either a top up to any LEADER funding nor can groups
 who have made either an EOI or application or received funding under the LEADER
 Programme 2014-2022 apply for the same project or any element associated with
 the same project under the Community Development Initiative 2021. Groups that
 fall under this category can only apply for a completely different project.

Cllr. Cathal Rasmussen asked if a breakdown of the funds to be allocated to South Cork is available. The Chief Officer answered that allocations will depend on the applications that are submitted and that a breakdown for any division is not predetermined.

Cllr. Marcia Dalton noted regarding the Community Development Initiative 2018 that because so many applications for large projects were submitted a number of groups received a percentage of the amounts that they had applied for as opposed to the full



amount. She asked if these projects would be considered before new projects to facilitate them being completed. The Chief Officer confirmed that this is not the case highlighting that this was not agreed at the time in 2018 and that it was the evaluation committee at the time that made the final decisions on allocation amounts.

6. **AOB**

Cllr. Cathal Rasmussen passed on a vote of sympathy on the recent death of Tony Power, Cork City Council. Tony was part of the City Council SICAP team that recently met with South Cork SICAP Sub Group.

The Chief Officer congratulated Cllr. Cathal Rasmussen on his recent appointment as Vice Mayor of the County.
