Welcome & Introduction

1. Confirmation of Minutes of the Previous LCDC Meeting of 5th March 2020.

The Chair welcomed everyone to the meeting. It was noted that a quorum was in place and the meeting commenced.

The Chair offered condolences on behalf of the LCDC on the loss of fellow LCDC Member John Kennedy and Cllr. John O' Sullivan's father-in-law.

The minutes of the West Cork LCDC meeting of 5th March 2020 were proposed by Kevin Curran and seconded by Thomas Collins.

 Community Enhancement Programme 2020 Applications presented by the Chief Officer (see list of Successful Applications attached)

The Chief Officer noted that soft copies of the results of the scheme had been emailed to LCDC members at 2.00pm. She offered an overview of the results as follows:

Community Enhancement Programme 2020

The 2020 CEP scheme is funded by the Department of Rural & Community Development with support from the Local Community Development Committees (LCDCs) of Cork County Council.

The initial Countywide allocation made on 23rd June was €72,536 however, on 10th August Minister Joe O'Brien announced a top up to the scheme for an additional €219,478, this brought the overall total to €292,014.

As with the 2019 Scheme a minimum of 30% of monies had to be applied to projects of €1,000 or less. There were two types of grants available under this Programme:

- Small scale capital grant up to a maximum of €1,000 or less
- Capital grant in excess of €1,000

The CEP was launched in Cork County on 13th July with a closing date of 4pm on Friday, 7th August. As the top up allocation was announced after our closing date and the fact that the scheme was oversubscribed, it was decided not to re advertise the scheme.

All projects have until 31st March, 2021 for drawdown of monies, this includes return of receipts plus photographic evidence prior to payment being made.

There wasn't a requirement for an Evaluation Committee as additional allocation of monies allowed for the majority of applications to be funded either partially or fully. Those that were unsuccessful were either too large to be funded, the timeline for completion unachievable or the project was deemed ineligible under the scheme guidelines.

The Chief Officer clarified the following about the 5 unsuccessful applications:

- Kinsale Community Health and Wellbeing Resource Centre (Bandon and Kinsale MD): too large a project. In receipt of LEADER funding.
- Castlehaven Nursing Association (West MD): Ineligible.
- Cork Surf Lifesaving (West MD): Ineligible.
- Eyeries Community Development Ltd (West MD): too large a project. Redirected to a Local Development Company.
- Working Artist Studios (West MD): too large a project. Redirected to the Capital Culture Scheme 2019 – 2022.

The Chief Officer said that email and letter notifications would be sent to all applicants straightaway to allow groups to begin their projects immediately. Cllr. John O'Sullivan and the Chair commended the scheme.

The CEP 2020 allocations as presented to the LCDC were proposed by Cllr. John O'Sullivan and seconded by Cornelius Buckley.

3. SICAP Mid Year Review presented by Andrew Lewis

Andrew Lewis said that due to COVID 19 and as advised by the Department the usual meetings between the SICAP Subgroup, Local Development Companies & CCC staff face to face meetings did not occur and was replaced by a desktop exercise.

He noted that the SICAP Mid Year Review was recently completed and that the Local Development Companies for the three Lots in West Cork performed satisfactorily with no issues.

He outlined that the Department are due to meet with POBAL in the near future to discuss SICAP targets for 2020 in case Local Development Companies struggle to meet these targets as a result of COVID 19.

The approval of the SICAP Mid Year Review for Lots 18-5, 18-6 and 18=7 were proposed by Cllr. John O'Sullivan and seconded by Phoebe Bright.

Cllr. John O'Sullivan called for flexibility in relation to 2020's SICAP targets. He stressed that it is unfair to expect Local Development Companies to perform as well this year as in 2019 because of COVID 19. Cllr. Patrick Gerard Murphy reiterated this need for flexibility pointing out the employment challenges for West Cork due to the impact of COVID 19 on the tourism industry.

Andrew Lewis confirmed that the meeting between the Department and POBAL will determine how much flexibility can be afforded to Local Development Companies in relation

to SICAP targets. He said that the indications were that the required flexibility will be available.

Cllr. John O'Sullivan commented that the LCDC needs to be in a position to react quickly if future funding is made available by the Department. The Chair confirmed that the LCDC will be ready.

Phoebe Bright asked if it is known what industry has lost the most staff due to COVID 19 in West Cork. Enda McWeeney said that hospitality is by far the biggest employer in the area. Kevin Curran noted that interaction between Cork County Council and tourism businesses has been very high in 2020 with significant supports being offered by the Local Enterprise Offices.
