# 2. SICAP - Presentation of Case Study by West Cork Development Partnership - Fergal Conlon 'Try a Trade'.

Mr. Fergal Conlon & Mr. Mark Gaffney presented the case study which included a very informative video showing the practical skills gained by participants. The 2019 project included three disciplines including hospitality, beauty & construction. The presentation showed the uniqueness of the program, the hands-on approach of the program itself, along with the road to progression & the work experience acquired.

Phoebe Bright noted how impressive the initiative was and the value for money achieved by the initiative. Ms. Bright also noted how it was an opportunity to set the participants up for success in the work environment in the future. Ms. Bright questioned why only half of the participants had taken part in the follow-up. Mr. Fergal Conlon highlighted that it was difficult to stay in touch with the participants due to their age and circumstances, but also noted that it was a very positive to see that 3 of the 5 members of the travelling community that had participated transitioned to employment immediately after completion of the course. Mr. Conlon stated that the future could lead to other options for the initiative including retro-fitting and farming.

Mr. Kevin Curran asked if there were many participants who continued on to further education following completion. Mr. Mark Gaffney stated that some participants continued on to PLC Courses, none of the participants undertook an apprenticeship as they found it difficult to commit to long term education and preferred the PLC format. The short-term perspective seemed to be a trend amongst the participants.

Mr. Curran suggested a review of the participants at a later date to see the long term impact of the initiative on the participants.

Ms. Kay Keegan noted that the initiative was very impressive and that it could become a national program following review of the case study by the Department.
