CARRIGALINE MUNICIPAL DISTRICT

"Asked for a report to be issued on the mechanisms and structures of Spike Island to Elected Members and outlined in full."

Councillor Marcia D'Alton proposed, seconded by Councillor Seamus McGrath

Members noted the response from the **Director of Services**, **Corporate Services** which outlined as follows:-

Spike Island DAC is a wholly owned company with Cork County Council as sole shareholder. In accordance with the Companies Act(s), it's governance and operations are managed by a Board of Directors who are appointed by Cork County Council as shareholder. The Board, under Company Law and good governance practice is independent in it's duties, including its fiduciary duties and in the performance of its functions.

As with all companies, the Board produces its annual report and set of accounts which are easily accessible to the public. In addition, as sole shareholder, the executive of Cork County Council holds a meeting with the Chairperson and other Directors at least once a year to review the annual accounts and activity of the company to ensure the shareholder's interests are protected. These annual meetings are currently underway and are led by the three Divisional Managers.

The Council has 8 subsidiary companies which operate facilities, these being:

- Briery Gap Cultural Centre CLG
- Camden Fort Meagher Developments DAC
- Carrignafoy Leisure DAC
- Claycastle Leisure Company DAC
- Cobh Heritage Trust CLG

Cultural facility Tourism facility Leisure Centre facility Leisure Centre facility Tourism facility

- Hatherton CLG
- Macroom Environmental Industrial Park DAC
- Spike Island Development Company DAC

Economic development facility Economic development facility Tourism facility.

The annual reviews will, once complete, facilitate the preparation of an update for Members' on the annual performance and activities of each company and facility for information. It is proposed that these would be brought to the relevant Divisional Committee in the autumn and the mechanisms for same will be agreed through the Corporate Policy Group.

During this discussion, Members made the following points:

- Carrigaline MD received representations regarding access to Spike Island
- Said meeting had been held with the Fort Camden company
- Members asked how wholly owned companies report to councils in other counties
- The governance role of Members in local government was outlined
- Said they are very supportive of the aims of companies but would like to have more information
- Welcomed the mechanism for updating Members outlined in the report from the Director
- This will assist Members in their governance and oversight responsibilities
- Members said they would welcome the opportunity to discuss operational issues with the company representatives
- Said the information flow on Fort Camden with the MD was welcome
- Spike Island is not in Carrigaline MD
- The response to the motion clarifies the legal framework
- Members said they are seeking a form of Municipal District engagement with companies
- Said the public see these companies as part of Cork County Council
- Members on the ground need more information and want to be able to respond to queries from the public
- Suggested visits for Councillors be arranged to Council owned facilities

The Chief Executive said there are eight wholly owned companies under the control of Cork County Council. He said most directors of these companies are staff. The Chief Executive is satisfied with the processes in place to protect the Council's interests in company interests. He said the companies are responsible for the management of their facilities. He said it is not possible to have unfettered access to Spike Island as it is a tourism facility run by Failte Ireland and Cork County Council. He said the process for renewing and reporting to Municipal Districts will be discussed in CPG.

HOUSING SPC

"Consideration of Cork County Council's Draft Scheme of Priority for Affordable Dwelling Purchase Arrangements".

Councillor Seamus McGrath proposed, seconded by Councillor Kevin Murphy

Director of Services, Mr. Maurice Manning, said the draft scheme came from SPC as a recommendation. Mr. Manning said the Council is required to prepare the draft scheme. It will be sent to the Minister and if approved it will be sent back to the Council for approval. He gave a

presentation on Cork County Council's scheme of priority for affordable dwelling purchase arrangements and said the Draft Scheme had been circulated to members in advance of the meeting.

He said that the purpose of this Scheme of Priority is to set out the manner in which affordable dwelling purchase arrangements are to be made available by Cork County Council, and the methodology that will be applied to determine the order of priority to be accorded to eligible households where the demand for such arrangements exceeds the dwellings available.

This Scheme of Priority is made under Section 11 of the Affordable Housing Act 2021 (No. 25 of 2021). Eligibility of households will be assessed in accordance with Section 11 of the Affordable Housing Act 2021 (No. 25 of 2021) and Regulation 5 of the Affordable Housing (No. 2) Regulations 2022 (S.I. No. 184 of 2022).

He outlined the manner in which Affordable Dwellings will be made available and the main points were as follows:

Where the Council intends to make dwellings available in a particular location or locations for affordable dwelling purchase arrangements in accordance with the Act, it will:

Calculate, in accordance with relevant legislation, the relevant income limits for the purposes of determining a household's eligibility for each type of dwelling that will be made available.

No later than three months in advance of the date when the particular properties are scheduled to be completed, advertise the availability of the properties in at least one newspaper circulating within the administrative area and on the Council's website.

He outlined to the meeting the information that will be provided in the advertisement.

He said that applications will only be considered for the dwellings which are the subject of an advertisement. A household must submit a separate application for each advertisement where it wishes to be considered for the properties in the advertisement.

He then outlined the Order of Priority for Eligible Households and said that in cases where the number of eligible applicants exceeds the number of dwellings available for purchase, this scheme shall be used to determine the order of priority for all applicants.

An order of application will be assigned to applications received before the closing date.

The Council will decide which of the available types of dwelling would adequately cater for the housing needs of the applicant households.

Where the number of eligible applicants exceeds the number of affordable dwellings for which applications have been accepted, the priority of eligible applicants will be on the following basis:-

Dwelling Type	Meets accommodation needs of
Three-bedroom dwelling	Households of at least 2 persons
Four-bedroom dwelling	Households of at least 3 persons

Where the number of eligible applicants still exceeds the number of dwellings for which applications were made, priority shall be given to the eligible applicants in the date and time order that their applications were received.

30% of dwellings will be given to eligible households whose current address as given in the application form is within the Municipal District of the relevant affordable scheme or within 10km of this said relevant affordable scheme.

In addition to submitting evidence in relation to a household's eligibility criteria, additional documentation may be requested from applicants to assess their place in the order of priority under the criteria set out in this Scheme of Priority. This request to be made and satisfied prior to an Affordable Dwelling Purchase Arrangement being offered.

Following the presentation, a discussion took place where Members made the following points:

- Members said there is a huge need for Affordable Housing
- Said this is a step towards managing applications
- The scheme needs to be in place
- There is discretion regarding 30% of allocations in proposal
- A detailed discussion has taken place at SPC level
- Members said they wanted to give additional priority to local applicants
- 30% has been allocated within MD or 10 km radius, giving fairness to local applicants
- The remaining 70% is open to other applicants
- Said there is a huge response to the survey on affordable housing
- Members said they are disappointed re the "Qualification" criteria. Said some applicants are not eligible due to their income levels
- Said this must be discussed with the Minister as this criteria came from the Department
- Members enquired re persons with disabilities, asked if there is provision for this sector of the community

The Director of Services said there are no specific prices but Members will be fully briefed on individual schemes. Members agreed the Draft Scheme of Priorities would be submitted to the Minister. He said there is no fixed percentage for persons with disability but the intention is to have equality for all applicants in line with the provisions of the Disability Strategy.

ESTABLISHMENT OF A WOMEN'S CAUCUS GROUP

"That Cork County Council would ratify the formal establishment of a Women's Caucus Group"

Councillor Eileen Lynch proposed, seconded by Councillor Susan McCarthy

RESPONSE:

Members noted the response from the **Director of Services**, **Corporate Services** which outlined as follows:-

In 2017 the Oireachtas set up the Oireachtas Cross Party Women's Caucus to address issues that predominately affect women including the relatively low number of women in politics. A guidance document was prepared in 2020 entitled "Women beyond the Dail - Establishing Local Caucus for Women Councillors" and this was issued to all Local Authorities as a guide to those authorities considering establishing a Caucus.

Funding has been received from the Department of Housing, Local Government and Heritage to support the establishment of the Caucus and the establishment of its terms of reference.

The appointment of a committee of Council is a Reserved Function of Council and Standing Order 73 of Cork County Council's Standing Orders states:

"The Council may appoint a Special Committee for a specific purpose. When appointing such a Committee it shall at the same time determine the number and names of members to constitute such Committee and shall also fix the quorum which shall not be less than three. The term of office of a Special Committee shall be for the life of the Council unless otherwise decided by Council."

There are currently 17 female Elected Members of Cork County Council:

SUPPORT FOR FISHING FLEET

Councillor Joe Carroll proposed, seconded by Councillor Kevin Murphy

During this discussion, the Members made the following points:

- Members said fishermen conditions are worsening
- Said County Council need to do as much as possible for fishermen
- Fishermen are being hit hard by price increases
- French and Spanish fishing crews are receiving subsidies and other assistance, including subsidy to diesel costs
- Members said this support for French and Spanish fishing crews are leaving Irish boats at a disadvantage
- Said Brexit has been a huge blow to the Fishing industry
- Increases in fuel is crippling the industry and creating a reduced share in income from catches
- Members said the increased fuel costs is reducing wages for fishermen
- Said fishing is a vital indigenous industry and many communities depend on it
- Said the fishing industry needs to be protected now or there will be no industry left in 10 years
- Members said the Government should follow in the steps of France and Spain in providing assistance
- Said the fishing industry cannot sustain these increases and the Government need to reduce excise duty
- Said agricultural industry is also experiencing the same issues
- Members agreed to write to the Minister for Agriculture, Food and the Marine to seek a subsidy for the Irish fishing fleet, and agricultural sector to offset cost increases in fuel and to reduce excise duties on diesel
- Members agreed that two separate letters would be sent
- It was also agreed that the letter regarding support to fishing industry would be circulated to all Local Authorities

The Mayor said Ireland did not do well in Brexit and trade negotiations. He said the fishing industry is on its knees and the Government must act to support it or it will become a non-existent industry. He said a stand alone minster is needed for the industry.
