## 1.0 <u>Carrigtwohill URDF Initiative-Public Realm Infrastructure Bundle Part 8 Planning:</u>

D. Cronin outlined the proposals in relation to this project and, that the CE report was circulated to all elected members on 3<sup>rd</sup> June and contained 21 no. modifications to the original proposals. He advised that these modifications sought to address the submissions received during the public consultation process and the input/feedback received from the elected members. Following the meeting on Friday 10<sup>th</sup> June with the Cobh MD, a further 3 no. modifications are proposed within a CE Report Addendum (circulated to the Cobh MD prior to this meeting). He stated that the Part 8 proposals, as amended by the 24 no. modifications was being recommended to the members.

Cllr. A. O'Connor stated that he wished to thank the team for their efforts to date in relation to this project. He stated that while he didn't necessarily agree with everything being proposed, it was a fair compromise and he was happy with the overall project. On that basis he was happy to propose that the project be recommended to full Council.

Cllr. A. Barry seconded the proposal. He stated that, like Cllr. O'Connor, he didn't agree with every individual element, but he was satisfied that the proposal would protect the future of the village.

Cllr. S. O'Callaghan stated that she was happy to support the project. She stated that it was good to see the good relationship between the members and the officials in relation to getting this project developed.

On the proposal of Cllr. A. O'Connor seconded by Cllr. A. Barry, it was agreed to recommend adoption of the proposal with modifications to full Council. It was agreed that the matter be forwarded for inclusion on the Agenda for full Council on Monday  $27^{th}$  June.
