What is the Economic & Community Monitor?

- E&C Monitor is a custom designed online data resource that consists of relevant and accurate datasets and indicators from the main authoritative sources in Ireland – hosted on a Local Authority website
- E&C Monitor contains hundreds of individual indicators under 15 Themes across multiple geographies
- Evidence Toolkit and Information portal for the county to support data driven policy & decision making (Development Plan, LECP, Economic Strategies, RSES, Community groups, Charities)

- Data refreshed/updated on a Quarterly basis (Jan, April, July and October)
- Depending on the data source of the indicator, the Monitor will be updated on a quarterly basis with all datasets being updated where appropriate
 - o Every quarter the Live Register/Labour Force will be updated
 - Property Market/Housing Supports data quarterly
 - o Crime, Tourism, Incomes annually
 - o Environmental indicators updated every year
 - All Census indicators were updated in 2017 Now contains 2011 and 2016 results. 2022 results next year.
 - o Local Electoral Areas/Municipal Districts updated 2019
