Presentation of Case Study for West Cork Development Partnership by Fergal Conlon.

Fergal Conlon presented a short video which focused on an initiative which provides afterschool language classes for foreign language children attending a Bandon School in conjunction with the Bandon Family Centre. He acknowledged the language barrier as a key challenge for these children and said that the project has been very successful in helping to increase their school attendance and confidence. He noted that there has been extra work required in this area due to the recent arrival of Ukrainian children and that this workload is going to increase in the coming months.

The Chair, Cllr. Declan Hurley and Arran O'Driscoll praised the work being done on this project. Ryan Howard congratulated the SICAP teams undertaking this type of work and commented that SICAP needs to be better resourced especially in light of the Ukrainian crisis.

Fergal Conlon presented an internal report he had received from his Development Officers which detailed the activity on the ground. Phoebe Bright asked if the report can be shared and the need for more SICAP funding highlighted. The Chief Officer said that a Community Response Forum is in place and that this can be fed into it to be looked at. She added that all relevant stakeholders are represented on the Forum. The Chair, Cllr. Declan Hurley said that he is the Chair of the Forum and would raise the issue in the next meeting the following morning. Phoebe Bright asked if the report can be shared on social media. Fergal Conlon said that he would check with the author and if ok send the report to the Chair for sharing.

Enda McWeeney expressed concern about the upcoming summer months when Ukrainian children will not be attending school. He said that it will be difficult to keep them busy.

Fergal Conlon commented that he would welcome further resources for SICAP. He said that SICAP workers are currently in a firefighting stage but need to move to supporting and facilitating volunteers to ensure that SICAP workers roles are sustainable. The Chair, ClIr. Declan Hurley acknowledged the risk of burnout for individuals assisting with the Ukrainian crisis.

The Chief Officer recommended that the Community Response Forum send a letter to Minister O'Brien as he is a strong supporter of SICAP. Arran O'Driscoll agreed with this.

The Chair, Cllr. Declan Hurley thanked Niall Healy's team for their hard work in addressing the Ukrainian crisis. The Chief Officer thanked Fergal Conlon and Arran O'Driscoll for the presentation.
