Mr. Maurice Manning, Director of Services Housing, said the draft scheme was considered on 27/06/2022. It was sent to the Minister for Housing for review where further clarifications and modifications were made. The Department recommended that the link to the MD map would be

included for clarification. The Department also recommended that the 10 km would be reserved as the crow flies.

During this discussion, the Members made the following points:

- Members said they are happy that affordable housing is kept local
- Said they are getting queries from people who want the scheme up and running
- Queried a timeline on the scheme in Clonakilty
- Asked for a timeline on the scheme and for a press release with information on how to apply for the scheme
- Members said the Housing SPC did a lot of work on this scheme
- Members asked about the income limits to qualify for the scheme

The Director of Services said they will aim to get a Part 8 submitted for Clonakilty early next year. Mr. Manning said they are waiting for an update on income limits for social housing, a review is to take place. He said there is a difference in income limits between the City and the County. Mr. Manning said the house price is dependent on what a buyer can afford to pay, a discount of up to 20% is expected.

During this discussion, the Members made the following points:

- Members said the Department are asking for Local Authorities to roll out these schemes earlier in the year
- Only 1 LIS scheme has been approved so far this year in the Kanturk/ Mallow MD
- Said the budget is not sufficient
- Asked for this issue to be referred to the Roads SPC for further discussion
- Said there needs to be a better process in place to take up these schemes within the year
- Members said that some applications may no longer be eligible as the criteria changed 3 years ago
- Stated applications from before the criteria was changed need to be assessed under the old criteria
- Expressed concern that there are no fall back schemes
- Said that some roads are in very bad condition, especially cul de sacs
- Stated waiting times are a big issue
- Members asked if some of the works could be contracted out
- Said LIS schemes are very restrictive in urban areas due to agricultural constraints
- Said there needs to be a system where 60% of this year's money can be spent before it is approved
- Members agreed that this motion would be referred to the Roads SPC for further discussion
- Members agreed to write to the Minister to request that the application forms for LIS schemes would be simplified and made more user friendly.
- Members also agreed to ask request that any applications in the system before the introduction of the new scheme should be assessed under the old criteria

REVIEW THE HOUSING ADAPTATION, MOBILITY & OLDER PERSON GRANTS

"This Council calls on the Minister for Housing to review and update the Housing Adaptation, Mobility and Older Person Grants. In light of rising construction costs, the grant amounts need to be increased and the income thresholds also require updating. The range of works permissible should also be reviewed, particularly for the Older Person Grant, taking account of the need to promote renewable energy and new technologies."

Councillor Seamus McGrath proposed, seconded by Councillor Sean O'Donovan

During this discussion, the Members made the following points:

- Members said a review is long overdue especially with rising construction costs
- The grants have not been reviewed for a number of years
- Income limits are restrictive and need to be reviewed
- The qualifying income limits need to be adjusted
- People are getting less work done with the money provided
- The cost of materials is gone up by 50% in some cases

- Stated some applicants are not applying for the grants as they know they won't get the works done with the money available
- Said these grants provide essential funding for people to carry out works
- These grants can help people to live at home independently
- Members said the outcome of the review needs to be published and changes need to take effect
- Members agreed to write to the Minister to ask for the grant amounts to be increased, income threshold amounts to be updated & the promotion of renewable energy technologies

Members agreed to suspend standing orders to discuss the issue of AIB banks going cashless.

Mayor Danny Collins proposed, seconded by Councillor Declan Hurley

During this discussion the Members made the following points:

- Members said the government are out of touch with their citizens
- Said that they are worried that this move has been paused not stopped
- Stated that banks have a social responsibility to citizens

- Positive sign that Central Bank has intervened
- Members said that AIB and the government are out of touch with rural Ireland
- Said the loss of banks in towns is marginalising rural communities
- Said customers should have a choice whether they want to engage in digital banking or not
- It is important that Post Offices and Banks are supported
- Public interest directors should be reinstated in AIB
- Members said AIB abandoned its customers and the government abandoned their citizens
- Said it was reckless of AIB to try and implement this move
- Said that rural communities cannot operate in a cashless society
- Said there needs to be a blended approach to banking
- A practical and working solution to digital literacy needs to be implemented
- Stated cash is an essential part of our community, banks have to continue to give that service
- Positive that Central Bank intervened and should be thanked for their intervention
- Members said Central Bank should only issue licenses to banks with cash included

The Mayor said that people were devastated with the announcement of cashless banking by AIB. He said this announcement should not have been made. He said that post offices need to be developed further and expanded nationally. He said the Kiwi bank system, currently used in New Zealand, needs to be introduced here. He said AIB need to explain why this decision was made and to ensure that it will not happen for at least 10 - 15 years. Members agreed to write to the CEO of AIB, Minister for Finance and the Governor of the Central Bank.
