#### 1. CONFIRMATION AND SIGNING OF MINUTES.

#### 3. REPORTS AND RECOMMENDATIONS OF OFFICERS

a) Municipal District Officers Report.

Matthew Farrell MDO presented the report. Full Report circulated. The MDO Sought the members approval for allocation of funds from Newmarket Town Development Fund (*From TDF Reserve 2022*) for €3,000.

Proposed Cllr. John Paul O'Shea, Seconded Cllr. Ian Doyle.

Following the report, the members made the following observations / comments.

All members welcomed the Clar funding.

Cllr. John Paul O'Shea Will a Section 38 be required for Kilcorney and Freemount. Clar delighted to see 5 successful projects, Cllr. O'Shea queried if there were unsuccessful projects in order to work with groups to ensure they reapply in the future and provide assistance. Cllr. O'Shea queried if a meeting was forthcoming to discuss the design of the park in Ballydesmond with elected members. €903,000 investment and would like a greater input. Requested the inclusion of Dromina and Kilbrin on the monthly MD report going forward part 8's have been approved with over 12 months

Cllr. O'Shea expressed his concerns in relation to a lack of progress on the extension of both graveyards.

**Response:** works due to be carried out in Kilcorney and Freemount are traffic calming measures referred this query to the SEE for response. In relation to Clar 7 applications made by KMMD 5 successful the two unsuccessful applications were because one group were unable to provide enough proof of land ownership and the other application wasn't strong due to time constraints. The MDO stated that he will work with these two groups in the future to assist them in securing funding. In relation to the Ballydesmond project conveyancing taking a long time. He assured members that consultations have not taken place. Once the land ownership is resolved the project will be moved forward. Works are due to be scheduled in Kilbrin. Development should commence in the next number of months. In relation to Dromina land negotiation is still underway.

**Cllr. Gearoid Murphy** Requested a general tidy up of the entrance to Spa House he also queried if it would be possible to include the entrance overlay to Spa house when the car park work is going on.

**Response:** The MDO stated that works are ongoing in the car park at the moment once these are complete a tidy up of the entrance will take place. Budget not available for Entrance overlay however these works can be included on a programme of works so that if additional funding becomes available the overlay will be considered.

Cllr. Liam Madden Sought an update on the picnic area at Navigation Road. Expressed his disappointment in relation to lack of facilities in Mallow Castle. In relation to Mallow Castle he requested a report with projects completed / outstanding money spent funding applied for. Cork County Council Depot wall looks unsightly, Cllr. Madden has been approached by art students that are interested in taking on the project. He asked if the MDO could contact Mallow Arts to facilitate the project. In Bridge Street there is some buildings that are unsightly could something be done like Bridewell Lane to improve the appearance of the street.

**Response:** The MDO stated that €3,000 was approved by members at the July meeting for the placement of picnic benches and the placement of one of the two canopies. He will request an update and revert. The MDO stated he has committed to a tender process for facilities at Mallow Castle. He will request an update on Mallow Castle and provide an update to members prior to Octobers meeting. The MDO will revert to members with a decision on the Depot Wall. The MDO acknowledges Bridge Street needs improvement.

**Cllr. Pat Hayes** requested a base for a motor home in Mallow. Cllr. Hayes requested a clean-up of Spa stream considering nesting season etc.

**Response:** Acknowledged the benefit of the concrete base in Mallow. He stated that this is a query for the tourism section, however Kanturk Mallow MD would sully support the provision of a mobile home base in Mallow. The MDO will discuss the clean up with the area engineer. Bio Diversity will be a factor.

**Cllr. Ian Doyle:** Sought an update on Dromina Graveyard. Grass Cutting was slow to take off this year requested an earlier start to the tender process to avoid delay next year. Sought an update on the Autumn and Winter planters in towns and villages. Islands on the N20 are unkept asked if these could be cleaned and painted.

**Response:** In relation to Dromina this was answered in response to Cllr. John Paul O'Shea's query. In relation to Grass Cutting SEE Dennis O'Regan has the matter in hand. Comments in relation to planters is noted. He will look into a clean-up of the Islands on the N20.

**Cllr. Tony O'Shea:** Requested an update on the Skate park. Fully supports Cllr. Liam Madden in relation to the facilities at the castle.

**Response:** The MDO stated the amount of funding in place isn't enough to develop the Skate Park. Trying to secure additional funding to complete the project is ongoing.

• The Section 38 report for the Traffic Calming Works at L1042 Castlemagner, Co Cork was circulated to members by email on the 31/8/22. Following on from this, I am now seeking approval to proceed with that these works in Castlemagner subject to funding becoming available. Queried the possibility of having a bank of Section 38's ready to progress the project when required.

Proposed Cllr. John Paul O'Shea, Seconded Cllr Gerard Murphy.

Following the report, the members made the following observations / comments.

Cllr. John Paul O'Shea One submission in relation to a ramp on the graveyard side of the GAA pitch he asked if this could be considered. All ramps need a section 38 if it is included now it will be in place if required in the future. He stated the importance of expediting the works in Kilcorney and Freemount funding is in place and he would like to see these projects completed ASAP.

**Response:** The SEE will consult the NNRD office and see if a ramp can be included. The SEE stated that there has been concern expressed from residents in adjacent to speed ramps terms of noise pollution. Therefore, a more favourable option would be horizontal deflection, road narrowing and vertical deflection such as raising junctions, making towns and villages more pedestrian friendly.

The SEE has met with a consultant engineer in Freemount and Newtown and a survey is being competed. With the funding available both villages have been looked at in detail with the hope that both villages can be brought to Section 38 approval. Funding available will not cover construction costs. The SEE stated he will contact the traffic and transportation office to see about extra funding to bring it to detail design stage. Agrees banking Sections 38 are a good idea as a requirement of the NTA is that projects are shovel ready. A design for Kilcorney is complete and a section 38 is being prepared.

**Cllr. Gearoid Murphy and Cllr. Bernard Moynihan** requested an update on the Ballymacquirke junction. Queried when the speed control measures will be installed in Grenagh.

**Response:** The SEE will contact the Cork NRD Office and request an update to be circulated to all. Andreana Sheehan EE said a lot of objections were received once these have been reviewed she would hope that she will bring the Section 38 before members in October.

**Cllr. Tony O'Shea** welcomed the gully cleaning in light of recent weather and asked if estates could be included. Requested clearer signage at Merritt's Corner clearer signage for HGV's is required.

**Response:** The SEE stated they are to preparing an operational plan for Mallow Town to include maintenance of the entire town. He will consult the town engineer to discuss better signage at Merritt's corner.

**Cllr. Liam Madden** requested lines are redone in town as the paint had become faded. Sought an update on the crossing at Muddy Hill to Spa House. Welcomed the safety fencing out the Spa. Sought an update on footpath repairs in Mallow. Requested a finish date for Grenagh crossing. Bells Cross pedestrian crossing doesn't have any flashing lights should there be. Stated the importance of hedge cutting and contacting landowners in relation to the maintenance from a safety point of view. Queried the possibility of speed calming measures at River Valley.

**Response:** The SEE said he will discuss the lining with the town engineer. Spa Road pedestrian crossing is assigned to the engineers assigned to the municipal district. Following discussions with them an independent review will be carried out to ensure the safest crossing point is selected. The SEE stated the fence erected at the Spa was erected on a temporary basis. The fence type was determined by the existing ground and what worked for foundation purposes. The sole purpose is safety. The surfacing in Grenagh will take place the 20<sup>th</sup> of September. SEE is hopeful the pedestrian crossing will be completed over the next few weeks. The SEE will follow up with the area engineer in relation to Bell's cross and revert. The budget for hedge cutting is limited. For private land ongoing engagement with private landowners is ongoing and paramount. The SEE said he will make contact with CCC's communications department in relation to a possible media campaign. No update on speed calming measures at River Valley the SEE said he will consult the town engineer to see what work has been done to date.

**Cllr. Pat Hayes** sought an update on a manhole cover before Spa Bar causing noise Pollution. Queried if traffic light sequence could be looked at in Mallow. Traffic is congested and needs to be tweaked to improve the flow.

**Response:** The SEE said that following discussions with the town engineer a

commitment was given by the utility company responsible for the manholes to rectify the problem. He will seek a further update. In relation to the traffic light query, the SEE said he will respond to this in his reply to two motions raised on this matter.

**Cllr. Ian Doyle** In relation to the two active travel allocations for Charleville, one which is near completion i.e. the entrance to the town park from the car park and the ramp. Can the project continue without the ESB carrying out there works. The second project which money was allocated was for the Railway road for a cycle lane and road narrowing. Cllr. Doyle queried if these funds could be used to enhance the footpath. Cllr. Doyle stated it is a very busy walkway.

**Response:** The SEE said waiting for the ESB is best practice. He will speak with Traffic and Transformation section with regarding changes to the application. A consultant will be engaged to prepare a design.

**Cllr. James Kennedy** Expressed his support for the changing of the lights in Mallow and the improvement of footpaths in Mallow. Sought an update on the manholes on Bridewell Lane. Queried if an engineer can authorise the trimming of a tree or is a tree surgeon required.

**Response:** The SEE will reply to traffic light queries with the notice of motion raised. He will seek a follow up on the manholes. Best practice is to engage a professional when carrying out tree maintenance. There is a limited budget therefore an arborist is the best person to ensure the limited budget available is put to the best use. CCC always makes safety a priority.

#### 4. NOTICE OF MOTION

a) Cllr. Gearoid Murphy 10/08/2022 "That the Thomas Davis Plaza in Mallow be deep cleaned or power-washed."

Proposed Cllr. Gearoid Murphy, Seconded Cllr. Pat Hayes.

**Response:** The SEE said Power Washing works were completed by the Mallow Town crew on the 10<sup>th</sup> and 11<sup>th</sup> of August 2022. He has arranged to meet with a pressure washing contractor today to assess the cost in conducting further cleaning works with specialized equipment. These works will be progressed if the 2022 budget allows.

- b) Cllr. John Paul O'Shea 23/08/2022 "That Cork County Council would provide an update on the completion of NTA approved schemes for 2022 for the Kanturk Mallow Municipal District as announced earlier this year".
- Proposed Cllr. John Paul O'Shea, Seconded Cllr. Ian Doyle.

**Response:** The SEE provided an update to members.

c) Cllr. John Paul O'Shea 23/08/2022 "That Cork County Council provide an update on the derelict site that is the old library in Kanturk"

Proposed Cllr. John Paul O'Shea, Seconded Cllr. Ian Doyle.

**Response:** Matthew Farrell MDO said the issues with this building are ongoing over a number of Years. Scaffolding was put in place to secure the building and prevent debris from falling from the Building. The File is under review. The property activation unit have viewed the file. Further remedial works may be required before the scaffolding is removed. Cllr. O'Shea said his opinion is that local groups and members have tried to engage with the

Owner without success therefore the only option is a Compulsory purchase order. Cllr. O'Shea expressed his concerns in relation to the length of time the process is taking he stated that the activation unit is in place now along with national funding, therefore CPO needs to happen ASAP. Urge officials to re-engage with the property activation unit and the divisional Manager and seek a response for the next meeting.

d) **Cllr. John Paul O'Shea 23/08/2022** "That Cork County Council provide an update on the Christmas lights plan for Charleville Town for Christmas 2022".

Proposed Cllr. John Paul O'Shea, Seconded Cllr. Ian Doyle.

**Response:** The MDO stated that the plan is near completion. He reassured members that the lights are safe. The plan is to replace the existing lights over the next few years. The condition of lights is safe and there will not be an issue with lights for this coming Christmas.

**Cllr. Tony O' Shea** queried the Christmas lights in Fair Street and the Spa were left out last year. **Response** The MDO said there are Issues with the height Of the buildings therefore trucks and Vans are getting caught. Affordability is an issue.

e) Cllr. Tony O'Shea 24/08/2022 "That Cork Co Council would look at a low cost safety scheme coming off the Carrigcleena road L-1214-38 and onto the Bweeng Grenagh road."

Proposed Cllr. Tony O'Shea, Seconded Cllr. Liam Madden.

**Response** The SEE stated This locus will be inspected by our office in conjunction with the road management and development unit. If the required sightlines for the given location are obstructed, a scheme will be proposed and our Non National Road Design Office will progress the detailed design required for construction. The proposed scheme will then be added to the Cork County LSC list.

f) **Cllr. Tony O'Shea 24/08/2022** "That Cork Co Council would provide an up-to date report on the synchronization of the traffic lights at mallow bridge."

Proposed Cllr. Tony O'Shea, Seconded Cllr. Gearoid Murphy.

**Response:** The SEE has been in contact with the NNRDO who have advised that fine tuning of Traffic lights will commence as soon as normal traffic conditions resume. I have been advised that Arup have been deferring this until the return of school traffic and the removal of temporary traffic management for water services upgrades. The SEE is of the understanding that fine tuning is to commence shortly.

g) **Cllr. Tony O'Shea 24/08/2022** "That Cork Co Council provide an update on the community enhancement scheme for Liscarroll village."

Proposed Cllr. Tony O'Shea, Seconded Cllr. Liam Madden.

**Response:** Update provided and information document circulated to members. Road resurfacing works scheduled for October – managed and scheduled by the NNRDO

h) Cllr. Gearoid Murphy 26/08/2022 "To seek an update on the N72 overlay programme between Mallow Roundabout and Oliver's Cross; in particular regarding funding for this project, and to ask when the Spa Glen section of the project will go out for procurement." Proposed Cllr. Gearoid Murphy, Seconded Cllr. Tony O'Shea.
Response: The following is the update received from the Cork National Road Office:

There is a TII allocation of €1 million in 2022 for Phase 2 of the N72 Annabela to Lacknamona Pavement Strengthening Scheme which relates to the N72 Spa to Spa

Glen section. The design and contract documents are currently being prepared and we hope to progress a tender competition for this scheme in the coming weeks. The Cork National Roads Office is also progressing the design and contract documents for Phase 3 of this pavement strengthening scheme, commencing at N71 Annabella Roundabout and continuing along N72 Park Road, and subject to TII approval and available funding, we would hope to progress a tender competition for this Phase 3 scheme later this year or early next year.

i) Cllr. Liam Madden 29/08/2022 "That Cork County Council Developers and Iarnoid Eireann would look at options of walkway and cycle route on Killarney /Kennel Hill side of railway especially with volume of houses being built in that area"

Prosposed Cllr. Liam Madden.

**Response:** The MDO said he will look into it.

j

j) **Cllr. Liam Madden 29/08/2022** "Rubbish bins in town and park need to update same have any options been looked at."
