3. Presentation by Catherine Seale, Community Water Officer, Local Authority Waters Programme

Title: Update on the Local Authorities Water Programme

# **EU Water Framework Directive**

- Achieve at least good water quality in all waters by 2027.
  - o State agencies, local authorities and public bodies working together
  - Involvement of water users and the public giving a voice to communities!
  - River Basin Management Plans, in three cycles:
  - o 1st Cycle 2009-2015
  - o 2nd Cycle 2018-2021
  - o 3rd Cycle 2022-2027

The health of Ireland's streams, rivers, lakes, and estuaries.

- Nationally 53% of our surface waters are in Good or High ecological status.
- 47% are in an unsatisfactory ecological status
- Cork County better than most!
- However increasing nitrates & WQ in estuaries are a concern

Pressures on Water Quality in Cork County



- Hydromorphology 16%
- DWWWTS 5.9%
- Agriculture 28.2%
- Urban run-off 9.6%
- Urban wastewater 10.1%

## Community Water Development Fund

- The Department of Housing, Local Government, and Heritage funds LAWPRO to
  provide the Community Water Development Fund. This fund supports community
  groups to enhance the quality of local streams, rivers, lakes, and coastal areas. The
  fund has been in place since 2017, with growing interest year on year.
- The standard of applications for funding is high, making the assessment process more difficult. The fund delivers a broad range of water projects that benefit the amenity of local areas. Types of projects approved for funding include:
  - Awareness raising initiatives such as river clean ups, biodiversity information boards, citizen science workshops, outdoor classrooms, rainwater harvesting, and enhancement of wetlands.
  - Preparation of local plans such as feasibility studies, habitat management plans, ecological surveys, and biodiversity action plans.
  - River and habitat enhancement works such as planting of native species and hedgerow, pollinator friendly planting, river-bank stabilisation, fencing and riparian buffer zones.

The Chair Cllr. Michael Hegarty thanked Catherine Seale for her presentation. He asked if water levels were being monitored during the dry spells this summer and Catherine confirmed that they were and that the data will be available later this year. Cllr. Michael Hegarty noted that many people in South Cork need to upgrade their septic tanks but are ineligible for grants to do and said that it would be welcome to address this. Catherine Seale agreed.

Arran O'Driscoll referred to a river badly effected by Japanese Knotweed and asked if LAWPRO could assist the community in dealing with it. Catherine Seale confirmed that she has worked with Japanese Knotweed previously and advised the community to contact LAWPRO to do a study of the effected area and hopefully move to treatment of the Japanese Knotweed as funding Is available.

Liam MacCarthy asked if nature-based solutions to the management of rainwater help during dry spells. Catherine Seale said that these approaches help to slowly release water and therefore help to prevent rapid run off of water if flash flooding occurs after a dry spell.

Tom Howard queried the best way to deal with Japanese Knotweed. Catherine Seale confirmed that injecting the stem is the best option.

Arran O'Driscoll asked for the LCDC to be kept informed about future LAWPRO training. Catherine Seale offered to add interested members to a mailing list.

Jimmy Hosford asked if current figures on the ecological status of Cork's waters are an improvement on previous figures. Catherine Seale said that they are mostly same as new figures are only released every 3-4 years with 2018 being the last year that data was issued however, she anticipates that new figures will be available from the EPA in 2023.
