Cork County Council have prepared a Section 177AE application to be lodged with An Bord Pleanála for the proposed road realignment and improvement scheme, in the townlands of Dromdeegy and Cooranig, Dunmanway, Co. Cork.

The existing road is substandard because of its inadequate width and poor horizontal and vertical alignment geometry. The realignment works will run over a length of approximately 410 meters with tie into the existing road at both ends. As well as improving the alignment, the overall cross section width of the road is to be improved thereby improving driver visibility.

The proposed overall road improvement works will consist of the following

- Alteration to existing road alignment to improve road safety
- Site clearance
- Road construction, resurfacing, road lining, signage and road studs
- Relocation of overhead line
- Construction of earth berms and fencing

**A Natura Impact Statement (NIS) has been prepared as part of the application for approval in respect of the proposed development.**

Cork County Council invite Inland Fisheries Ireland (IFI) to make submissions or observations in respect of the application and NIS in relation to:

- i. The implications of the proposed development for proper planning and sustainable development in the area concerned,
- ii. The likely effects on the environment of the proposed development, and
- iii. The likely significant effects of the proposed development on a European site.
