# DRAFT COUNTY CORK CREATIVE IRELAND STRATEGY 2023-27.

Mr. Ian McDonagh, Arts Officer, informed the members that a proposed County Cork Creative Ireland Strategy 2023-2027 had been presented at the Corporate Policy Group on 6<sup>th</sup> December 2022. He advised that the Creative Ireland Strategy came about after the Commemoration Programme in 2016. He noted that the previous Creative Ireland strategy focused on engaging and interacting with communities with regards to arts, culture, heritage, language, environment, health and technology and was a great success overall. He stated the five pillars that are to be prioritised for the period of 2023-2027 are:-

- Creative Youth
- Creative Communities
- Creative Industries
- Creative Health and Wellbeing
- Creative Climate Action and Sustainability.

Ms Maeve Mulrennan, Assistant Arts Officer presented the 2023-2027 Creative Ireland Strategy.

She outlined that Creative Communities are deploying creativity to achieve greater integration across targeted policy priorities. This has delivered new creative engagement initiatives in relation to young people, older persons, climate action and local economies. Individuals and communities' perception about the role and value of culture and creativity is central to citizens' wellbeing and in its broadest sense is being enhanced.

She outlined that the strategy process began in March 2022 and consultation was held in a number of locations and online during the summer. From this, key themes were identified. The PPN Linkage Group also reviewed the plan.

The strategic priority objectives encompassing the primary role of the local authority in the delivery of the Creative Ireland Programme are:

- Connected, Creative Communities
- Creative Placemaking and Representation
- The Creative Economy
- Wellness and Creativity
- Creative Climate Action

### **During a discussion, Members made the following points:**

- Members thanked Mr McDonagh and Ms Mulrennan
- Members said that this is an exciting scheme and a welcome strategy.
- Members noted that the Arts are extremely important.
- Asked in relation to Clonakilty if it's possible to create a storage area for arts group to store equipment.

The Mayor said that the issue of storage should be dealt with at West Cork MD level.

The Mayor acknowledged the collaborative efforts in the preparation of the Strategy.

- Members noted that the patients deserve better as they are transferring patients far outside of their communities and from single rooms to shared rooms.
- Said it was clinically and ethically indefensible.
- Said there were not enough replacement beds in East Cork and no local community based options.
- Said that house setting suits some patients but other patients need this type of residential care.
- Said that it was an unsatisfactory arrangement for all concerned.
- Member agreed to write to Stephen Mulvaney to ask him to meet with the families of the residents concerned in the closure of Owenacurra Care Centre.

- Members also agreed to write to Minister for Rural & Community Development.
- Members agreed to circulate letter to all Local Authorities.

#### **RESPONSE:**

Members noted the response from the **Director of Services, Roads & Transportation,** which outlined as follows:-

We would like to thank Cllr Moynihan for this NOM proposing to honor the women of Cumann na mBan, by naming the new roundabout (at Coolcower), on the N22 Bypass after them. This proposal will be assessed together with other naming proposals for new Junctions on the N22 Baile Bhuirne to Macroom Road Development Scheme, including Coolcower. Such assessment may include public consultation in the area and will be agreed by and with the Members of the Macroom Municipal District in due course.

#### During this discussion, the Members made the following points:

- Members said that no history would be complete without mentioning Cumann na mBan and the extremely brave work they did during the War of Independence and this would be a valuable way to commemorate them and show equal recognition to their male counterparts.
- Said women's role had been whitewashed from history.
- Members congratulated the CE, Roads Department and TII on the great job done on the Macroom By-pass.

- Members acknowledged that this would be a fitting tribute to the women of Cumann na mBan.
- Said that Macroom Municipal District should name this roundabout.
- Members noted there was no legislation or procedure regarding namings.
- Members noted that it should be put out to public consultation.
- Said it was currently known as the "Coolcower Roundabout".

The Chief Executive said that there is no specific legislation around placenames and is a matter for the Municipal District to consider. He also noted that the TII should be consulted on this matter as it was part of a national route.

- Said the maximum amount of tax relief that you can currently receive is €200 which is not good enough.
- Said that this tax relief was not raised despite inflation.
- Said that people need to have health insurance and the health service has been subject to years of under investment.
- Members agreed to amend the notice of motion to read as follows:-"That Cork County Council would write to the Government and the Minister for Finance to reintroduce an income tax credit scheme to incentivize and encourage many many more Irish people to take out personal health insurance cover while also preserving the existing rebate of up to €200 at the point of purchase."
- Members agreed to write to the Minister for Finance and send a copy of the letter to all other Local Authorities.

- 1. Members queried regarding salt & grit bins in estates. The Chief Executive said that salt and salt bins are provided free of charge for this week by request to local area offices. This is done by filling out an application which is available on the Council's website.
- 2. Members said there is a concern for the lack of communication and payment from government to some people hosting Ukranian refugees as some haven't been paid for several months and are now threatening to withdraw their facilities.
