

1. Part 1 News & Updates

1.1 National Climate Action Plan 2023 (CAP 23)

The government published CAP 23 on the 21st December last. Some key elements as follows:

- Increased role for Local Government in Citizen Engagement;
- A Just Transition Commission;
- Unprecedented investment in climate action over the next decade;
- Enhanced analytical capacity is being developed by the DPER;
- Ambitious renewable energy targets -9 GW from onshore wind, 8 GW from solar, and at least
 5 GW of offshore wind energy by 2030;
- IDA Ireland, Enterprise Ireland and the Sustainable Energy Authority of Ireland will work to help decarbonise industry and align grants and other supports with emissions reductions;
- Acknowledgement of need to work out ways to assist broader society with the costs of retrofitting;
- Fleet electrification and use of biofuels will continue to provide the greatest share of emissions abatement;
- Guided by the Food Vision 2030 Strategy, Farmers and food producers to prioritise environmental, social, and economic sustainability;
- The Land Use Review will inform the sector's sectoral emission ceiling;
- Reduce food waste by 50%
- Ensure that all plastic packaging is reusable or recyclable by 2030;



PUBLIC SECTOR

The public sector will play a leadership role in driving far-reaching climate action across its buildings, transport, waste, and energy usage, as well as wider society. This will include reducing emissions by 51% by 2030 and increasing the improvement in energy efficiency in the public sector from the 33% target in 2020 to 50% by 2030, as well as increasing climate literacy in the public sector, implementing green public procurement and retrofitting public sector buildings.

GOVERNANCE

The actions to deliver on our ambition and decarbonise our economy will be supported by a robust governance structure that now includes Ireland's first carbon budget programme and sectoral emission ceilings. The Climate Action Delivery Board will have an enhanced role in relation to delivery, including providing recommendations for overcoming barriers, while taskforces will be established to focus on key specific areas or initiatives of climate delivery that require cross- Government collaboration. In addition to this, an annual climate action planning and reporting cycle will be introduced.

The Environmental Protection Agency and the Climate Change Advisory Council reports will continue to inform the monitoring of Ireland's climate action performance on a sectoral level. The Government will annually update the new Climate Action. Plan and the roadmap of actions to reflect developments in the previous year, developments in technology and research in relation to climate action, and to ensure the required emissions reductions are achieved.

1.2 Climate Action Regional Office (CARO) Update

- LA Climate Action Plans (LACAP) signing of ministerial order requiring LAs to commence process of drafting Climate Action Plans is likely to occur on or before 7th March 2023.
- Latest CARO **Draft Guidance document on preparation of Local Authority Climate Action Plans (LACAP)** now also covers the question of Decarbonization Zones (such as Macroom) and how they can be progressed.
- **CARO Guidance for the Climate Adaptation of Regional & Local Roads:** CCMA CATCEN committee meeting 12th December, agreed the following strategy / projects were:
 - Phase 2 Strategy Document
 - Phase 3 Scoping Report on Carbon Management & Green Public Procurement
- Coastal Erosion Guidance Document final report of working group approved by CCMA CARO is currently engaging with DHLGH re funding to draft a guidance document.
- CARO Energy Manual for LA Municipal Buildings An Energy Manual to assist Local Authorities in managing various building types is at an advanced stage and is currently being reviewed and finalised by CARO.

1.3 Waste Enforcement Regional Lead Authority (WERLA)

1.3.1 Single Use Plastics Directive (SUPs).

There are several Regulations due for publication in the coming months to cover the levy on single use coffee cups, fishing nets etc. The respective roles and responsibilities of Local Authorities and Environmental Protection Agency remain to be confirmed.

1.3.2 Exemptions under Burning Regulations

The **Exemption which allowed farmers to dispose of green agricultural waste by burning** e.g untreated/uncontaminated wood, trees, trimmings, leaves, bushes has again expired on the 1^{st of} January 2023. A working group was established by Minister in 2022 to look at alternatives – it was to have reported by December. No communication from DECC yet, so as of now the disposal of green agricultural waste by burning is illegal.

1.3.3 Deposit Return Scheme (DRS) for plastic bottles and aluminium cans.

Minister of State with responsibility for Communications and Circular Economy, Ossian Smyth, launched Ireland's national Deposit Return Scheme (DRS) on the 28th of November last. The Scheme will include PET plastic bottles and aluminium and steel cans between 150ml and 3 litres. A deposit of 15c will apply to containers 500mls or less and a deposit of 25c for each container above 500ml. The Scheme will be operated by Deposit Return Scheme Ireland CLG, trading as **Re-turn**. All producers and retailers are legally obliged to register with Re-turn. Registration of producers and retailers will be the key focus for 2023 with registration now open at www.re-turn.ie. The planned 'go-live' date for consumers in February 2024.

1.4 Amendment to EU Good Agricultural Practice for Protection of Waters Regulations.

On 20th December last the Minister published amendments to the European Union (Good Agricultural Practice for Protection of Waters) Regulations 2022, also known as the Nitrates Regulations.

The purpose of the amended regulations is to give effect to changes made under the Common Agricultural Policy Strategic Plan in following areas;

- width of buffers strips has been increased, (i.e the distance from waters where which fertiliser can be spread, and where lands can be cultivated),
- changes to facilitate the processing and sharing of data to enable calculation of the livestock excretion rate bands for dairy farms, (the higher the milk yield/cow the higher the excretion rate/cow), which will impact on maximum stocking rates on dairy farms,
- reducing the storage height of silage bales outside of farmyards, (no more than 2 bales high to minimise effluent loss),
- to provide for an earlier reporting date for the Environmental Protection Agency Nitrates Action Programme (NAP) Review to ensure that there is sufficient time to inform development of the next NAP, (changed from 30th June 2025 to 1st October 2024)

In addition, other articles have been amended to provide clarification, and three definitions on poaching, grassland stocking rate, and dairy cow, have also been added.










1.5 Particulate Matter Monitoring goes live in Carrigaline.

A monitor, measuring Particulate Matter (PM) emissions has recently been commissioned in Carrigaline with real time information being available via the EPA's <u>airquality.ie</u> network.

The monitor currently measures PM 10 micron but will in due course be upgraded to measure the finer and more harmful PM 2.5-micron particles.

1.6 Community Environmental Awareness Programmes


1.6.1 Climate literacy course for post primary schools

Cork County Council recently invited post primary schools in the Southern Division of Cork County to register interest in a Climate Literacy Course. The 10-week course will be delivered in schools during the second and third terms of the 2022/23 academic year by Education for Sustainability. Cork County Council will fund all costs, i.e., €1600 per school. While we are piloting it with schools in the Southern Division, we would hope to roll it out to schools in both Western and Northern Divisions thereafter.

The 10-week course combines online resources including lesson plans and an online student workbook as well as in person teacher training for one class grouping for 10 weeks. While the course is very suitable for Transition Year or CSPE it can also be integrated with other subjects. A facilitator will visit your school weekly to deliver the course and simultaneously train the teacher(s). Course topics include climate change, sustainable development, climate justice plastic, fast fashion, sustainable transport, biodiversity loss, food and soil and taking action. The online course materials will be made available to all teachers in the school and online training sessions will also be held for any teachers wishing to integrate climate literacy into other subjects.

1.6.2 Community Recycling Award for Relove Paint at the Irish Environmental Pakman Awards

We were delighted to accept the Community Recycling Award, on behalf of the partners of Relove Paint, at the Pakman Awards on 28th October last. A unique collaboration between Cork County Council and Cork City Council, unwanted water based paint is collected at both local authority civic amenity sites by three social enterprises, Cycle Sense Skibbereen, IRD Duhallow and a Northside Community Enter Cork city, who filter, remix and recolour the paint before selling it back into the community at a low cost. The project resulted in 5 tonnes of paint being diverted from incineration/landfill and made available to local enterprises. To date 2,200 litres of paint have been sold back into the community with the volume of sales increasing all the time. A great example of the circular economy in action.

1.6.3 Fast Fashion Workshops for Post Primary Schools

In November, Post Primary Schools were invited to participate in Fast Fashion Workshops delivered by Circular Fashion Ireland and fully funded by Cork County Council's Environmental Awareness Office. To date 7 schools have participated in workshops, 2 schools are scheduled for January and one remaining space will be advertised to all schools across the county to close out the 10 committed workshops.

The workshops are available to all classes, 1st year through to 6th year and are 90 mins in duration to include Q&A. Some of the topics covered include:

- What is fast fashion?
- Environmental impacts of fashion & textiles industry
- Sustainable fashion
- Circular economy and fashion
- Reuse & Repair

1.7 National Broadband Plan (NBP)

1.7.1 Fibre Roll-out (BCPs)


NBI rely on their parent website at https://nbi.ie/ to provide information on the National Broadband Contract. Website https://nbi.ie/nbp-project-progress/ provides detail on the roll-out progress and the website advises the number of premises in the Intervention Area has grown by 17K since commencement of the project. NBI also advise the roll-out programme remains on target to be delivered within the originally planned 7-year programme. The national roll-out programme for 2022 envisages:

- Premises under construction to grow by 43%, to 221,000 homes (40% of the 7-year target)
- Premises available to order set to increase by 266% to 128,000 homes
- Premises passed to grow by 219% to 102,000 homes


The website provides progress report numbers at a national level.

Network build is substantially complete in Carrigaline, Midleton, Youghal DA's. Deployment is commencing in the Long Island & Hare Island DA's. Deployment in the Rathmore and Templemartin DA's to follow. Surveying works are complete at Kanturk, Clonakilty, Fermoy and Tallow DA's and on 3 of the islands. Approx. 81,000 premises across Cork County will ultimately benefit from access to high-speed broadband constructed under the National Broadband Contract and it is estimated 67,000 of these premises are in the Cork County areas.

NBI continue to operate a dedicated e-mail service at <u>reps@nbi.ie</u> for Elected Representative queries and news items are published at <u>https://nbi.ie/news/updates/</u>. NBI advise of issuing news items direct to relevant Elected Representatives.

Receiving the grants of €1,000 each under the RISE Community Fund supported by NBI were the Castlelyons Community Centre, with plans to install a mobile booster to extend the benefits of high-speed connectivity in the area; Carrigaline GAA, to enable internet availability throughout the club grounds and use technology to enhance training methods; Carrigaline Mens Sheds, to install a smart TV into their newly built facility and give access to videoconferencing and online resources; and Courtbrack

Community Centre, which will be bolstering its online capabilities to better serve everyone in the community as well as digitise some of its key functions including introducing online banking for the first time.

1.7.2 Broadband Connection Points

. A total of 25 BCP's are now completed across the county and are operational. Remote working is being accommodated at a number of BCP's. Usage of BCP's across the county approximates to 330 users per month.

The Council continues to support the Broadband Connection Points (BCPs) initiative and is co-funding the monthly broadband retail service costs at BCP's. Many of the BCP's availed of Town and Village funding support to purchase furniture and fittings to enhance remote working opportunities.

Grants under the €5 million Government Grant Connected Hubs Call 2022 scheme, totalling in excess of €110K, were received by Laharn, Bere Island and Castlelyons BCP's to add additional remote working infrastructure at the Broadband Connection Points (BCPs).

On 15th April, Minister Humphreys announced a €15M Community Centre Investment Fund to support community groups with the upgrade and development of their Community Centre facilities which may have become aged and dilapidated over time. Further info on the fund can be viewed at https://www.gov.ie/en/service/fec91-community-centres-investment-fund/. Funding will be available under 3 Categories with grants of between €10,000 and €300,000 available.

On 13th October Minister Humphreys announced the recipients of the Category 1 grants for project types up to a value of €25K under the €15M Community Centre Investment Fund to support community groups with the upgrade and development of their Community Centre facilities which may have become aged and dilapidated over time. These grants will allow communities to undertake upgrade works on a fully funded basis. There was extensive interest in these grants and a total pf €12.5M is now committed to these projects nationwide. Across Cork City and County community groups will benefit to amounts of €1.35M for upgrade of their community centres. Community Centres across the county hosting BCP sites will benefit to amounts of €120K.

1.7.3 WiFi4EU Project

Under the WiFi4EU initiative, the European Commission wishes to promote free Wi-Fi connectivity for citizens and visitors in public spaces such as parks, squares, public building, libraries, health centres, and museums across Europe through the installation of state-of-the-art Wi-Fi equipment in the centres of community life.

County Council secured 4 vouchers under the WiFi4EU award procedures and each of these vouchers supports EU funded infrastructural investment. There is an additional commitment from the Irish Government to match fund the EU investment. Accordingly, the combined EU and Irish Government grant associated with the WiFi4EU scheme is up to a maximum of €120,000.

Cork County Council appointed Paradyn to undertake installation of access points across the county. Installation works are progressing, and access point installations are complete in Cobh, Midleton, Camden, Youghal, Dunmanway, Carrigaline and Kanturk. Draw down of funding associated with completed works has commenced and remaining installations are due to be complete in first quarter of 2023.

1.8 Fire & Building Control

1.8.1 Long Service Awards

34 current and former Fire Services Personnel from Cork County Fire Service were honoured for their years' service at a ceremony in the Knightsbrook Hotel, Trim, Co Meath on the 17th November. The ceremony was organised by the National Directorate for Fire and Emergency Management and was the first long service awards ceremony held

since the onset of the pandemic, it was attended by over 270 fire service personnel. The 34 Cork County Personnel being honoured have a combined service record of over 1,000 years and it was great to see them getting recognition for their long service.

1.8.2 Fire Safety Week 2022

This year National Fire Safety Week 2022 ran from 17th October -23^{rd} October 2022 and was welcomed by all 20 Fire Stations across the county as it was the first year since 2019 that we were able to be out in towns and villages with fire safety information stands promoting the fire safety message. This year the main focus of the week was fire safety in the home, encouraging all homes to have working smoke alarms and to have an escape plan if the alarm goes off.

1.8.3 Annual Primary Schools Drawing and Colouring Competition

During the month of November, once again we ran our Primary Schools Colouring and Drawing Competition. It once again proved a very popular competition, with a first prize for each class of a €50 Smyths Toys voucher and fire safety activity packs for the winners' class and two runners up prizes for each class of €25 Smyths Toys Vouchers. Prize winners have been picked and local fire brigades will be delivering the prizes in the run up to Christmas. See below a selection of prizewinning entries receive





1.8.4 Community Smoke Alarm Scheme for Elderly Vulnerable /Residents

Cork County Fire Department, in conjunction with the National Directorate for Fire and Emergency Management (NDFEM), provides community groups with 10-year battery operated smoke alarms for distribution and installation within elderly and vulnerable resident's dwellings.

Interested community groups can contact the Fire Service, following assessment of applications a member of the fire service will then be in contact with the group to arrange delivery of smoke alarms.

1.8.5 Building Regulations (Part M Amendment) Regulations 2022

Revised Building Regulations (Part M Amendment) 2022, (SI No 608 of 2022) were signed on 29 November by the Minister of State with responsibility for Local Government. These revised Regulations make provision for a changing places toilet in certain buildings. The corresponding Technical Guidance Document M- Access and Use has also been updated, this document outlines how compliance with the updated requirements can be achieved.

Changing places toilets offer larger supported sanitary facilities that address the needs of people for whom current accessible sanitary facilities are inadequate. The key objectives of the amendments are as follows:

- To increase the provision of changing places toilets in certain new buildings, subject to their size and use,
- To ensure adequate standards of accessibility and usability in changing places toilets, To improve the accessibility and usability of existing building stock by making provision for a changing places toilet, where there is a significant extension or material change of use, subject to the building size and use,
- To support and complement the aims of the Equality Act 2004, the Disability Act 2005, and the UN Convention on the Rights of Persons with Disabilities.
- To further the achievement of UN Sustainable Development Goals by reducing inequality and promoting an inclusive society.
- To support and underpin the philosophy of Universal Design. The new Regulation will enhance the needs of an important segment of our society by the regulatory provision of this sanitary facility in certain buildings and spaces and will greatly improve community participation and social inclusion.

A test of Pfizer Ringaskiddy's External Emergency Plan took place at the Rochestown Park Hotel on 3rd November 2022, in line with the requirements of the 2015 COMAH Regulations. The exercise tested a major accident scenario on-site by conducting a tabletop walk through of the External Emergency Plan. The event was coordinated by the Inter-Agency Emergency Management Office and was attended by 28 people from the Principal Response Agencies, including Cork County Fire Service, and Pfizer Ringaskiddy. Cork County Council were further represented by staff from the Environment & Corporate Affairs Directorates.




A test of the Kinsale Harbour Oil / HNS Spill Contingency Plan took place in the Council Chambers and Crisis Management Team Room in County Hall on 28th November 2022. The exercise simulated a Tier 2 type oil spill incident, where a cargo ship ran aground in Kinsale harbour with significant quantities of heavy fuel oil & other products onboard. The exercise was led by the County Pollution Officer on behalf of the County Engineer and was well attended by internal and external stakeholders. The Oil Spill Management Team was supported by an Information Management Team made up of members of the Fire Service on the day.



In response to weather alerts issued by Met Eireann, Cork County Council's Severe Weather Assessment Team (SWAT), chaired by the Director of Services Roads and Transportation, convened on five occasions via MS Teams in Q4 of 2022 for the weather events listed below. The National Emergency Coordination Group (NECG) convened on a daily basis between 11th Dec & 14th Dec 2022 to monitor and advise on the national Orange weather alerts issued by Met Eireann.



Covid-19 update:

The HSE had previously advised that sampling at nursing homes could recommence in Q2/Q3, subject to the incidence rate of Covid-19 at the time, as well as the agreement by management at individual nursing homes. Given the continued risk of Covid-19, as well resource constraints within the laboratory, sampling at nursing homes remained suspended in Q3, but will be reviewed for Q4. In Q3 2022 continued priority was given to schools and creches and to re-testing supplies which had issues, with many coming back into compliance. Q3 also the saw reinstatement of sampling at private supply hotels/ B&Bs and Sports clubs.

Sampling of Group Water Schemes has not been affected by Covid-19 restrictions with outdoor monitoring points accessible at all supplies.

2.2.3 Bathing Water Compliance Programme 2021

Note: Bathing Season monitoring extends from mid-May to mid-September. In addition to bathing water sampling and testing outlined below, the Water Quality Laboratory also undertakes environmental education activities as required by the Blue Flag rules. This year, on-the-beach activities were scheduled for May and June, laboratory staff assisted by a number of NGOs plans to engage with schools. Beach activities were held on a number of beaches with students learning about beach ecology and the importance of keeping our beaches clean along with water safety instruction from Cork Co. Council's Water Safety Development Officer.

Below table outlines the completed bathing water monitoring programme for 2022, with the bathing water monitoring results for 2021 re-stated in section 2.1.3.1. These tables are the similar to those submitted in the Q3 Divisional Committee Report. Figure 1: IW Work Programme-Inspections




Figure 2: IW Work Programme – Samples





2.6 Energy Management

2.6.1 SEAI

Public bodies are required under Statuary Instrument 426 of the European Union Energy Efficiency Regulations (2014) as amended to report their energy performance annually. The system by which public bodies report their energy consumption is through the Monitoring and Reporting (M&R) system, managed by the Sustainable Energy Authority of Ireland (SEAI).

Under the National Energy Efficiency Action Plan (NEEAP), Cork County Council had an energy efficiency improvement target of 51% on 2009 energy efficiency figures by 2030.

2.6.2 Energy Efficiency Status 2030 (preliminary)




Figure 1 Cork County Council's energy efficiency performance glide path to 2030 from SEAI M&R

At the end of 2021, Cork County Council's energy efficiency was 25.3% better than baseline. The NEEAP target glide path presented in the current SEAI monitoring and reporting scorecard is shown in Figure 1.

The figures presented below were published by the SEAI in their Annual Report 2020 on Public Sector Energy Efficiency Performance. The major findings are as follows:

- 2.8% worse than 2020
- 25.3% better than baseline (2009)
- 49.4% improvement required by 2030

Cork County Council's 2021 scorecard is expected to be published by SEAI in October 2022.

2.6.5 ISO 50001

Cork County Councils Energy Management System (EnMS) is accredited to the ISO 50001 standard. Cork County Council is therefore compliant with SI 426, which is the statutory instrument that requires all large organisations to either have completed an organisational energy audit or have implemented an approved EnMS. An ISO 50001 recertification audit was successfully completed on the 31st of March 2022.

2.6.6 Significant Energy Users (SEU)

ISO 50001 is an organisational energy management system. A requirement of the ISO 50001 accreditation is that Cork County Council continuously monitors and reports on its SEU's. Cork County Council has four nr. Significant Energy Users (SEU). Cumulatively they account for more than 80% of all energy consumption. The 2022 percentage breakdown is provided below:

- Public Lighting (33%)
- Fleet (37%)
- County Hall campus (5%)
- Leisure Centres (6%)
- Fermoy
- Mallow
- Dunmanway

2.6.7 Energy Efficiency Status

The Energy & Climate Change Section monitor the energy consumption of each SEU monthly using Energy Performance Indicators (EnPI). The EnPI for each Significant Energy User is described as follows:

• County Hall has two EnPIs

- > A formula called CUSUM predicts what energy should have been used based on past performance and is adjusted for weather conditions.
- Fleet
 - Is based on the average monthly litres/100km over the past 12 months.
- The Swimming Pools
 - A formula called CUSUM predicts what energy should have been used based on past performance and is adjusted for weather conditions.
 - kWh/m²/year
- Public lighting is calculated as the average wattage per lamp in the County. This energy performance indicator (EnPI) is reviewed annually.

The E&CC Section are currently reviewing the appropriateness of these EnPIs as part of CCC ISO 50001 compliance. New or additional EnPIs may be agreed with the relevant SEUs as part of this review process where required. Monthly EnPIs for 2021/2022 are presented in Figure 2 hereunder:
