Notice is hereby given that County Rates have been duly made on the property rateable thereto in the above-named County Health Districts of North Cork, South Cork, and West Cork. The annual rates on valuation (formerly rates in the pound) for the ordinary expenditure of the County Health Districts for the service of the financial year ending on the 31st day of December 2023 are respectively:

The rate books are now in my custody and may be inspected by any person affected thereby at the offices of the Cork County Council, Rates Department, Floor 6, County Hall, Cork, between the hours of 10 a.m. and 4 p.m., exclusive of Saturdays, Sundays and Bank /Public Holidays, by appointment. The said rates will be payable from and after the publication of this notice.

Under Section 7(1) of the Local Government (Financial Provisions) Act, 1978, any person who is aggrieved at the failure of a rating authority to make him an allowance under that Act or who believes that he is entitled to a different allowance to that made to him may, within 2 months of the date of the making of the rate, request the rating authority in writing to grant the appropriate allowance. In case the request is not complied with within 28 days the person may, within 4 months of the date of the making of the rate, apply to the District Court to have the appropriate allowance made.

The above rates were made on 21<sup>st</sup> February 2023. Any request in respect of them under Section 7(1) of the Local Government (Financial Provisions) Act, 1978, must therefore be made to Cork County Council not later than 20<sup>th</sup> April 2023. Any application to the District Court under the same provision must be made not later than 20<sup>th</sup> June 2023.

Faoi Alt 7(1) den Acht Rialtais Áitiúil (Forálacha Airgeadais), 1978, aon duine arb éagóir leis mainneachtain údarás rátúcháin liúntas a thabhairt dó faoin Acht sin nó a chreideann go bhfuil sé i dteideal liúntais eile a fháil, féadfaidh an méid a thabharfar dó, laistigh de 2 mhí ó dháta déanta an ráta, a iarraidh i scríbhinn ar an údarás rátúcháin an liúntas iomchuí a dheonú. I gcás nach gcomhlíontar an t-iarratas laistigh de 28 lá féadfaidh an duine iarratas a dhéanamh chuig an gCúirt Dúiche, laistigh de 4 mhí ó dháta déanta an ráta, chun an liúntas cuí a fháil.
