The restoration will involve the removal of the existing concrete structures, and construction of new public realm amenity areas enhancing the viewing platforms with heritage sensitive materials, lighting, street furniture, and associated site works. As per Article 81 of the Planning and Development Regulations 2001 (as amended) an Environmental Impact Assessment (EIA) screening determination has been made and a determination has been made that an **EIA Report is not required.** In accordance with Article 120 (3), as amended by S.I. No. 296 of 2018, a person may, within 4 weeks from the date of this notice (on or before **Friday**,**7**th **April 2023**), apply to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.
