Cllr. Audrey Buckley

- 1. *"Can we repaint and look at the lining on the road at Camden bus turnaround please. With so many cars parking there the bus has difficulty turning."*
- 2. *"Can I ask that Fennell's Bay Road be looked at please for resurfacing."*

Cllr Seamus McGrath

- 1. *"To request that resurfacing work is carried out in the front of the Owenabue Carpark."*
- 2. *"To seek an update on my previous request for a Pedestrian Crossing on the Upper Kilmoney Road near the two bus stops on the western end of the road (Upper Clevedon and Forest Park)."*

3. *"To request that nameplates be erected on Mill Road and Pottery Road in Carrigaline. Also, that information signs be erected to explain the historical significance of both names."*

Cllr Marcia D'Alton

1. *"That the extreme littering exposed by the contract for Site Clearance on the Carrigaline to Ringaskiddy and Glenbrook Pedestrian and Cycleway, Phase 1 Glenbrook to Raffeen would be thoroughly cleaned as a matter of urgency. The lack of attention to this legacy of unsustainability is a sad irony for a transportation route advanced under the climate change banner."*
2. *"That as part of the water main replacement project on the R613, traffic calming around Coolmore Cross would be introduced as part of the reinstated layout. Recent experiences from the closure of the R613 are a clear illustration of the volume of traffic using this road every day."*
3. *"That Cork County Council would designate a Park and Ride facility in the Ballyhemiken Quarry and would liaise with the manufacturing facilities in Ringaskiddy and with the IDA to organise a regular small bus operating on a loop from here to each of the factories in the Ringaskiddy area with a view to relieving traffic and giving a practical alternative to the drivers of single-occupancy cars."*

Cllr Michael Paul Murtagh

1. *"That provision made in the recent Coastguard Station part 8 planning, to widen the footpath on the R612 at the RCYC, is implemented in tandem with the development of the Coastguard station site. This is extremely necessary to address ongoing safety issues particularly for school-going children, pedestrians and cyclists at the entrance to Crosshaven on a recognised route to primary and secondary schools and linking the Crosshaven-Carrigaline active travel route to Crosshaven village amenities and well known tourist attractions. There is national funding for safe active travel routes available through the department of transport and Minister Eamonn Ryan has specifically called for available funding to be spent. I would also ask that this motion is brought to the next Roads & Transportation in order to apply for the necessary funding as a matter of urgency."*
2. *"That members are given a report listing Hydrant locations, condition, flows and pressures in the Minane and Tracton area following work done by Irish water in the locality and reports of poor flow."*
3. *That the MD provide and erect "Respect your home, please do not litter dog foul" etc slogan signage at key junctures from "The Pines" to "Hawthorne Drive" through "Weston" and on to "Glenwood" estates."*

Cllr Jack White

1. *"That Cllrs be informed by email of any adverts for proposed road closures in our Municipal District."*
2. *"That our MD request an update on turnaround times for housing offers in our area."*

Cllr Ben Dalton O'Sullivan

1. *"That this council would write to the relevant body to ask them to install broadband connections to the Earls Well development in Waterfall."*
2. *"That this council would write to Irish Water asking them to install a backup power generator to the water pumping station in Shanagraigue."*
3. *"Revisiting my motion from last year, I'm asking if the council would arrange for further clearing and maintenance works at Barnaheley Cemetery in Ringaskiddy."*
