MUNICIPAL DISTRICT OF BANDON/KINSALE:

Consideration of Part 8 Chief Executive's report in respect of works to extend an existing walkway in the townlands of Ballylangley and Curranure, Bandon. The existing amenity walkway, known as the Clare O'Leary Walk, currently extends to the east of Bandon Town, adjacent to the N71. The proposed works include extending the existing amenity walkway by approximately 900 metres to the footpath on the eastern boundary of Bandon Town on the N71, creating a 3m wide active travel route from Bandon Town Centre.

MUNICIPAL DISTRICT OF MACROOM:

Tuath Housing in partnership with Cork County Council propose a Social Housing scheme at Masseytown, Macroom, Co Cork.

The construction of a new housing development consisting of 18 No. Residential Units plus 1 no. Acquired Brain Injury Ireland (ABII) 5-bed communal dwelling comprising:

- o 4 No. 1 bed, 2-person single storey units.
- o 4 No. 2 bed, 4-person single storey units.
- o 6 No. 2 bed, 4-person two storey units.
- o 4 No. 1 bed, 2-person own door apartments
- o 1 no. ABII, 5-bed communal dwelling
- 2 No. paved homezone areas, a total of 41 No. car parking spaces including visitor parking and designated parking.
- Ducting to 1 No. future EV charging point for each residential unit, and 4 No. visitor spaces.
- Soft landscaping including green spaces, planting, and trees.
- Connection to public utilities
- All associated site and ancillary works

The Mallow Relief Road is consistent with all relative objectives of national policy and its development is critical for the future development of Mallow Town and its environs.
