STREETSCAPE PAINTING SCHEME 2023

Cork County Council is pleased to announce the Streetscape Painting Scheme for the following areas for 2023:

- Macroom Cork Street, Railway View, Main Street, Castle Street, New Street
- Millstreet Minor Row, The Square, Main Street, West End
- Cill na Martra Village
- Coachford Village
- Cloughduv Village
- Inchigeelagh Village
- 1. Eligible works are items that will enhance the exterior, street facing element of the building.
- 2. Tenants or owners of buildings can avail of a grant of up to 50% of the cost of works, up to a maximum of €800.00 for works carried out by a contractor.
- 3. A contribution to a maximum of 100% or €800.00, whichever is the lesser, may be paid towards the cost of materials where it is proposed the tenant/owner will undertake the works themselves. If availing of grant for materials only, the attached disclaimer form must be completed and returned. One quotation only for materials will suffice.

Application Process:

- Make a formal application in writing to the applicable Municipal District Office of Cork County Council providing the following information:
 - a) Photograph of the building's present condition.
 - b) Map indicating the location of the property.
 - c) 2 quotations from registered contractors for the proposed painting works or 1 quote for materials.
 - d) Where a scaffold/hoist is required, a permit must be sought in advance from Cork County Council at a cost of €125 per month.
- Where works are undertaken without the prior written approval of CCC, a grant <u>will</u> <u>not be awarded</u> to the applicant. On completion of works, the Council are to be notified so that an inspection can be arranged. Works must be completed within 4 months of the date of approval.
- Please note if works are not complete by 30th November 2023 the grant will lapse.
- If the scheme is oversubscribed the applicants eligible to continue in the application process will be selected by what is considered by the Council to be the highest need.
- Where a contractor is appointed it shall be the responsibility of the successful applicant(s) to ensure that all necessary consents are obtained and all relevant legislation and codes of practice, in particular those related to Health & Safety which apply to such work and / or approved schemes, are complied with.
- The Contractor is to submit relevant invoices to the applicant who in turn submits the invoice and receipts to the Council for inspection, approval and payment of funds.
- If applying for cost of materials only, the applicant must complete the attached disclaimer from and submit with the application form.
- Please note a valid application does not guarantee funding.
- Local Authority Charges due by applicants must be paid up to date.
- Photographs of approved properties may be used in future promotions of the Scheme.

Please note that the Contract is between the applicant and the painting contractor.
