2. SICAP

SICAP End of Year Reviews 2022 for lots 18.5, 18.6 and 18.7

Andrew Lewis confirmed that the SICAP Sub Group had held meetings with each of the Local Development Compnaies to discuss the SICAP EYR 2022 performance and the Annual Plans for 2023. He confirmed that KPIs 1 and 2 had been achieved across the 3 lots. He noted that the large numbers of Ukrainians bolstered the numbers considerably. He said that the Ukrainian crisis forced West Cork Development Partnership CLG and Comhar na nOileán to pivot significantly in order to deliver supports successfully. He said that this required a huge effort and represented a massive achievement. He also commended the successful delivery of the SICAP programme despite this situation.

Andrew Lewis highlighted the successful integration of Ukrainians on Sherkin Island. He noted that that links made by West Cork Development Partnership CLG and Comhar na nOileán with the Department of Social Protection, the HSE, the CETB and various family resource centres through the COVID-19 Community Response Forum were vital in successfully providing support to Ukrainians. It was important for this to continue.

Andrew Lewis said that the SICAP Subgroup recommended the approval of the End of Year Reviews 2022 by the LCDC.

Andrew Lewis thanked John Lyne and Enda McWeeney for their work on the SICAP Subgroup and offered particular thanks to parting LCDC member John Lyne who is retiring. The Chair Cllr. John O'Sullivan agreed. He thanked John Lyne for his contribution to the LCDC and SICAP Subgroup and wished him well for the future on behalf of the LCDC members.

John Lyne commended West Cork Development Partnership CLG and Comhar na nOileán on their great work regarding the Ukrainian crisis. He highlighted the success of the SICAP Boxing Clever initiative, which had led to job creation and Recruit Refugees Ireland. He commented that the COVID-19 Community Response Forum formed the base for these successes.
