Welcome and Introduction

It was noted that a quorum was in place and the meeting commenced.

1. Confirmation of Minutes of the Previous LCDC Meeting of Monday 17th April 2023

2. SICAP

Avondhu Blackwater Partnership CLG 2022 Case Study by Mary Gubbins

Context

Social Inclusion and Communication Activation Programme 2018 - 2023

Introduction:

- Our 2022 Case Study was a result of work with Syrian women living in the Mallow area
- This group was supported under Goal 2 'Promoting Personal Development and Wellbeing
- This support identified the needs of Syrian Women living in the Mallow area and led to a suitable programme of activities being devised.

Background:

- In 2015 the Irish Refugee Protection Programme was established as a direct response to the humanitarian crisis that developed in Southern Europe
- From 2000-2019, over 3,000 refugees from almost 30 nationalities were resettled to Ireland
- Under the UNHCR led refugee resettlement programme, Ireland signed up to bring Syrian refugees from the Lebanon and Jordan
- In this time period 256 Syrian and Iraqi refugees were resettled across Cork & Kerry with 90 individuals relocating to the Mallow area.
- Avondhu Blackwater Partnership were involved with the key agencies from the initial stages of this relocation programme
- Through our SICAP & TUS Programmes we engaged with the Cork Kerry Resettlement Project outlining support available
- This led to the engagement of the men through SICAP, initially availing of employment and self employment related supports
- With the assistance of the project this resulted in 6 individuals referring onto TUS, extensive self employment work with 3 people, with one business set
- TUS participants have availed of SICAP funded training



Emerging Needs:

- Having had initial engagement and success with the Syrian men, the needs of the women began to emerge
- Existing engagement and supports for the women included through leisure, befriending, health other initiatives
- In consultation with the key agencies in Mallow the need to provide a non-accredited programme for these women emerged

The Initiative:

- This non accredited programme centered around empowerment, confidence building and goal setting
- The target group was Syrian women living in the Mallow area
- The aim was to provide engagement opportunities for women experiencing multiple barrier to progression
- The facilitator needed to be an Arabic speaker due to both language and cultural issues
- The training was about creating a safe space where women could meet speak openly about issues, their daily struggles and set goals for the future

Course Description:

- Procurement guidelines were followed and a suitable Arabic speaking facilitator with a wealth of experience and knowledge was secured
- An eight week programme was devised, where participants attended 3 hour sessions on a weekly basis
- The training discussed topics including reproductive health, violence against women, poverty, employment, sexuality, religion, war, experience of being a refugee and personal development
- The programme also looked at goal setting and outlining pathways to employment and education / training.

Outcomes:

- 17 Syrian women attended ranging in age from early 20s to late 50s. 11 in regular attendance
- Adhering to the class start and finish times was an issue due to medical appointments, care and personal issues
- Valuable opportunities for learning, networking and future planning were created
- The Arabic speaking facilitator, her previous experience of delivering similar programme and her understanding of traditions and culture were essential to the success of the programme

Challenges & Barriers:

- The need to deliver the course with an Arabic speaking facilitator was a challenge both for language development and also long term integration
- In some cases small children and babies were brought to the course, which may have affected its delivery
- A disclosure of domestic violence was made by a class participant, which led to her isolation within the group



• The content of the poster may have impacted participation rates

Conclusion:

- The Syrian Women are keen to capitalize from the learning achieved from this initiative
- They are keen to seek out opportunities for integration through participation in future events, activities and training
- SICAP will continue to work with individuals as a result of this initiative who
 expressed an interest in progressing into employment (2), training (2) and self
 employment (1)
- Some of the Syrian women participated in a similar initiative completed with women in Direct Provision later in the year.

Cllr. Gearoid murphy thanked Mary and Avondhu Blackwater Paternership for the very informative presentation and the important work carried out to make these individuals feel welcomed and included in the community from unimaginable partnerships that are being formed.

Cllr. Bernard Moynihan & Sean Hegarty concurred that exceptional work was carried out.

3. Community Support Fund 2023 & Women's Shed 2023 - Allocations

Community Support Fund 2023

The Department of Rural and Community Development ("the Department") funds the Community Support Fund (CSF) which provides funding to support community groups across Ireland

The **Community Support Fund** will support groups, particularly in disadvantaged areas

- With their non-pay running costs for example energy costs (electricity costs, refuse charges, heating charges) or other non-pay operating costs for example rental/lease costs, insurance bills.
- Groups will also be able to use the funding to carry out necessary repairs and improvements to their facilities, purchase equipment etc.

This funding will help communities, community groups and committees, allowing them to continue to provide valuable services to the people in their area, and in the process strengthen the bonds that tie communities together.

Cork County launched this scheme on Friday, 3rd February with a closing date of 3pm on Monday, 13th March, 2023

The €362,678 fund comprises of

 Current funding (Non-Pay) for use towards running/operating costs, eg. Utility costs, insurance, audit/accountancy fees, etc.

(Costs related to the period from 1st April 2022 – 31st March 2023 only eligible under this category)

 Capital funding for use towards carrying out necessary repairs and improvements to facilities, purchase of equipment, etc.

(For drawdown, capital costs must cover period from LCDC grant approval date to 31st August 2023)

There are three types of grants available under this Programme:

- Small scale capital grant up to a maximum of €1,000 or less
- Capital grant in excess of €1,000
- Grants associated with running/operating costs



The majority of applications were able to be funded either via the capital or operating costs. Those that were unsuccessful were either too large to be funded, the timeline being unachievable or the project was deemed ineligible under the scheme guidelines.

In addition to above allocation, the Department permitted us to add on outstanding balances from other reiterations of the community enhancement schemes over the past few years, this increased the county allocation to €366,166.73 and included the following balances:
