Target Group; This case study focuses on the Ukrainian Refugees who have been resettled into the Duhallow area since March of 2022.

#### Historical Context & External Context

Historical Context; While the theme of equality permeates through each of IRD
Duhallow's various functions, the specific remit of social inclusion is central to IRD
Duhallow's Equality Working Group. The function of the Equality Working Group is
to champion and prioritise the needs of underrepresented groups in the Duhallow
area through the promotion of strategic and supportive actions aimed at mitigating
the impacts of social exclusion and disadvantage.



• External Context; Minister of State for Rural and Community Development, Joe O Brien, tasked Local Development Companies to co-ordinate the voluntary activities focused on supporting new arrivals from Ukraine in our respective regions.

## Strategy & Supports

- Emergency Response; Simple & Effective Strategy Put in place. Focus was on responding to the immediate needs first with practical supports & develop a cohesive plan once they were settled.
- While awaiting the 1<sup>st</sup> arrivals we worked closely with the local schools, childcare services, & GP services to est capacity.
- Easter Weekend; 1<sup>st</sup> arrivals in to Banteer followed by arrivals to both the Green Glens and the Wallis Arms in Millstreet. Since then we have 2 new centres in Kanturk, 1 in Newmarket, Dromcummer and numerous dispersed throught the region in host accommodation.
- 3-Pronged Approach;
  - o Humanitarian supports
  - Activation Supports
  - Social Inclusion Supports

IRD Duhallow redeployed staff to provide such supports
Recruited a part time Ukrainian translator / support worker with HSE funding support to
work alongside IRD Development Officers.

# **Humanitarian Supports**

Donations of clothes, toiletries, personal items, toys, bikes, laptops, phones.
 Purchased large quantities of toiletries due to high turnover of refugees. Worked closely with St Vincent de Paul & Red Cross. Marquee hired to receive, sort and distribute donations. Recruiting & Co-ordinating volunteers from all communities, assisting Ukrainians to become volunteers, organising emergency dentists and doctors' appointments, transport for cancer care appointments, transport to social welfare appointments, organising translation support.

IRD Duhallow (LDC) delivered a suite of educational & socially inclusive supports to alleviate educational disadvantage, increase participation, build resilience, improve wellbeing & mental health & create opportunities to upskill/gain employment.

- Actions: Preparation for Work & Future Career Supports, Holistic Trauma Care Supports, Cultural events.
- Delivered via a mix of blended learning options
- Benefits: Ukrainians were more prepared to enter the workforce, managing change
   & accepting new life, understanding the Irish work culture
- Resilience & Capacity Building, wellbeing and mental health
- improved
- Promoted greater integration in local communities
- Cultural Awareness



#### **Outcomes & Learnings**

- In 2022 over 1000 Ukrainians supported in Duhallow via SICAP Programme
- Transient nature of the refugee situation is a challenge
- Mental health & wellbeing is a concern
- Trauma coming to the fore and motivation wains periodically
- Humanitarian supports to be managed to avoid creating dependency
- Poor Public transport and lack of accommodation a barrier to progression
- Acquiring a level of English is a priority
- The integrated approach of an LDC where already offering the likes of education & training, employment, family supports and emotional supports meant we could respond with supports quickly
- · Greater integration in our communities a priority going forward

The Chair Cllr. Gearóid Murphy said that the support being offered to Ukrainians is heartwarming and encouraging to see. He commended IRD Duhallow CLG for their hard work.

The Chair Cllr. Gearóid Murphy thanked Sharon O'Connell for her update and hard work. He noted that there are many good ideas in the Plan and asked if it will impact on one off housing in communities. Sharon O'Connell confirmed that the LECP is not a spatial plan and it is not intended that it will impact on planning decisions.

Bob Seward asked how towns and villages will be included at a local level under the village renewal plans. Sharon O'Connell said that Implementation Plans will follow approval of the High-Level Goals. These will have a more localised focus. Bob Seward said that the High-Level Goals will provide great opportunities if Implementation Plans are put in place.

James Fogarty noted that the LECP must correspond to all relevant national and regional plans as well as the Cork County Development Plan to ensure that any funding applied for by local groups is secured. He added that he was impressed with the High-Level Goals and the level of engagement with the LECP from local communities.



Sean Hegarty acknowledged the challenges in securing funding for local projects and stressed that the help and guidance of Local Development Companies and the Council is vital. James Fogarty agreed. He said that the funding system will not be changing and that local communities and Local Development Companies will continue to be vital. Sharon O'Connell commented that the LECP is intended to be a bottom up plan and that the LCDCs will be essential to its success.

Cllr. Gerard Murphy said that it will be important to local communities that localised Implementation Plans containing clear relevant advice are available to them. He noted that it is vital to get these groups involved with the consultation process. He said that these groups and the Local Development Companies' expertise is invaluable. The Chair Cllr. Gearóid Murphy agreed.

The Local Economic and Community Plan Socio-Economic Statement and High-Level Goals were proposed by Cllr. Pat Hayes and seconded by Cllr. Gerard Murphy.
