Welcome and Introduction.

Note - Cllr. Seamus McGrath (Vice Chairman) chaired this month's South Cork Local Community Development Committee meeting. It was noted that a quorum was in place and the meeting commenced.

2. SICAP: SECAD Partnership CLG 2022 Case Study by Toni McCaul

SECAD Ukraine Supports Documentary

Context

On 24 February 2022, Russia launched a full-scale assault on Ukraine. The war has since killed thousands, displaced millions and destroyed entire cities. Some 50,000 Ukrainians have come to Ireland in the months since we announced visa-free travel and offered housing and support for the displaced in line with the European Union's temporary protection directive.

The number hosted in Ireland is just a fraction of the more than seven million Ukrainian refugees that the United Nations has recorded across Europe since the start of the war in February. But it has proved to be a logistical challenge for a country with a population of only about five million, which is already experiencing a housing crisis and a shortage of doctors and teachers.

SECAD has received a higher-than-average cohort of refugees from the Ukraine. As of October 2022, at the time of filming this video case study, the largest numbers by far within the Lot are residing in private accommodation centres, of which there are as of October 2022 6 in the SECAD area:

- Youghal Accommodation Centre (Redbarn) 565+
- Old Imperial Hotel Youghal—43
- Trabolgan holiday village, Whitegate 293
- Warrensgrove centre Lissarda 63
- Cobh Mercy Convent 43
- Inchigeela 25

This totals those currently living in such centres around 1,032 with more accommodation centres coming onstream all the time.



Furthermore, there are many more Ukrianians living in family homes/pledged accommodation in the area. From discussion with other agencies, it is estimated that the figures below loosely represent those residing with host families in the areas of Midleton, Youghal, Cobh, Carrigaline, Ballincollig, and Macroom to be in the region of 300-400. This is clearly conservative and falls short of including numbers in the peri-urban conurbations, with the overall Ukraine population in our area now indicating in the region of 1,400 to 1,500.

SECAD during the presentation addressed the areas of Rational & Needs Analysis including provision of Information sessions at Accommodation Centres, English Language Supports, Provision of structural & governance support to emerging LCGs, Skills training and employment supports.

Toni McCaul noted that a lot development has happened since this project has been established with a great sense of teamwork and community has evolved over the past 12 months.

Cllr. Seamus McGrath thanked Toni & her team, and SECAD for their excellent work and for their powerful & attentive presentation, and opened the floor for questions & comments.

Liam McCarthy commented that he was impressed by the presentation and was grateful for the work that was being carried out and wishes that there will be no negative salient taking away from the work that was done.

The Chief Officer thanked Toni McCaul for her presentation and mentioned that SICAP along with the Local Development Companies have supported the Ukraine crisis with a lot of work being carried out at on the ground and acknowledged that any additional funding that is available would be greatly forthcoming.

Cllr. Seamus McGrath ended the conversation with thanking all those involved for their work and the presentation & would hope that the work that is being carried out would reach a greater audience.

Marica Dalton' query to say that that the information in High Level Goal no. 4 is just a snapshot of the information that was provided to them and that the challenge is in the presentation of data. She confirmed that she would undergo a comparative piece on the date before going out to public consultation.

Ryan Howard thanked Sharon for her presentation, and asked will the framework show the structure element when it comes to design of the plan i.e link to the LCDC's and other agencies. He also queried if there is going to be clear measurable KPI's or measurable impacts on the communities included in the framework.

Sharon O'Connell responded to Ryan by saying that the first phase of the LECP is the framework and the second phase is the implementation plan which will address these goals along with a smart action plan that will include regular reporting to the Department

Mary O'Leary had a query regarding the first few High Level Goals of the LECP plan on how they are going to be achieved, such as will communities be assisted in a practical way and how can communities apply for such support.

Sharon responded that in the first instance we need to show that a framework is in place and that all future funding will have to link back into the LECP..
