The Chair Cllr. Gearóid Murphy thanked Eileen O'Keeffe for her presentation. He said that Kildorrery is noted as a model village in terms of community development and that it is welcome to get an insight into how this came about. He commented that he was struck by the problem of succession for community groups and added that this a big problem across the county and has been frequently raised by the LCDC.

Bob Seward thanked Eileen O'Keeffe for her presentation and said that it shows what can be achieved when communities and volunteers are supported. He commended the SICAP and LEADER programmes in this regard.

Cllr. Gerard Murphy acknowledged that the highlighted problem of succession is a widespread one. He noted that the amount of paperwork increasingly required of community development groups can be off-putting for prospective new members. The Chair Cllr. Gearóid Murphy and Cllr. Pat Hayes agreed.

The Chair Cllr. Gearóid Murphy commended the good work being done by Ballyhoura Development CLG and all local development companies in supporting community development groups with this paperwork.

Cllr. Gerard Murphy noted the value of Council grants which are less complicated to apply for and draw down than EU funding. He said that these are a good starting point for community development groups. The Chair Cllr. Gearóid Murphy agreed.

3. LEADER Programme 2023 – 2027: Local Development Strategy

The Chairman asked if there were any conflicts of interest to be declared at start of this item. No conflicts of interest were declared.

The Chief Officer stated that the LCDC in partnership with Avondhu Blackwater Partnership CLG is currently involved in a bidding process for LAG status under the next LEADER Programme 2023-2027. She noted that a Local Development Strategy must be submitted to the Department by 14th July and that Consultants have been employed to assist in the drafting.

The Chief Officer noted that as both the SICAP and LEADER Programmes are ending this year, the LCDC boundaries will change to align with the Council's divisional boundaries from January 2024.

The Chairman welcomed Valerie Murphy CEO of Avondhu Blackwater Partnership CLG and representatives of the Consultants into the meeting.

A presentation on the North Cork Local Development Strategy 2023-2027. They covered the background to LEADER, Principles of LEADER Approach, the structure of the strategy under the various headings as outlined in the LEADER Strategy Guidance Document, the LEADER Themes and how they were being linked to the public consultations and the Financial Plan.

The Chief Officer said that the budget for Cork under the LEADER Programme 2023-2027 is €16.8m.

Some queries were raised and responded to with the Local Development Strategy being approved by the North Cork LCDC, proposed by Bob Seward and seconded by Cllr. Gerard Murphy.

The Chief Officer noted that confidentiality is vital at this stage of the process as we are in a competitive bid process.
