Welcome and Introduction.

It was noted that a quorum was in place and the meeting commenced.

1. Confirmation of Minutes of the Previous LCDC Meeting of 25th May 2023.

2. LEADER Programme 2023 - 2027: Local Development Strategy

The Chair asked if there were any conflicts of interest to be declared at start of this item. No conflicts of interest were declared.

The Chief Officer stated that the LCDC in partnership with Avondhu Blackwater Partnership CLG & SECAD Partnership CLG is currently involved in a bidding process for LAG status under the next LEADER Programme 2023-2027. She noted that a Local Development Strategy must be submitted to the Department by 14th July and that have been employed to assist in the drafting.

The Chief Officer noted that as both the SICAP and LEADER Programmes are ending this year, the LCDC boundaries will change to align with the Council's divisional boundaries from January 2024.

The Chair welcomed Valerie Murphy CEO of Avondhu Blackwater Partnership CLG and Ryan Howard CEO of SECAD Partnership CLG representatives of the Consultants into the meeting.

A presentation on the South Cork Local Development Strategy 2023-2027. They covered the background to LEADER, Principles of LEADER Approach, the structure of the strategy under the various headings as outlined in the LEADER Strategy Guidance Document, the LEADER Themes and how they were being linked to the public consultations and the Financial Plan.

The Chief Officer said that the budget for Cork under the LEADER Programme 2023-2027 is €16.8m. The budget for South Cork LCDC area was outlined to the meeting, however, this may be subject to change by the Department.

Some queries were raised and responded to with the Local Development Strategy being approved by the South Cork LCDC, proposed by Cllr. Michael Hegarty and seconded by Cllr. Seamus McGrath.

The Chief Officer noted that confidentiality is vital at this stage of the process as we are in a competitive bid process.
