Welcome and Introduction.

It was noted that a quorum was in place and the meeting commenced.

1. Confirmation of Minutes of the Previous LCDC Meeting of 27th April 2023.

The Minutes were adopted on the proposal of Liam McCarthy and seconded by Tom Howard.

2. Community Support Fund 2023 and Women's Shed Fund 2023 - Allocations

The Department of Rural and Community Development ("the Department") funds the Community Support Fund (CSF) which provides funding to support community groups across Ireland

The **Community Support Fund** will support groups, particularly in disadvantaged areas

- With their non-pay running costs for example energy costs (electricity costs, refuse charges, heating charges) or other non-pay operating costs for example rental/lease costs, insurance bills.
- Groups will also be able to use the funding to carry out necessary repairs and improvements to their facilities, purchase equipment etc.

This funding will help communities, community groups and committees, allowing them to continue to provide valuable services to the people in their area, and in the process strengthen the bonds that tie communities together.

Cork County launched this scheme on Friday, 3rd February with a closing date of 3pm on Monday, 13th March, 2023

The €362,678 fund comprises of

 Current funding (Non-Pay) for use towards running/operating costs, eg. Utility costs, insurance, audit/accountancy fees, etc.

(Costs related to the period from 1st April 2022 – 31st March 2023 only eligible under this category)

• Capital funding for use towards carrying out necessary repairs and improvements to facilities, purchase of equipment, etc.

(For drawdown, capital costs must cover period from LCDC grant approval date to 31st August 2023)

There are three types of grants available under this Programme:

- Small scale capital grant up to a maximum of €1,000 or less
- Capital grant in excess of €1,000
- Grants associated with running/operating costs



The majority of applications were able to be funded either via the capital or operating costs. Those that were unsuccessful were either too large to be funded, the timeline being unachievable or the project was deemed ineligible under the scheme guidelines. In addition to above allocation, the Department permitted us to add on outstanding balances from other reiterations of the community enhancement schemes over the past few years, this increased the county allocation to €366,166.73 and included the following balances:

The Chief Officer clarified that this information cannot be made public through an announcement or social media until Minister Humphreys makes an official announcement.

The Chair Michael Hegarty asked if unsuccessful applicants can query the decision. The Chief Officer said that her team would be happy to take any queries.

Ryan Howard said that the Midleton Hub is not a charity. Liam McCarthy noted that they are a social inclusion group. The Chief Officer suggested that SICAP funding would be a more appropriate funding source for this group however, she agreed to relook at this application pending further investigation if additional funding became available, at present all monies have been fully committed.



Cllr. Marcia Dalton commented that the Passage West Youth Choir is an independent group not associated with a school. The Chief Officer confirmed that the team worked with the information they had available to them and that LCDC grant schemes usually do not cover the purchase of uniforms. Ryan Howard asked that the Passage West Youth Choir be considered if monies become available. The Chief Officer confirmed that this will be looked at should the opportunity of additional monies arise.

3. Any Other Business

The Chief Officer noted that as both the SICAP and the LEADER Programme are ending this year, the LCDC boundaries will change to align with the Council's divisional boundaries from January 2024.
