3. LEADER Programme 2023-2027: Local Development Strategy

The Chair asked if there were any conflicts of interest to be declared at start of this item. No conflicts of interest were declared.

The Chief Officer stated that the LCDC in partnership with Avondhu Blackwater Partnership CLG, SECAD Partnership CLG and Comhar na nOileán Teo is currently involved in a bidding process for LAG status under the next LEADER Programme 2023-2027. She noted that a Local Development Strategy must be submitted to the Department by 14th July and that Consultants have been employed to assist in the drafting.

The Chair welcomed Valerie Murphy CEO of Avondhu Blackwater Partnership CLG and representatives of the Consultants into the meeting.

A presentation on the West Cork Local Development Strategy 2023-2027 was given. They covered the background to LEADER, Principles of LEADER Approach, the structure of the strategy under the various headings as outlined in the LEADER Strategy Guidance Document, the LEADER Themes and how they were being linked to the public consultations and the Financial Plan.

The Chief Officer said that the budget for Cork under the LEADER Programme 2023-2027 is €16.8m and gave details of the allocation for the West Cork LCDC area under the strategy however, this may be subject to change by the Department.

Some queries were raised and responded to with the Local Development Strategy being approved by the West Cork LCDC, proposed by Kevin Curran and seconded by Máire Ní Shé.

The Chief Officer noted that confidentiality is vital at this stage of the process as we are in a competitive bid process.
