
Black sheep



Diana, Princess of Wales's black sheep jumper has sold for \$1.14m (€1.07m) at auction. The red jumper which a newly-engaged Diana wore to a polo match in June 1981, was sold by Sotheby's in New York and easily outstripped its \$50,000-\$80,000 (€46,980-€75,160) estimate. The jumper, which shows a black sheep among a row of white ones, was discovered in an attic in March by designer Joanna Osborne. The auctioneers did not disclose the identity of the winning bidder.

Putin-Kim meeting a big cause for concern for South Korea

South Korea has expressed "deep concern and regret" over a meeting between North Korean leader Kim Jong-un and Russian president Vladimir Putin that was apparently focused on expanding military co-operation.

It came as the two isolated, nuclear-armed leaders align over their escalating confrontations with the US.

Washington has warned that the summit on Wednesday between Mr Kim and Mr Putin could lead to a deal to supply ammunition for Moscow's war in Ukraine.

There is widespread concern in Seoul that the North in return would receive advanced weapons technologies from Russia, including those related to military spy satellites, which would increase the threat posed by Mr Kim's mil-

itary nuclear programme. "We express our deep concern and regret that despite repeated warnings from the international community, North Korea and Russia discussed military co-operation issues, including satellite development, during their

South Korea's Foreign Ministry spokesperson.

"Any science and technology co-operation that contributes to nuclear weapons and missile development, including satellite systems that involve ballistic missile technologies, runs against UN Security Council resolutions," he said in a briefing.

Mr Lim also pointed out that Mr Kim's delegation in Russia included several individuals sanctioned by the Security Council over involvement in illicit North Korean weapons development activities, including Korean People's Army marshal Ri Pyong Chol and Jo Chun Yong, a ruling party official who handles munitions policies.

Mr Lim said Moscow should realise there will be "very negative impacts" on its relations with Seoul if it proceeds with military

co-operation with Pyongyang. Seoul's unification minister, Kim Yung-ho, who handles affairs with North Korea, warned that potential arms transfers between Pyongyang and Moscow would only invite stronger responses

from South Korea, the US and Japan, which have been stepping up their trilateral security co-operation to cope with regional threats.

White House National Security Council spokesman John Kirby said North Korea would face consequences if it supplies arms to Russia. "No nation on the planet, nobody, should be helping Mr Putin kill innocent Ukrainians," Mr Kirby said.

If the countries decide to move forward with an arms deal, the US will take measure of the arrangement and "deal with it appropriately", he said.

He said that any deal that would improve North Korea's military capabilities "certainly would be

of significant concern to us" A day after giving intense coverage to the summit, Russian media outlets were silent on Mr Kim as of yesterday afternoon. North during their meeting to visit North Korea at a "convenient time" and that Mr Putin accepted with "pleasure and reaffirmed his will to invariably carry forward' the history of friendship between the nations.

Kremlin spokesman Dmitry Peskov confirmed that Mr Putin had accepted the invitation and said Russian foreign minister Sergei Lavrov is expected to visit North Korea in October.

Mr Putin said after the summit that Mr Kim will visit two more Russian cities on his own, flying to Komsomolsk-on-Amur, where he will visit an aircraft plant, and then go to Vladivostok to view Russia's Pacific Fleet.

Meanwhile, Russia's Ministry has declared two US dip-"persona non grata" and ordered them to leave the country within seven days as they were alegedly involved in "illegal activity"

Brazilian rioter handed 17-year prison sentence

Brazil's Supreme Court has handed a 17-year prison sentence to a supporter of former president Jair Bolsonaro who stormed top government offices on January 8 in an alleged bid to forcefully restore the right-wing leader to office. Aecio Lucio Costa Pereira, 51, is the first of several participants in the uprising to be prosecuted. In January, cameras at the Senate filmed him wearing a shirt calling for a military coup and recording a video of himself praising others who had also broken into the building. Almost 1,500 people were detained on the day of the riots, though most have been released.

French official held in Niger finally released

A French official detained in Niger last week has been released, the French government said. The arrest heightened tensions between France and Niger, where military officers deposed an elected president last month and ordered rench officials to leave. France's Foreign Ministry said in a statement that Stephane Jullien, counsellor for French citizens abroad, was released on Wednesday, five days after he was arrested. It did not provide details about the release, or about the reason for his arrest. The French government had urged his liberation.

Luxury cruise ship is pulled free at high tide

The luxury cruise ship MV Ocean Explorer has been "successfully pulled free off Greenland, three days after running aground with 206 people on board, authorities and the ship's owner said.

The ship was freed by a fisheries research vessel at high tide, said the cruise ship's owner, Copenhagen-based SunStone Ships, and the Arctic Command, which had been co-ordinating the operation.

Biden's son indicted on firearms charges in long-running probe

Hunter Biden has been indicted on federal firearms charges, the latest step in a long-running investigation into the US president's son that puts the case on track toward a possible high-stakes trial as the 2024 election looms.

He is accused of lying about his drug use when he bought a firearm in 2018, a period when he has acknowledged struggling with addiction to crack cocaine, according to the indictment filed in federal court in Delaware by a special counsel overseeing the case.

The indictment comes weeks after the collapse of a plea deal that would have averted a criminal trial and weeks or months of distracting headlines for president Joe Biden.

The court fight may be an extended one. His defence attorney argued Hunter Biden didn't violate the law and remains protected by an immunity provision that was part of the plea deal.

The charges, meanwhile, are rarely filed as stand-alone counts and a recent appeals court decision

called the law itself into question. President Biden's son has also been under investigation for his

business dealings, and the spe-cial counsel has indicated that tax charges could be filed at some point in the future in Washington or in California, where he lives.

Political pressure has also es-calated as the House has formally opened an impeachment inquiry into the Democratic president, seeking to tie the elder Biden to his son's businesses and divert attention away from former president Donald Trump's own legal woes.

the years-long probe, federal prosecutors have not indicated Joe Biden is connected. And so far, Republicans have unearthed no significant evidence of wrongdoing by the elder Biden, who as vice president spoke often to his son and stopped by a business dinner with his son's associates. The White House maintains Joe Biden was not involved in his son's business affairs.

The prosecutor who has long overseen the Hunter Biden probe, Trump-appointed Delaware attorney David Weiss, was elevated to special counsel last month, giving him broad authority to investigate and report out his findings.

Key Serbia and Kosovo talks break down

Kosovo and Serbia have failed yet again to make progress in talks aimed at improving their long-strained relations, and the European Union's top diplomat warned the lack of progress could hurt their hopes of joining the bloc.

EU foreign policy chief Josep Borrell, who supervised the talks in Brussels, blamed the latest breakdown on Kosovo prime

minister Albin Kurti's insistence that Serbia should essentially recognise his country before progress can be made on enforcing an agreement they reached in February.

Serbia and its former province of Kosovo have been at odds for

Their 1998-99 war left more than 10,000 people dead, mostly Kosovo Albanians

Kosovo unilaterally declared

independence in 2008 but Belgrade has refused to recognise the move.

"Unfortunately, after quite a long meeting, prime minister Kurti was not ready to move forward on... a credible process," Mr Borrell said.

Serbian president Aleksandar Vucic also blamed Mr Kurti. "Kurti did not want to accept it
