#### Welcome and Introduction

## 3. SICAP

### SICAP Mid-Year Reviews

Andrew Lewis thanked the SICAP Sub Group of Cllr. Gearóid Murphy and Cllr. Gerard Murphy for their assistance with the reviews of the three lots: 18.1 IRD Duhallow CLG, 18.2 Ballyhoura Development CLG and 18.3 Avondhu Blackwater Partnership CLG. He noted that the Sub Group met the three LCDCs individually to access their progress.

Andrew Lewis said that both KPI1 and KPI2 had been achieved by all three lots. He noted that any underspends cannot be carried over into 2024 as the SICAP Programme will end on 31st December 2023.

Cllr. Gearóid Murphy endorsed the reviews saying that they reflected the good work being undertaken by the Local Development Companies on the ground.

Maura Walsh commented that VAT usually goes into Q1 of the following year and queried if it can be accessed in 2023 instead as the SICAP Programme will end on 31<sup>st</sup> December 2023. Andrew Lewis answered that the VAT for the End of Year 2023will be not be available until



February 2024, once the End of Year 2023 review has been assessed and approved by the LCDC.

The SICAP Mid-Year Reviews of lots 18.1, 18.2 and 18.3 were proposed by Michael Doyle and seconded by Sean Hegarty.

SICAP Sub Contracts Pre-approval granted by LCDC Chief Officer
